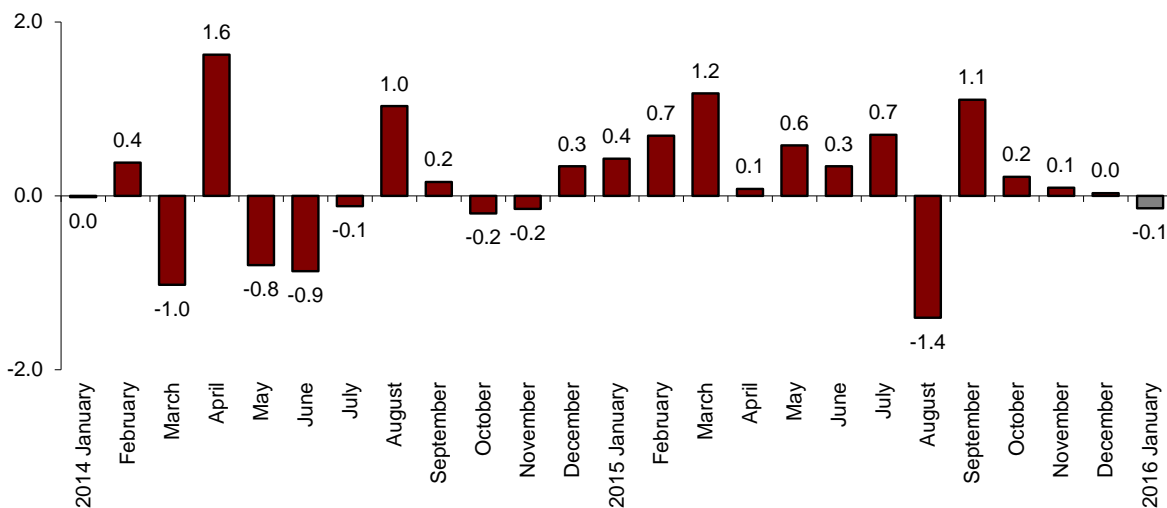
La variación mensual del Índice de Producción Industrial es del -0,1% si se eliminan los efectos estacionales y de calendario

La tasa anual del Índice de Producción Industrial se sitúa en el 3,5% en la serie corregida de efectos estacionales y de calendario, y en el 0,7% en la serie original

Evolución mensual de la producción industrial

La variación mensual del Índice de Producción Industrial (IPI) entre los meses de enero de 2016 y diciembre de 2015, eliminando los efectos estacionales y de calendario, es del -0,1%. Esta tasa es 0,1 puntos inferior a la observada en diciembre de 2015.

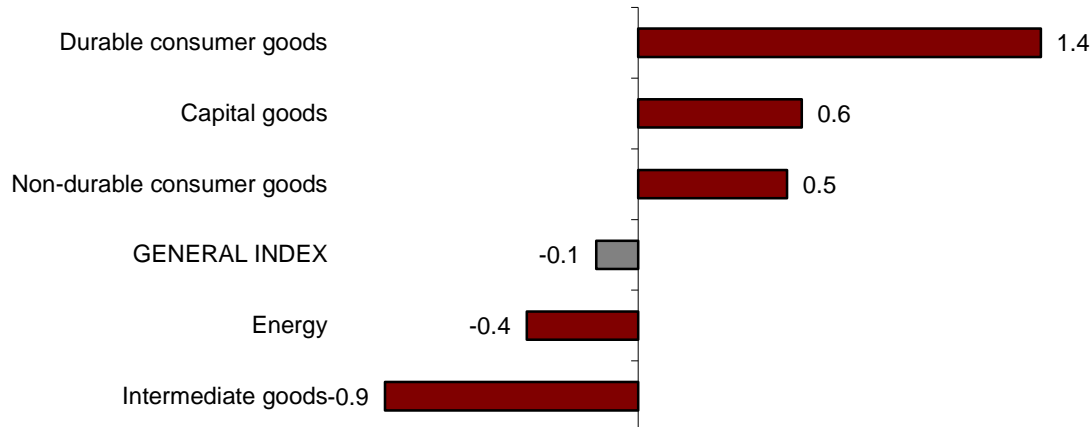
General Industrial Production Index

Los sectores industriales de Bienes de consumo duradero (1,4%), Bienes de equipo (0,6%) y Bienes de consumo no duradero (0,5%) presentan tasas mensuales positivas.

Por su parte, Bienes intermedios (-0,9%) y Energía (-0,4%) registran tasas mensuales negativas.

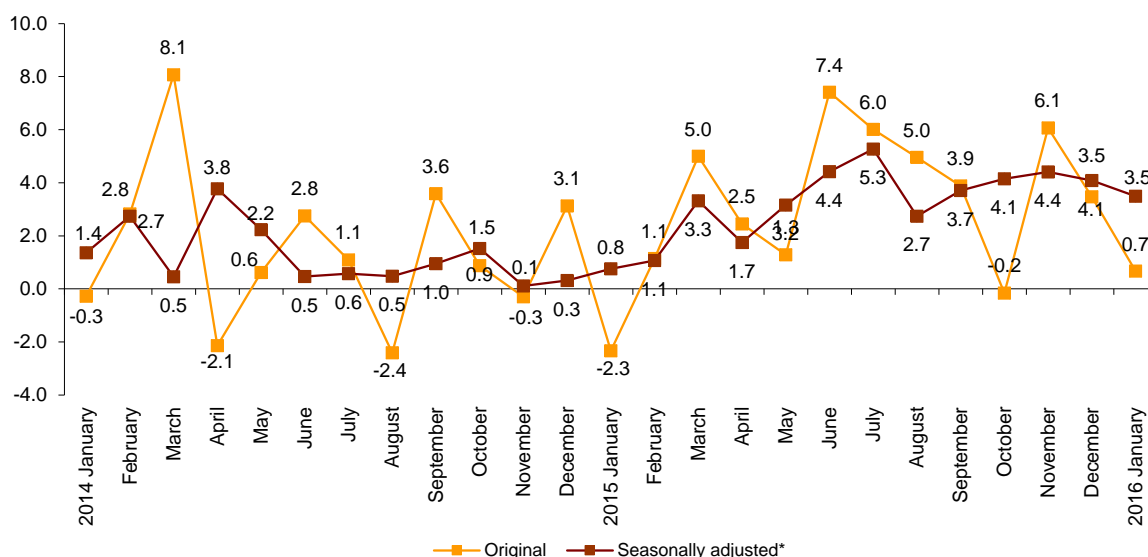

Evolución anual de la producción industrial

El Índice de Producción Industrial corregido de efectos estacionales y de calendario presenta en enero una variación del 3,5% respecto al mismo mes del año anterior. Esta tasa es 0,6 puntos inferior a la registrada en diciembre de 2015.

La serie original del IPI experimenta una variación anual del 0,7%. Esta tasa es 2,8 puntos menor que la de diciembre.

Los índices corregidos de efectos estacionales y de calendario presentan tasas anuales positivas en todos los sectores, excepto en Energía (-7,5%).

Bienes de equipo (9,3%), Bienes intermedios (5,2%) y Bienes de consumo no duradero (4,3%) registran los mayores incrementos.

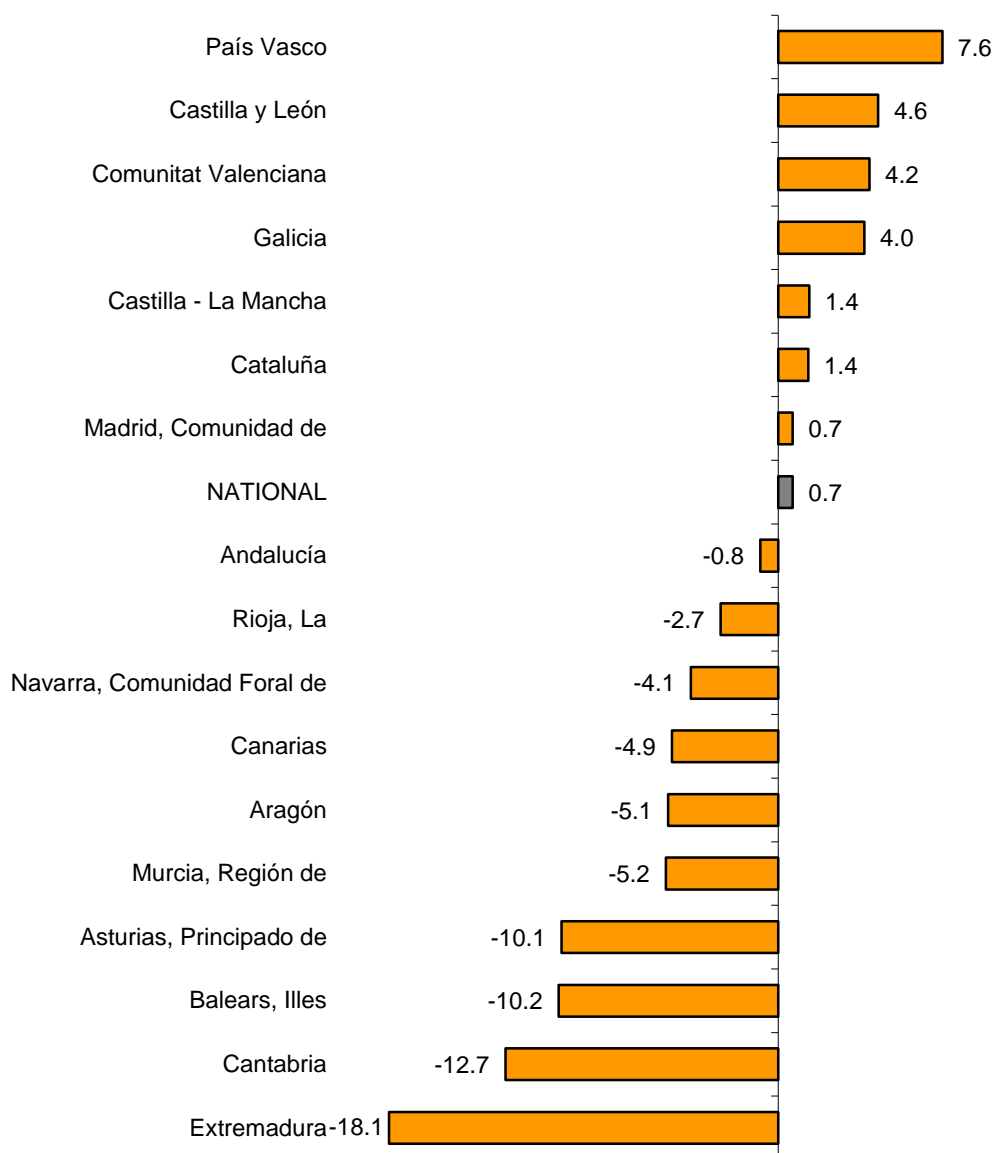

Resultados por comunidades autónomas. Tasas de variación anual de la producción industrial. Serie original

La tasa anual de la producción industrial aumenta en siete comunidades autónomas. Los mayores incrementos se dan en País Vasco (7,6%), Castilla y León (4,6%) y Comunitat Valenciana (4,2%).

Por su parte, las comunidades que presentan los mayores descensos en su tasa anual son Extremadura (-18,1%), Cantabria (-12,7%) e Illes Balears (-10,2%).
