#### Industrial Production Index (IPI). Base 2005 May 2010. Provisional data

#### **Main results**

– The **interannual variation** of the **Industrial Production Index** for the month of **May** is **0.8%**, almost five points above that registered in April.

- By economic destination of the goods, **Non-durable consumer goods and Capital** goods present positive interannual rates.

- The average rate of the IPI stands at 1.2% in the first five months of the year.

- Eleven Autonomous Communities register positive interannual rates for the IPI in the month of May.

#### Annual evolution of industrial production

The Industrial Production Index (IPI) experienced an interannual variation of **0.8%** in May, almost five points above that registered in April.

The industrial sectors that most influenced this interannual decrease in industrial production in the month of May were:

• Non-durable consumer goods, with an annual variation of **3.9%** and an effect of **1.068** on the general index, due to the increases in the majority of activities comprising this sector. Worth noting were the increases registered in the *Processing and preserving of meat and production of meat products* and the *Processing and preserving of fruit and vegetables*.

• **Capital goods**, with an annual variation of **5.1%** and an effect of **1.007** on the general index. Industrial production registered increases in more than half of the activities comprising this sector. Worth noting among them were those observed in the *Manufacture of components, pieces and accessories for motor vehicles* and in the *Manufacture of other machinery for specific uses*. Nonetheless, of note was the decrease in *Naval construction*. In turn, among the industrial sectors with a negative effect on the general index, worth noting were:

• Intermediate goods, with an annual variation of -2.3% and an effect of -0.832 on the general index. Although more than half of the activities in this sector registered increases in production, the negative evolution of other activities had the greatest influence. Worth noting among these was the *Manufacture of other chemical products*, the *Manufacture of electronic components and assembled printed circuits*, the *Manufacture of cement, lime and plaster*.

A more detailed analysis showed the activities that most affected the annual rate of the IPI in the month of May.



#### Year-to-date average rates

The average for the Industrial Production Index registered a variation of **1.2%** in the first five months of the year, as compared with the same period the previous year.


By economic destination of the goods, this rate was positive in Capital goods (3.4%), Intermediate goods (2.4%) and Non-durable consumer goods (0.4%). Conversely, it was negative in Energy (-0.4%), and Durable consumer goods (-9.2%).

#### Evolution of the IPI, adjusted for the calendar effect

After correcting the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the IPI in the month of May was - **0.4%**, more than one point above that registered in April.


#### **Results by Autonomous Community**

Press

Eleven Autonomous Communities registered negative interannual variations in May. Those that presented the greatest interannual increases in industrial production were Castilla y León (5.6%), Principado de Asturias (4.5%) and Extremadura (4.2%).

In turn, industrial production in Andalucía (-4.0%), Comunitat Valenciana (-3.3%) and Galicia (-2.8%) registered the greatest decreases interannual rates.
