

The monthly variation of the Industrial Production Index stands at 0.5%, after adjusting the seasonal and calendar effects

The annual rate of the Industrial Production Index stands at 1.0% in the series adjusted for the seasonal and calendar effects and at 3.6% in the original series

Monthly evolution of the Industrial Production


After adjusting the seasonal and calendar effects, the monthly variation of the Industrial Production Index (IPI) between September and August stood at 0.5%. This rate was 0.5 points higher than that registered in August.



Capital goods (5.7%) and Non-durable consumer goods (0.3%) registered the greatest increases in their monthly variation rates.

In turn, Durable consumer goods (-2.5%) and Intermediate goods (-1.4%) registered the greatest negative variation rates.



Annual evolution of the Industrial Production

After adjusting the seasonal and calendar effects, the Industrial Production Index (IPI) registered a variation of 1.0% in September, as compared with the same month of the previous year. This rate was 0.7 points higher than that registered in August.

The original series of the Industrial Production Index recorded an annual variation of 3.6%. This rate was 5.9 points higher than that of August.

General Industrial Production Index Annual rate



After adjusting the seasonal and calendar effects, all industrial sectors registered positive annual rates, except for Durable consumer goods (–6.7%) and Energy (–1.1%).

Non-durable consumer goods (2.9%) and Intermediate goods (2.0%) recorded the greatest positive rates.



Results by Autonomous Community. Annual variation rates of the Industrial Production. Original series

The annual rates of the original series of the Industrial Production increased in 14 Autonomous Communities and decreased in 3 of them. The greatest increases were registered in La Rioja (12.0%), Illes Balears (7.2%), and Comunidad Foral de Navarra (6.9%).

In turn, the greatest decreases were registered in Galicia (-2.3%), Extremadura (-1.9%) and Cantabria (-0.8%).
