Industrial Price Indices. Base 2000 January 2008

The General Industrial Price Index increases 1.3% in January as compared to the previous month

In January, the General Industrial Price Index registered a 1.3% increase with respect to the month of December 2007. The activities that most influenced this variation were *Electricity* and gas (3.9%), Food and beverage products industry (1.5%) and Manufacture of chemicals and chemical products (1.4%). In contrast, among the activities that recorded a decrease with respect to the previous month, the activity with the greatest repercussion was Manufacture of coke and refined petroleum products (-0.6%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were 1.0% for consumer goods (0.6% for durable consumer goods and 1.0% for non-durable consumer goods), 0.8% for capital goods, 1.5% for intermediate goods and 1.8% for energy.

The interannual rate of the General Index increases 6.6%

The General Industrial Price Index registered an increase of 6.6% in January 2008 with respect to the previous year. The activities that most influenced this variation were Manufacture of coke and refined petroleum products (25.5%) and Food and beverage products industry (10.9%).

By economic destination of the goods, the variation rates as compared with the same month the previous year were 5.4% for consumer goods (2.8% for durable consumer goods and 5.9% for non-durable consumer goods), 2.7% for capital goods, 5.7% for intermediate goods and 13.3% for energy.
