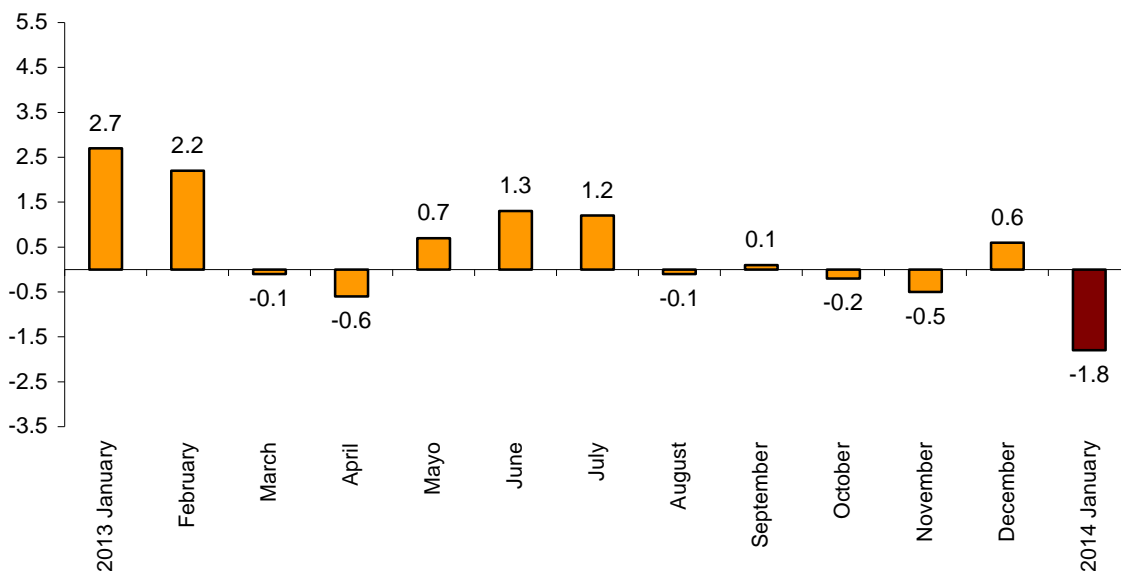
The annual rate of the Industrial Price Index stands at -1.8% , more than two points below that registered in December

The monthly variation rate of the Industrial Price Index is -1.3%

Annual evolution of industrial prices

The annual rate of the General Industrial Price Index (IPRI) stood at -1.8% in January, more than two points below that registered in December and the lowest since November 2009.

General index

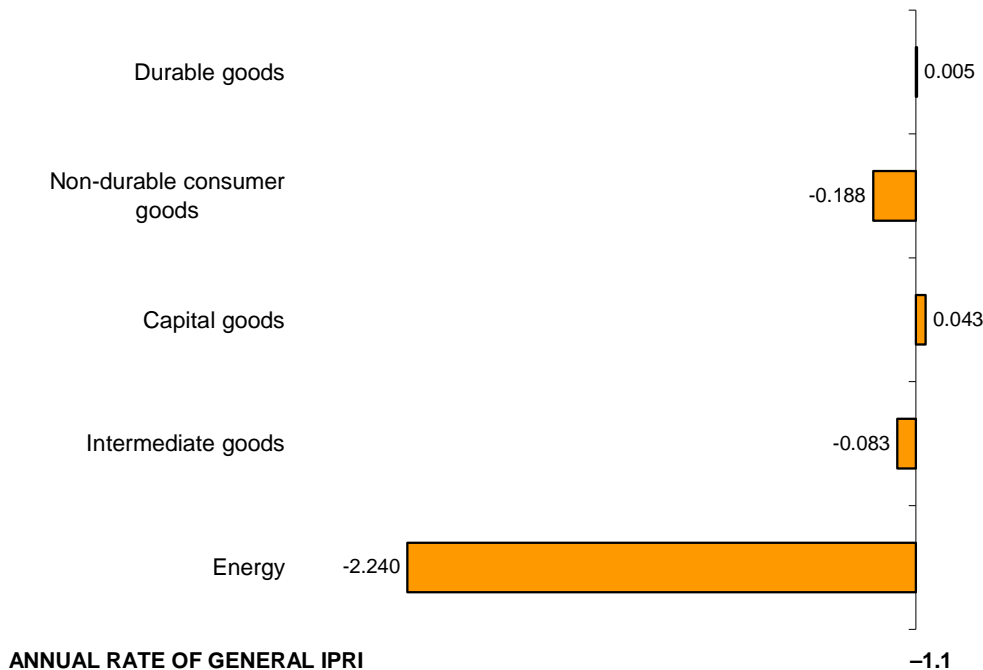


By economic destination of the goods, the industrial sectors that influenced the most the increase in the general rate of the IPRI were:

- **Energy**, whose rate stood at -3.3% , nearly eight points and a half below that of the previous month. This behaviour was due to the decrease in the prices of the *Production, transportation and distribution of electrical energy*. At a lesser extent this behaviour is also a consequence of the decrease in the prices of *Refined petroleum products*, as compared with the increase registered in 2013.

• **Non-durable consumer goods**, whose variation stood at **-0.7%**, seven tenths below that of December and the lowest rate since February 2010. This behaviour was due to the decrease in prices of the *Manufacture of vegetable and animal oils and fats*, that registered the lowest annual rate since July 2009.

In January, the monthly variation of the general IPRI was **-1.3%**.

By economic destination of the goods, the industrial sectors that recorded the greatest monthly negative effect on the general index were:

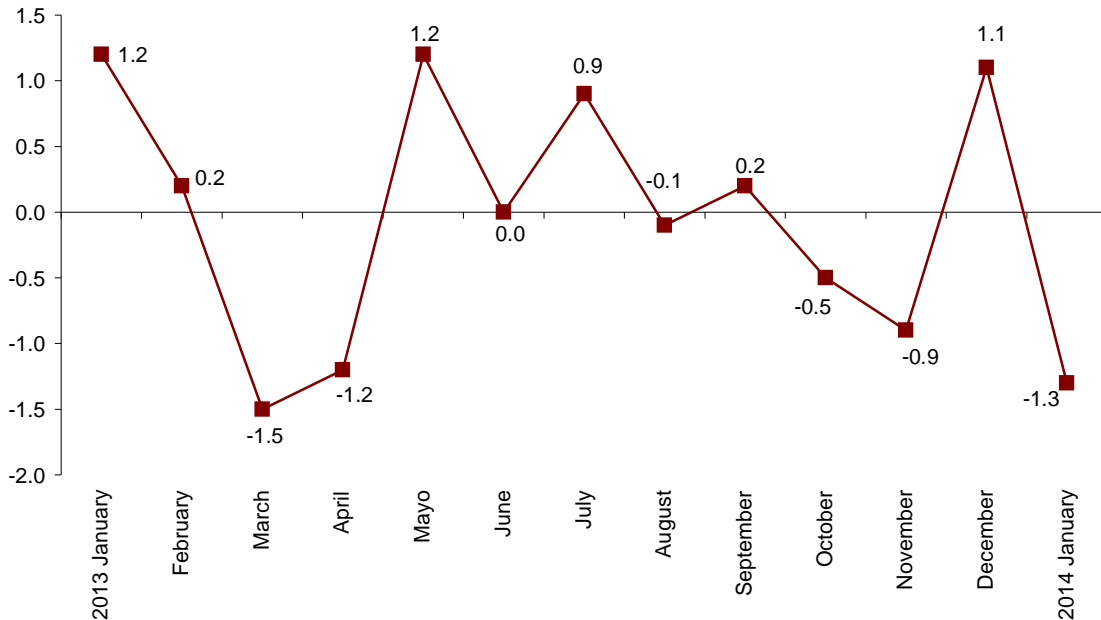
- **Energy**, with a monthly variation of **-4.7%** and an effect of **-1.272**. This behaviour was due to the decrease in the prices of the *Production, transportation and distribution of the electric power*.

- **Non-durable consumer goods**, with a variation of **-0.2%** and an effect of **-0.041**, mainly due to the decrease in the prices of the *Manufacture of vegetable and animal oils and fats*.

In turn, among the industrial sectors with a positive monthly effect on the IPRI, worth noting:

- **Capital goods**, with a variation of **0.2%** and an effect of **0.035**. This behaviour is due to the increase in the prices of the *Manufacture of other special-purpose machinery*.

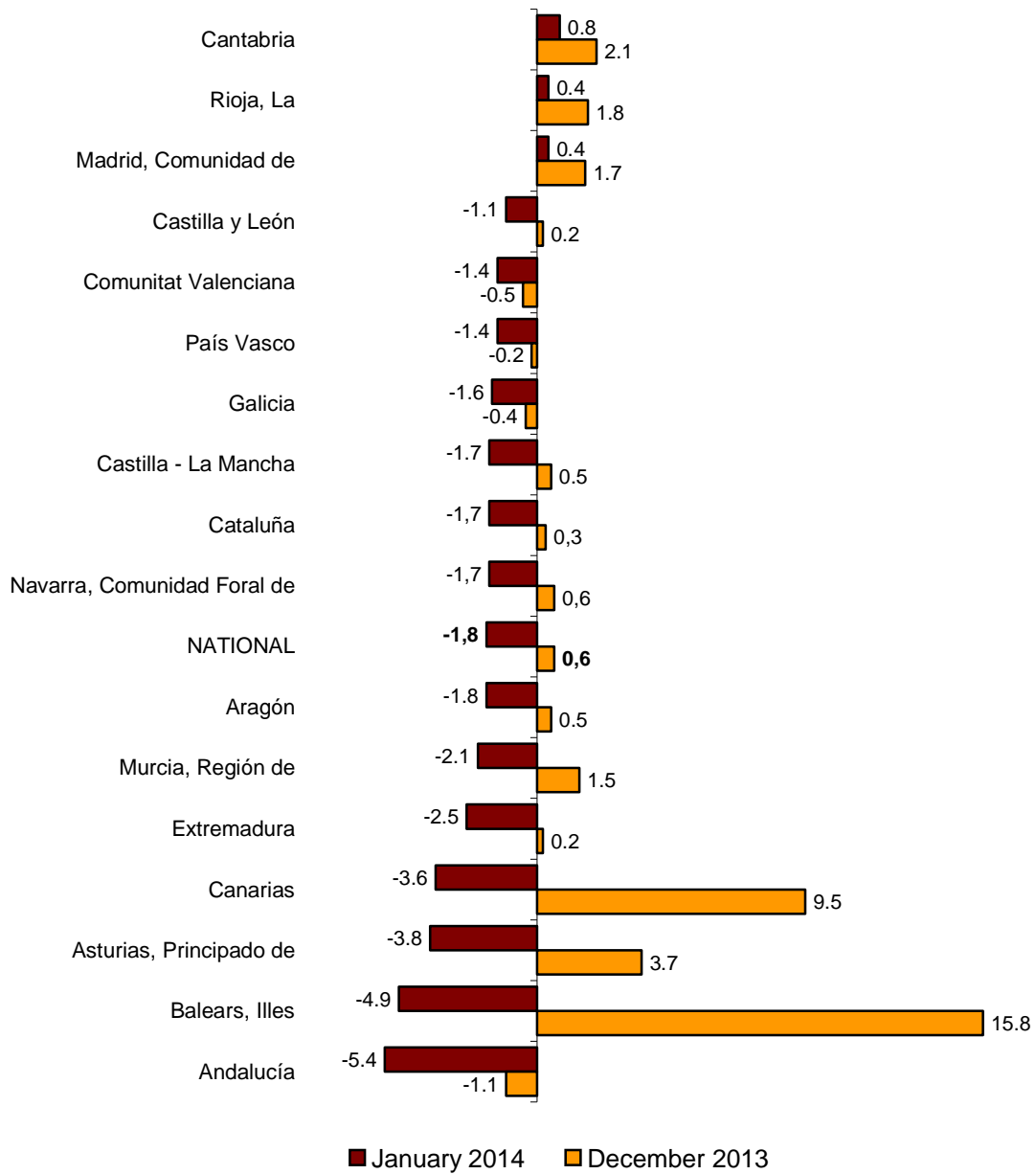

Results by Autonomous Community. Annual variation rates

The annual rate of the IPRI decreased in most Autonomous Communities, highlighting Illes Balears (up to -4.9%), Canarias (up to -3.6%) and Principado de Asturias (up to -3.8%), with decreases of 20.7, 13.1 and 7.5 points, respectively.
