Industrial Price Indices. Base 2000 February 2008

The General Industrial Price Index increases 0.5% in February as compared to the previous month

In February, the General Industrial Price Index registered a 0.5% increase with respect to the month of January 2008. The activities that most influenced this variation were *Food and beverage products industry* (0.9%), *Metallurgy* (3.5%) and *Manufacture of chemicals and chemical products* (1.1%). In contrast, among the activities that recorded a decrease with respect to the previous month, the activity with the greatest repercussion was *Manufacture of coke and refined petroleum products* (-1.0%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were 0.6% for consumer goods (0.8% for durable consumer goods and 0.5% for non-durable consumer goods), 0.3% for capital goods, 1.2% for intermediate goods and -0.3% for energy.

The interannual rate of the General Index increases 6.6%

The General Industrial Price Index registered an increase of 6.6% in February 2008 with respect to the previous year. The activities that most influenced this variation were Food and beverage products industry (11.0%) and Manufacture of coke and refined petroleum products (25.3%).

By economic destination of the goods, the variation rates as compared with the same month the previous year were 5.4% for consumer goods (3.2% for durable consumer goods and 5.8% for non-durable consumer goods), 2.5% for capital goods, 6.0% for intermediate goods and 13.3% for energy.
