Industrial Price Index (IPRI). Base 2010 May 2015. Provisional data

The annual rate of the Industrial Price Index stands at -1.4%, five tenths below that registered in April

The monthly variation rate of industrial prices is 0.3%

Annual evolution of industrial prices

The annual rate of the General Industrial Price Index (IPRI) stood at **–1.4%** in May, five tenths lower than that registered in April.

By economic destination of the goods, the industrial sector that influenced this decrease was:

• *Energy*, whose annual rate was –7.5%, more than two points lower than that registered in April. This behaviour was due to stability in the prices of *Electric power generation, transmission and distribution* this month, as compared to the increase registered the previous year.


It was also influenced, though to a lesser extent, by the decrease in the prices of *Manufacture* of gas; distribution of gaseous fuels through mains, which registered an increase the previous year. In fact, this industrial sector registered its lowest rate since June 2010.

Although the annual rate of *Energy* decreased, it is worth noting the increase in the rate of *Manufacture of refined petroleum products*, due to the increase in prices of this industrial sector this month, as compared with the stability of the previous year.

Although the annual rate of the general IPRI decreased, it is worth noting the increase of:


- *Capital goods*, whose annual variation increased two tenths, standing at **0.8%**. This was mainly due to the increase in the prices of *Manufacture of locomotives and rolling stock*, higher than that registered in 2014.
- Intermediate goods, whose variation increased one tenth, standing at 0.1% due to the increase in the prices of Manufacture of basic chemicals fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms and of Manufacture of plastic products.

Contribution of the industrial sectors in the annual rate of the IPRI



The annual variation rate of the **general index excluding** *Energy* increased one tenth, reaching **0.7%**, thus standing more than two points over that of the general IPRI.

Monthly evolution of industrial prices


In May, the monthly variation of the general IPRI was **0.3%**.

By economic destination of the goods, the industrial sectors with the greatest monthly positive contribution to general index are:

- *Energy*, with a variation of **0.7%** and a contribution to the general index of **0.196**. This was due to the increase in the prices of *Manufacture of refined petroleum products*, partly compensated by the decrease of prices in *Manufacture of gas; distribution of gaseous fuels through mains* and *Electric power generation, transmission and distribution*.
- Capital goods, whose rate stood at 0.3%. This was mainly due to the increase in the prices of Manufacture of railway locomotives and rolling stock. It had a contribution of 0.046 to the general IPRI.
- *Intermediate goods*, with a rate of **0.1%** and an effect of **0.041**. This was mainly due to the increase in prices of *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms*.

The only sector with a negative contribution to the general index was:

• **Durable consumer goods**, whose rate of **0.0%** had a contribution of **-0.001**. This was due to the decrease in prices of *Manufacture of jewellery, bijouterie and related articles*.



A more detailed analysis showed the activities that most affected the monthly rate of the IPRI in the month of May.



Results by Autonomous Community. Annual variation rates

The annual rate of the IPRI decreased in 13 Autonomous Communities. Illes Balears (2.3%), Comunidad de Madrid (0.1%), Principado de Asturias (2.0%) and Islas Canarias (-4.4%) registered the highest decreases, 8.2, 2.5, 2.4 and 2.4 points, respectively.

In turn, among the Autonomous Communities to increase their annual rate worth noting were Castilla-La Mancha (-3.8%) and País Vasco (-1.3%), which registered increases of six and five tenths, respectively.
