### Mercantile Companies Statistics (MC) March 2017. Provisional data

# In March 10,548 mercantile companies were created, 7.3% more than in the same month of 2016 and 1,986 were dissolved, 11.8% more

# Illes Balears, Región de Murcia (both 25.1%) and País Vasco (15.9%) are the Autonomous Communities with the greatest business dynamism<sup>1</sup>

In March, 10,548 mercantile companies were created, 7.3% more than in the same month of 2016. The capital subscribed for their constitution exceeded 391 million euros, representing a decrease of 66.7%. The average capital subscribed (37,101 euros) decreased by 69.0% in annual rate.

On the other hand, in March, a total of 3,081 mercantile companies increased their capital, 10.5% more than in the same month of 2016. The capital subscribed in the increases grew 86.4% and exceeded 3,488 million euros. The average capital subscribed in these transactions (1,132,118 euros) increased 68.6% in annual rate.

The number of mercantile companies dissolved in March was 1,986, indicating 11.8% more than in the same month of 2016. Of these, 77.9% did so voluntarily, 7.7% due to mergers and the remaining 14.4% for other reasons.



### Evolution of the monthly rate


In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between February and March in the last five years. In 2017, the monthly variation of the number of companies created was 19.2% and that of the companies dissolved was -11.6%.



#### Results by main economic activity

22.6% of the mercantile companies created in March corresponded to Trade and 15.1% to Construction. As regards the mercantile companies dissolved, 20.5% corresponded to Trade and 18.7% to Construction.


% mercantile companies created by main economic


The activity with the greatest net balance of mercantile companies created in the month of March 2017 was *Trade*, with 1,975.

Conversely, *Transport and storage* registered the lowest net balance, with 259 companies created.



The economic activity with the greatest capital subscribed of mercantile companies created was *Real estate, financial and insurance activities*, with 193.25 million euros.

In turn, *Information and communications* presented the lowest capital subscribed, with 3.82 million euros.



#### **Results by Autonomous Communities**

The Autonomous Communities with the greatest number of mercantile companies created in March were Comunidad de Madrid (2,120), Cataluña (2,117) and Andalucía (1,784).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (47), Cantabria (66) and Comunidad Foral de Navarra (88).

Regarding the dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (568), Andalucía (354) and Comunitat Valenciana (169).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (9), La Rioja (10) and Región de Murcia (29).




In terms of annual variation of the number of mercantile companies created, Illes Balears and Región de Murcia (both with 25.1%) and País Vasco (15.9%) recorded the greatest increases.

In turn, Cantabria (-32.0%), Extremadura (-17.3%) and Aragón (-10.5%) registered the highest decreases.

Regarding the mercantile companies dissolved, Región de Murcia (163.6%), Principado de Asturias (45.7%) and País Vasco (33.0%) were the Autonomous Communities that registered the highest positive rates.

In turn, those with the highest decreases were Comunidad Foral de Navarra (-35.7%), Cataluña (-23.5%) and La Rioja (-16.7%).
