Mercantile Companies Statistics (MC) June 2017. Provisional data

In June 8,334 mercantile companies were created, 10.3% less than in the same month of 2016 and 1,428 were dissolved, 2.7% less

The Autonomous Communities with the greatest business dynamism Región de Murcia ((9.1%) and Illes Balears (7.4%)¹

In June, 8,334 mercantile companies were created, 10.3% less than in the same month of 2016. The subscribed capital for their constitution exceeded 525 million euros, representing an increase of 28.5%. The average subscribed capital (63,011 euros) decreased by 43.4% in the annual rate.

On the other hand, 2,493 mercantile companies increased their capital in June, 1.3% less than in the same month of 2016. The increases in the subscribed capital grew by 44.2% and exceeded 7,679 million euros. The average subscribed capital in these transactions (3,080,345 euros) increased by 46.1% in the annual rate.

The number of mercantile companies dissolved in June was 1,428, indicating 2.7% less than in the same month of 2016. Of these, 75.8% did so voluntarily, 5.7% due to mergers and the remaining 18.5% for other reasons.




Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between May and June in the last five years. In 2017, the monthly variation of the number of companies created was -5.1% and that of the companies dissolved was -5.3%.



Results by main economic activity

Of the mercantile companies created in June, 20.7% corresponded to *Trade* and 15.8% to *Real estate, financial and insurance companies.* Regarding the dissolved companies, 21.1% corresponded to *Trade* and 20.5% to *Construction*.




MC - JUNE 2017 (2/7)




The activity with the greatest net balance of mercantile companies created in the month of June 2017 was *Trade*, with 1,429.

Conversely, *Agriculture* and fishing registered the lowest net balance, with 188 companies created.



The economic activity with the greatest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 387.96 million euros.

In turn, *Information and communications* presented the lowest subscribed capital, with 3.08 million.



Results by Autonomous Communities

Press Release

The Autonomous Communities with the greatest number of mercantile companies created in June were Comunidad de Madrid (1,876), Cataluña (1,686), and Andalucía (1,312).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (24), Comunidad Foral de Navarra (67) and Cantabria (68).

Regarding the dissolved mercantile companies, the ones that registered the highest number were Comunidad de Madrid (441), Andalucía (233) and Cataluña (118).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (5), Cantabria (12) and La Rioja (13).

In terms of annual variation of the number of mercantile companies created, Región de Murcia (9,1%) and Illes Balears (7,4%) are the only Autonomous Communities with a positive growth rate.



In turn, La Rioja (-51.0%), Cantabria (-34.6%) and Castilla y León (-27.0%) registered the highest decreases.

Regarding the mercantile companies dissolved, La Rioja (116.7%), Galicia (46.9%) and Illes Balears (43.2%) were the Autonomous Communities that registered the highest positive rates.

In turn, the ones with the greatest decreases in their annual rates were Castilla–La Mancha (-33.3%), Cataluña (-22.9%) and Región de Murcia (-22.2%).
