Mercantile Companies Statistics (MC) July 2018. Provisional data

In July, 7,692 mercantile companies are created, 3.5% more than in the same month of 2017 and 1,480 are dissolved, 8.0% more

Aragón (35.6%), Castilla-La Mancha (21.5%) and Andalucía (19.3%) are the Autonomous Communities with the greatest business dynamism¹

In July, 7,692 mercantile companies were created, 3.5% more than in the same month of 2017. The subscribed capital for their constitution exceeded 599 million euros, with an annual increase of 40.9%. The average subscribed capital (77,888 euros) increased by 36.2%.

On the other hand, in July, 2,736 mercantile companies increased their capital, 22.7% more than in the same month of 2017. The capital subscribed in the increases recorded a 37.9% decrease and exceeded 2,335 million euros. The average capital subscribed in these transactions (853,547 euros) decreased by 49.4% in the annual rate.

The number of mercantile companies dissolved in July was 1,480, 8.0% more than in the same month of 2017. Of these, 67.8% did so voluntarily, 18.1% due to mergers and the remaining 14.1% for other reasons.






In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between June and July in the last five years. In 2018, the monthly variation in the number of companies created was -5.3% and in the number of companies dissolved 8.0%.





Results by main economic activity

In July, 19.6% of the mercantile companies created corresponded to *Trade* and 16.0% to *Construction*. As for dissolved companies, 21.7% corresponded to *Industry and Energy* and 21.5% to *Trade*.









The activity with the greatest net balance of mercantile companies created in the month of July 2018 was *Trade*, with 1,191.


Conversely, *Agriculture and fishing* registered the lowest net balance, with 181 companies created.

The economic activity with the greatest subscribed capital of mercantile companies created was *Real estate, financial and insurance activities*, with 439.65 million euros.

In turn, Administrative and support service activities registered the lowest capital, with 2.92 million.



Results for Autonomous Communities

Press Release

The Autonomous Communities with the greatest number of mercantile companies created in July were Comunidad de Madrid (1,789), Cataluña (1,580), and Andalucía (1,251).

In turn, those in which the fewest mercantile companies have been created were La Rioja (31), Comunidad Foral de Navarra (40) and Cantabria (50).

Regarding dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (588), Andalucía (175) and Comunitat Valenciana (137).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (3), Cantabria (6) and La Rioja (7).

In terms of annual variation of the number of mercantile companies created, Aragón (35.6%), Castilla–La Mancha (21.5%) and Andalucía (19.3%) recorded the greatest increases.

In turn, Principado de Asturias (-41.8%), Comunidad Foral de Navarra (-29.8%) and Extremadura (-23.7%) registered the greatest decreases.

Regarding the mercantile companies dissolved, the highest rates were recorded in Castilla– La Mancha (36.0%), Comunitat Valenciana (35.6%) and Illes Balears (23.9%).

In turn, those with the largest decreases were Cantabria (-70.0%), Región de Murcia (-42.3%) and La Rioja (-30.0%).
