Mercantile Companies Statistics (MC)

August 2016. Provisional data

6,403 mercantile companies were created in August, 23.4% more than in the same month of 2015, and 1,236 were dissolved, 3.8% more than in August 2015

The Autonomous Communities with the greatest business dynamism¹ are La Rioja (131.3%), Cantabria (52.4%) and Cataluña (47.3%)

6,403 mercantile companies were created in August, that is, 23.4% more than in the same month of 2015. The capital subscribed for their constitution exceeded 779 million euros, representing an increase of 159.7%. The average capital subscribed (121,814 euros) increased 110.4% in its annual rate.

On the other hand, 2,242 mercantile companies increased their capital in August, 6.0% more than in the same month of 2015. The capital subscribed in the increases registered an increase of 16.0% and exceeded 2,058 million euros. The average capital subscribed in these transactions (917,936 euros) increased 9.5% in its annual rate.

The number of companies dissolved in August was 1,236, that is, 3.8% more than in the same month of 2015. Among these, 69.9% did so voluntarily, 16.0% due to mergers and the remaining 14.1% for other reasons.



Performance of the monthly rate


In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies created and dissolved between July and August in the last five years. In 2016, the monthly variation of the number of companies created was –22.0% and that of the companies dissolved was –7.8%.


Performance of the monthly rate of mercantile companies created and dissolved (August 2016 variation is compared with July 2016)



Results by main economic activity

22.0% of the mercantile companies created in the month of August corresponded to *Trade* and 15.1% to *Construction*. Regarding the dissolved companies, 19.2% corresponded to *Trade* and 16.9% to *Construction*.






The activity with the greatest net balance of mercantile companies created in August 2016 was *Trade*, with 1,166 new companies.

On the contrary, *Agriculture and fishing* registered the lowest net balance, with 173 companies created.






The economic activity with the greatest capital subscribed of the mercantile companies created was *Real estate, financial and insurance activities*, with 653.22 million euros.

In turn, *Administrative and support service activities* presented the lowest capital subscribed, with 2.16 million euros.

Results by Autonomous Communities

The Autonomous Communities with the greatest number of mercantile companies created in August were Cataluña (1,698), Comunidad de Madrid (1,040), and Andalucía (958).

Conversely, the Autonomous Communities where less mercantile companies were created were Comunidad Foral de Navarra (57), Cantabria (64) and Extremadura (67).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (406), Andalucía (168) and Cataluña (141).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (9), La Rioja (11) and Extremadura (12).



In terms of annual variation of the number of mercantile companies created, La Rioja (131.3%), Cantabria (52.4%) and Cataluña (47.3%) recorded the highest rates.

In turn, Extremadura (-16.3%), Castilla–La Mancha (-9.6%) and Canarias (3.2%) registered the greatest decreases.

Regarding the mercantile companies dissolved, Comunidad Foral de Navarra (200.0%), Región de Murcia (180.0%) and Cantabria (110.0%) were the Autonomous Communities that registered the highest positive rates.

In turn, the Autonomous Communities registering the lowest annual rates were Aragón (-49.3%), Principado de Asturias (-36.0%) and La Rioja (-26.7%).
