Mercantile Companies Statistics (MC) August 2018. Provisional data

## In August 5,871 mercantile companies are created, 0.7% less than in the same month of 2017 and 1,352 were dissolved, 10.1% more

## Cantabria (38.5%), Extremadura (23.7%) and Comunidad Foral de Navarra (19.3%) are the Autonomous Communities with the greatest business dynamism<sup>1</sup>

In August, 5,871 mercantile companies were created, 0.7% less than in the same month of 2017. The subscribed capital for their constitution exceeded 248 million euros, with an annual decrease of 4.6%. The average subscribed capital (42,396 euros) decreased by 4.0%.

On the other hand, 2,205 mercantile companies increased their capital in August, 4.6% less than in the same month of 2017. The capital subscribed in the increases recorded a 76.8% decrease and exceeded 1,260 million euros. The average capital subscribed in these transactions (571,821 euros) decreased by 75.7% in the annual rate.

The number of mercantile companies dissolved in August was 1,352, 10.1% more than in the same month of 2017. Of these, 69.2% did so voluntarily, 19.3% due to mergers and the remaining 11.5% for other reasons.


#### Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between July and August in the last five years. In 2018, the monthly variation in the number of companies created was -23.7% and in the number of companies dissolved -8.6%.


#### **Performance of the monthly rate of mercantile companies created and dissolved** August variation is compared with July of the same year



#### Results by main economic activity


Of the mercantile companies created in August, 19.2% corresponded to *Trade* and 15.9% to *Real estate, financial and insurance companies.* Regarding the dissolved companies, 18.8% corresponded to *Trade* and 17.3% to *Industry and Energy*.






The activity with the greatest net balance of mercantile companies created in the month of August 2018 was *Trade*, with 873.

Conversely, *Agriculture and fishing* registered the lowest net balance, with 150 companies created.


Net balance of mercantile companies created by main economic activity August 2018.




The economic activity with the greatest subscribed capital of mercantile companies created was *Real estate, financial and insurance activities*, with 160.68 million euros.

In turn, *Information and communications* presented the lowest capital subscribed, with 2.37 million euros.

### **Results by Autonomous Communities**

The Autonomous Communities with the greatest number of mercantile companies created in August were Comunidad de Madrid (1,336), Cataluña (1,082), and Andalucía (932).

In turn, those with the lowest number of mercantile companies created were La Rioja (35), Cantabria (54) and Comunidad Foral de Navarra (68).

Regarding dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (445), Andalucía (164) and Castilla–La Mancha (125).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (7), La Rioja (12) and Extremadura (16).



In terms of annual variation of the number of mercantile companies created, Cantabria (38.5%), Extremadura (23.7%) and Comunidad Foral de Navarra (19.3%) recorded the greatest increases.

In turn, Galicia (-20.7%), Cataluña (-16.6%) and Aragón (-16.5%) showed the greatest decreases.


#### Annual variation in mercantile companies created by Autonomous Community August 2018



Regarding the mercantile companies dissolved, the highest rates were recorded in Comunidad Foral de Navarra (600.0%), Castilla–La Mancha (557.9%) and Región de Murcia (211.1%).

In turn, those with the highest decreases were Castilla y León (-38.2%), Extremadura (-30.4%) and Canarias (-29.5%).

### Revision and updating of data

Data for 2018 are provisional and will be reviewed when data for the same period of the next year are published. That is, when the data for January 2019 are published, the final data for the same month in 2018 will be disseminated.

# Methodological note

The Mortgage Statistics provide information on constitutions of mortgages, that is, regarding the number of new mortgages constituted on real estate properties during the reference month and the amount of the new mortgage loans corresponding to said mortgages. As from 2006, information on changes and cancellations made to the mortgage registers is published. All this information is broken down on the basis of various variables such as the nature of the mortgaged property or lending institution.

All the information on constitutions, changes and register cancellations of mortgages is obtained from the information contained in the Land Registers of the entire national territory, by virtue of a collaboration agreement signed in 2004 between the two institutions. In order to facilitate comparisons, the data for 2003 are presented according to both the old and the new base.

Type of survey: monthly continuous survey

**Population scope**: the registration of mortgages constituted, with changes or cancelled in the land registries

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month

Reference period of the information: the calendar month

Classification: rural and urban properties (dwellings, plots and other urban)

Collection method: administrative records
