Mercantile Companies Statistics (MC)

September 2015. Provisional data

6,444 mercantile companies are created in September, 2.8% less than in the same month of 2014, and 1,269 are dissolved, 3.9% less

The Autonomous Communities with the greatest business dynamism¹ are Aragón (14.3%), Illes Balears (6.6%) and Cataluña (4.7%)

6,444 mercantile companies were created in September, that is, 2.8% less than in the same month of 2014. The capital subscribed for their constitution exceeded 219 million euros, representing a decrease of 42.9%. The average capital subscribed (34,097 euros) decreased 41.3% in its annual rate.

On the other hand, 2,102 mercantile companies increased their capital in September, 4.8% less than in the same month of 2014. The capital subscribed in the increases registered an increase of 9.3% and exceeded 1,818 million euros. The average capital subscribed in these transactions (865,314 euros) increased 14.8% in its annual rate.

The number of companies dissolved in September was 1,269, that is, 3.9% less than in the same month of 2014. Among these, 69.3% did so voluntarily, 12.0% due to mergers and the remaining 18.7 % for other reasons.




Performance of the monthly rate


In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies created and dissolved between August and September in the last five years. In 2015, the monthly variation of the number of companies created was 24.3% and that of the companies dissolved was 6.9%.




Results by main economic activity

21.9% of the mercantile companies created in the month of September corresponded to *Trade* and 16.3% to *Construction*. Regarding the dissolved companies, 20.7% corresponded to *Construction* and 20.6% to *Trade*.









MC - SEPTEMBER 2015 (2/7)



The activity with the greatest net balance of mercantile companies created in September 2015 was *Trade*, with 1,154 new companies.


On the contrary, Agriculture and fishing registered the lowest net balance, with 157 companies created.





The economic activity with the greatest capital subscribed of the mercantile companies created was Real estate, financial and insurance activities, with 128.90 million euros.

In turn, Administrative and support service activities presented the lowest capital subscribed, with 2.63 million euros.

Results by Autonomous Communities

Press Release

The Autonomous Communities with the greatest number of mercantile companies created in September were Comunidad de Madrid (1,583), Andalucía (1,189), and Cataluña (1,072).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (25), Cantabria (54), and Comunidad Foral de Navarra (63).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (321), Andalucía (199) and Comunitat Valenciana (133).

In turn, those with the lowest number of dissolutions were La Rioja (6) and Comunidad Foral de Navarra (9).


In terms of annual variation of the number of mercantile companies created, Aragón (14.3%), Illes Balears (6.6%), and Cataluña (4.7%) recorded the highest rates.

In turn, Galicia (-12.6%), Castilla–La Mancha (-12.1%), and Extremadura (-11.8%) registered the greatest decreases.

Regarding the mercantile companies dissolved, Región de Murcia (76.9%), País Vasco (37.8%), and Comunitat Valenciana (12.7%) were the Autonomous Communities that registered the highest positive rates.

In turn, the Autonomous Communities registering the lowest annual rates were Extremadura (-35.0%), La Rioja (-33.3%), and Cataluña (-22.1%).
