Unpaid Bills of Exchange Statistics (UBE) April 2014. *Provisional data*

The value of unpaid bills of exchange decreases 48.3% in April, as compared with the same month of 2013

2.2% of the total expired bills of exchange are unpaid


In April, the number of expired bills of exchange reached 13,391 million euros, 10.7% below that registered in the same month of 2013.

With regards to returned unpaid bills of exchange, the value reached 292 million euros, representing a 48.3% annual decrease.

The percentage of unpaid bills of exchange as compared with expired bills of exchange reached 2.2%, that is, 1.6 points below that registered in the same month of the previous year.



In April, the total value of expired bills of exchange reached 7,512,299, that is, 5.0% less than in the same month of 2013.

Release

The average value of expired bills of exchange reached 1,782 euros, representing a 6.0% decrease in the annual rate. In turn, the average value of unpaid bills of exchange stood at 1,362 euros, that is, 28.6% less than that registered in April 2013.




Monthly rate evolution

In order to contribute to the analysis and interpretation of data, this chart shows the variation of the unpaid and expired bills of exchange between April and March of the last five years.

In April 2014, the monthly variation of the expired bills of exchange increased 1.4%, and the monthly variation of the unpaid bills of exchange decreased by 3.9%.





Credit expired by type of bill

In April, 64.8% of the value of expired bills of exchange corresponded to unpaid portfolio bills of exchange and 35.2% to debt collection management from clients.

Of the total value of unpaid bills of exchange, 66.5% corresponded to portfolio bills of exchange and 33.5% to bills of exchange in debt collection management.


In April, 2.2% of the total expired portfolio bills of exchange were unpaid. Likewise, 2.1% of the total expired bills of exchange in debt collection management were unpaid.

Geographical distribution of unpaid bills of exchange

In April, the greatest annual decrease of the value of unpaid bills of exchange was registered in Galicia (-86.8%). In turn, Andalucía (-12.2%) and Extremadura (-13.1%) were the Autonomous Communities registering the lowest decrease.



Annual variation of the value of unpaid bills of exchange by Autonomous Community. April 2014

Extremadura (3.6%) was the Autonomous Community that presented the highest percentage of unpaid bills of exchange as compared with the expired bills of exchange. In turn, Castilla y León (1.6%) registered the lowest percentage.

In April, Cataluña and Comunidad de Madrid accumulated around half of the total of unpaid bills of exchange (48.7%).
