#### **Unpaid Bills of Exchange Statistics (UBE)**

May 2014. Provisional data

## The value of unpaid bills of exchange decreases 42.5% in May, as compared with the same month of 2013

#### 2.3% of the total expired bills of exchange are unpaid

In May, the number of expired bills of exchange reached 13,135 million euros, 8.5% below that registered in the same month of 2013.


With regards to returned unpaid bills of exchange, the value reached 307 million euros, representing a 42.5% annual decrease.

The percentage of unpaid bills of exchange as compared with expired bills of exchange reached 2.3%, that is, 1.4 points below that registered in the same month of the previous year.





In May, the total value of expired bills of exchange reached 7,675,415, that is, 2.1% less than in the same month of 2013.

The average value of expired bills of exchange reached 1,711 euros, representing a 6.6% decrease in the annual rate. In turn, the average value of unpaid bills of exchange stood at 1,315 euros, that is, 23.2% less than that registered in May 2013.



#### Monthly rate evolution

In order to contribute to the analysis and interpretation of data, this chart shows the variation of the unpaid and expired bills of exchange between May and April of the last five years.

In May 2014, the monthly variation of the expired bills of exchange decreased 1.9%, and the monthly variation of the unpaid bills of exchange increased by 5.1%.

#### Credit expired by type of bill

In May, 64.1% of the value of expired bills of exchange corresponded to unpaid portfolio bills of exchange and 35.9% to debt collection management from clients.

Of the total value of unpaid bills of exchange, 65.1% corresponded to portfolio bills of exchange and 34.9% to bills of exchange in debt collection management.

In May, 2.4% of the total expired portfolio bills of exchange were unpaid. Likewise, 2.3% of the total expired bills of exchange in debt collection management were unpaid.



#### Geographical distribution of unpaid bills of exchange

In May, the greatest annual decrease of the value of unpaid bills of exchange was registered in Galicia (–82.2%). In turn, Andalucía (–11.2%) was the Autonomous Community registering the lowest decrease.

### Annual variation of the value of unpaid bills of exchange by Autonomous Community. May 2014



Extremadura (3.5%) and Canarias (3.4%) were the Autonomous Communities that presented the highest percentage of unpaid bills of exchange as compared with the expired bills of exchange. In turn, Castilla y León and País Vasco (both at 1.8%) registered the lowest percentage.

In May, Cataluña and Comunidad de Madrid accumulated around half of the total of unpaid bills of exchange (49.7%).
