Unpaid Bills of Exchange Statistics (UBE) September 2013. Provisional data

The value of unpaid bills of exchange decreases 34.1% in September, as compared with the same month of the previous year

2.4% of the total expired bills of exchange are unpaid


In September, the number of expired bills of exchange reached 14,884 million euros, 8.1% below that registered in same month of the previous year.

With regards to returned unpaid bills of exchange, the value reached 351 million euros, representing a 34.1% decrease, as compared with the same month of 2012.

Credit materialised in bills of exchange. September 2013

The percentage of unpaid bills of exchange as compared with expired bills of exchange reached 2.4%, two tenths below that registered in August and nine tenths below that registered in the same month of the previous year.



In September, the total value of expired bills of exchange reached 7,345,297, that is, 2.3% less than that registered in the same month of 2012.

The average value of expired bills of exchange reached 2,026 euros, representing a 6.0% decrease in the interannual rate. In turn, the average value of unpaid bills of exchange stood at 1,490 euros, that is, 14.8% below that registered in the same month of the previous year.


Number and value of bills of exchange. September 2013

Monthly rate evolution

In order to contribute to the analysis and interpretation of data, this chart shows the variation of the unpaid and expired bills of exchange between September and August of the last five years.

This year, the monthly variation of the expired bills of exchange increases 16.7%. In turn, the monthly variation of the unpaid bills of exchange increases 5.6%, the lowest monthly rate of the period.

Credit expired by type of bill

In September, 63.8% of the value of expired bills of exchange corresponded to unpaid portfolio bills of exchange and 36.2% to debt collection management from clients.


Of the total value of unpaid bills of exchange, 63.6% corresponded to portfolio bills of exchange and 36.4% to bills of exchange in debt collection management.


In September, 2.4% of the total expired bills of exchange of portfolio were unpaid. Likewise, 2.4% of the total expired bills of exchange in debt collection management were unpaid.

Geographical distribution of unpaid bills of exchange

In September, the greatest annual decrease of the value of unpaid bills of exchange was registered in Galicia (-58.3%), Principado de Austurias (-53.0%) and Canarias (-52.6%). The Autonomous Community that registered the lowest decrease was Cantabria (-10.1%).





Extremadura (with 3.6%) and Cantabria (3.2%) were the Autonomous Communities that presented the highest percentage of unpaid bills of exchange as compared with the expired bills of exchange. In turn, Galicia (1.6%), La Rioja and Castilla y León (both with 1.9%) registered the lowest percentage.

In September, Cataluña and Comunidad de Madrid accumulated over half of the total of unpaid bills of exchange (50.3%).
