First quarter 2013. Provisional data


The number of debtors processed increases in annual rate 22.8% in the first quarter of 2013

One out of four companies declared bankrupt has *Construction* as its main activity

During the firs quarter of 2013, the number of debtors processed reached 2,854, representing a 22.8% increase, as compared with the same period of the previous year.

By type of bankruptcy, 2,727 were voluntary (25.6% more than in the first quarter of 2012) and 127 were necessary (17.0% less). Considering the type of procedure, ordinary procedures increased 112.7%, and abbreviated procedures increased 2.7%.



Evolution of the quarterly rate

The quarterly variation of the number of debtors processed between the first quarter of 2013 and fourth quarter of 2012 was10.4%. This increase was lower that that registered during the last two years.



Companies declared bankrupt, by legal nature and turnover bracket

Within the 2,854 debtors processed in the first quarter, 2,661 were companies (individuals with business activity and corporations), 30.1% more as compared to the first quarter of the previous year.

By legal nature, 77.3% of the companies processed were Private Limited Companies.

26.2% of the companies processed wee within the lowest turnover bracket (up to 250,000) and were, mainly, Private Limited Companies.

Companies declared bankrupt, by economic activity and number of employees


25.0% of the companies declared bankrupt carried out their main activity in *Construction*, 17.1% in *Trade* and 16.3% in *Industry and energy*.


Regarding the number of employees, 74.1% of the total number of companies declared bankrupt had fewer than 20 employees. Within these, 16% were within the bracket of zero employees.

Taking the total number of exiting companies in each economic activity as a reference, it is worth noting that 0.18% of the *Industry and energy* companies initiated a bankruptcy proceeding during the first quarter of 2013. In turn, only 0.01% of the *Agriculture, livestock and fishing* companies were affected by bankruptcy proceedings.





Companies declared bankrupt, by old section

24.8% of the total number of companies processed during the first quarter of 2013 had an old section of 20 years or over. In turn, 12.4% had a four or less old section.

Within the companies declared bankrupt with and old section of less than four years, 25.2% carried out their main activity in *Professional activities*. However, within the companies declared bankrupt with an old section of 20 years or over, 32.0% carried out their man activity in *Industry and energy*.

Geographical distribution of debtors processed

The Autonomous Communities of Cataluña, Comunidad de Madrid and Comunitat Valenciana accounted for 57.8% of the total debtors processed during the first quarter of 2013.

Cantabria and la Rioja were the Autonomous Communities with the fewest debtors processed.



Regarding to the annual variation rate, Comunitat Valenciana (-9.3), Galicia (-7.6%) and Andalucía (-4.9%) decreased their number of debtors processed.

In turn, Illes Balears registered the greatest annual rate variation (400%). This Autonomous Community went from 77 debtors processed during the first quarter of 2012 to 385 during the same period of 2013.

Note: In February and March, the response rate of the courts was 98.9%, 97.8% respectively, that is, out of the 89 courts to which the questionnaire was sent, 1 and 2 did not submit information by the closing date of the statistics.
