
#### Bankruptcy Proceedings Statistics (BPS) First Quarter 2018. Provisional data

# The number of bankrupt debtors decreases its annual rate by 1.3% in the first quarter of 2018

# 37.5% of the companies declared bankrupt have as their main activity *Trade and Construction*

During the first quarter of 2018, the number of bankrupt debtors reached 1,457 representing a 1.3% decrease, as compared with the same period of the previous year.

By type of bankruptcy, 1,371 were voluntary (0.5% more than the first quarter of 2017) and 86 were necessary (23.2% less). Considering the type of procedure, ordinary procedures decreased 6.6%, and abbreviated procedures did so by 0.5%.

#### Evolution of the guarterly rate



In order to contribute to the analysis and interpretation of the data, the following chart shows the quarterly variation of the number of debtors processed between the first quarter and the fourth guarter of the previous year in the last five years. In 2018 the guarterly rate was 5.6%, the highest for the period in question.

#### Companies declared bankrupt, by legal nature and turnover bracket

Within the 1,457 debtors processed in the first quarter, 1,066 were companies (natural persons with business activity and legal persons), and 391 were natural persons without business activity, representing 73.2% and 26.8%, respectively of the total debtors.

In the first quarter of 2018, the number of bankrupt companies decreased by 3.4%, as compared with the same period of the previous year.

By legal nature, 80.5% of companies declared bankrupt were Private Limited Companies.

38.7% of companies declared bankrupt were within the lowest turnover bracket (up to 250,000 euros) and were mainly Private Limited Companies.

#### Companies declared bankrupt by economic activity and number of employees

The main economic activity of 22.3% of companies declared bankrupt was *Trade*, 15.8% *Other Services* and 15.2% *Construction*.

Regarding the number of employees, 56.3% of the total number of companies declared bankrupt had less than six employees. Among these, 30.5% had no employees.



Taking the total number of existing companies in each economic activity as a reference, 0.06% of companies in the *Industry and energy* sector initiated a bankruptcy proceeding during the first quarter, compared to 0.006% of companies in the *Agriculture and fishing* sector.

By employee bracket, 0.18% of existing companies with 20-49 employees initiated a bankruptcy proceeding, as compared with 0.01% of companies without employees.



#### Bankrupt companies by seniority

20.5% of the total number of bankrupt companies during the first quarter were 20 years old or over. In turn, 20.5% were four years old or younger.


26.0% of bankrupt companies with four or less years of experience were in the *Trade* sector. On the other hand, 52.3% of bankrupt companies with 20 or more years of experience were involved in *Trade*, and in *Industry and energy*.

Taking the stock of existing companies by seniority as a reference, 0.033% of those that were 20 years old or more were affected by a bankruptcy proceeding this quarter. However, 0.020% of total companies with up to four years old initiated a bankruptcy proceeding.

In terms of annual variation of the number of bankrupt debtors, Región de Murcia was the Autonomous Community with the highest decrease (-46.4%). In turn, La Rioja registered the highest increase (125.0%).
