**Bankruptcy Proceedings Statistics**  
Fourth quarter of 2011. *Provisional data\**

**The number of debtors processed increases 13.3% in 2011, as compared with 2010**

**One in three companies declared bankrupt has *Construction and property development* as their main activity**

The number of debtors processed was 6,755 in 2011, representing a 13.3% increase as compared with 2010. This figure include 934 Individuals without business activity declared in bankruptcy proceedings, 3.9% less than 2010.

By type of proceeding, 6,472 were voluntary (14.5% more than the last year) and 283 were necessary (9.3% less).

Considering the type of proceedings, abbreviated proceedings increased 17.4% and ordinary proceedings decreased 24.0%.

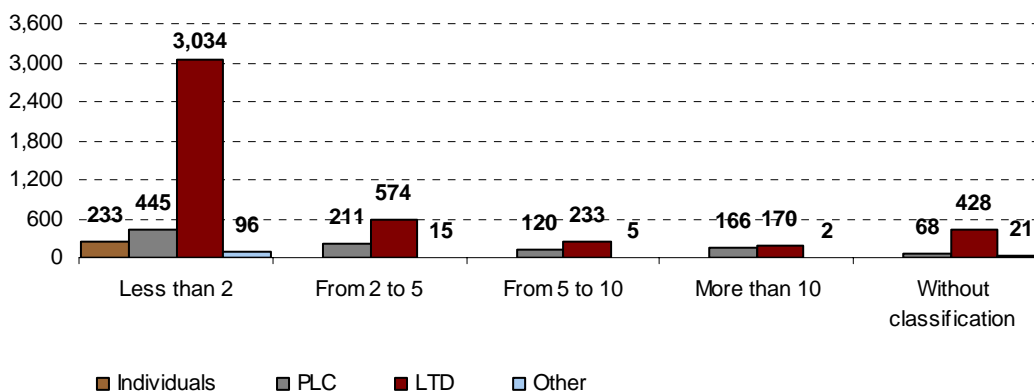
By type of company processed, the number of Individuals with business activity decreased 11.1% in the interannual rate, whereas the number of Private Limited Companies increased 18.2% and Public Limited Companies 14.1%. Most companies declared bankrupt were Private Limited Companies (76.3%).

\*The data provided relating to the fourth quarter of 2011 corresponds to that submitted by 27 January 2012, by the Mercantile Courts, the Courts of First Instance and the Courts of First Instance and Trial with mercantile jurisdiction.

### Companies processed, by legal nature and turnover bracket

65.4% of the companies declared bankrupt in 2011 were within the lowest turnover bracket (less than two million euros). Considering the legal form of the companies declared bankrupt, this section includes all Individuals with business activity, 68.3% of Private Limited Companies and 44.1% of Public Limited Companies.

### Companies declared bankrupt, by economic activity

Of the 6,755 debtors processed in the year 2011, 86.2% were companies (individuals with business activity and corporations). One in three of these companies were dedicated to *Construction and property development*.

*Transport and storage* was the economic activity in which the number of companies declared bankrupt increased the least, as compared with the year 2010 (2.9%). In contrast, *Trade* was the economic activity in which it increased the most (23.4%).

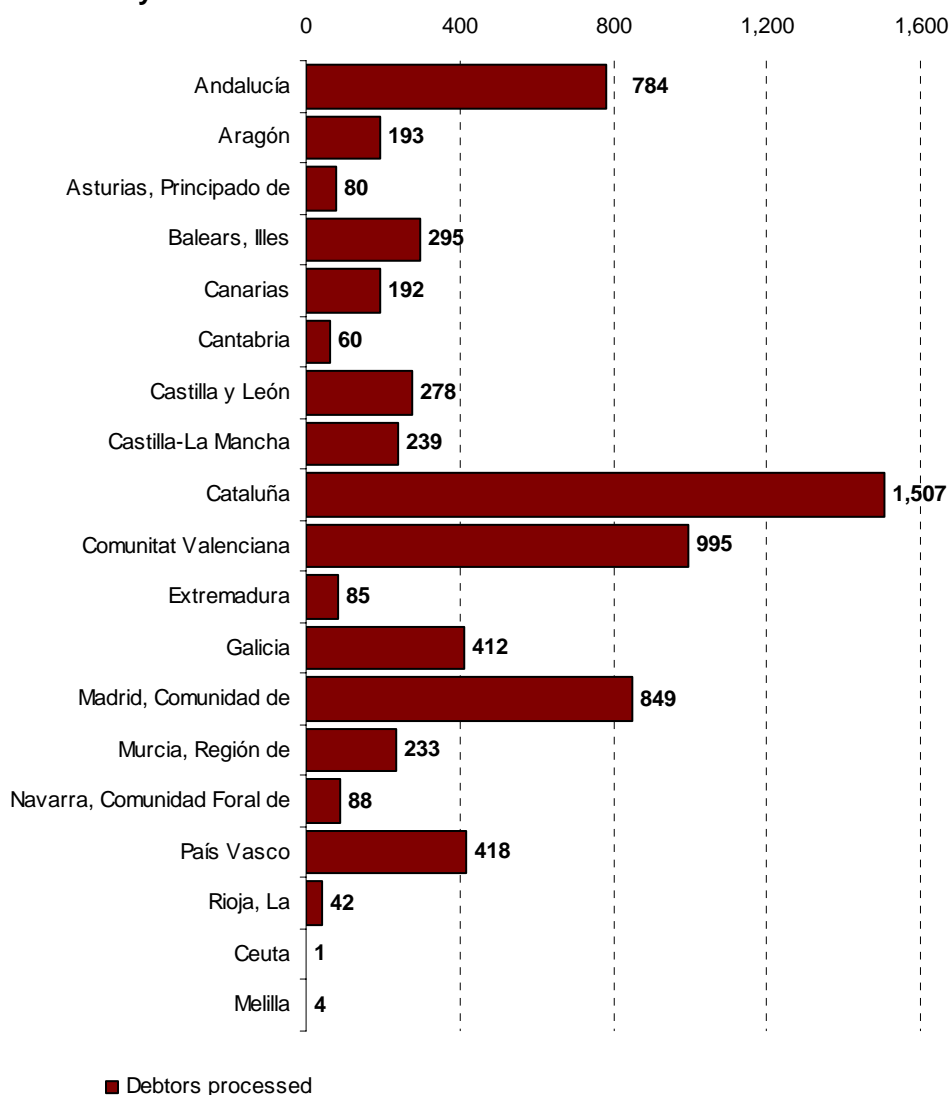

### Results by Autonomous Community and City

Cataluña was the Autonomous Community with the highest number of debtors processed (1,507) in the year 2011, followed by Comunitat Valenciana (995), Comunidad de Madrid (849), and Andalucía (784). These four Communities accounted for more than 61.2% of the total debtors processed.

The Communities with the lowest number of debtors processed were La Rioja (42) and Cantabria (60).

**Total debtors processed by Autonomous Community and city**

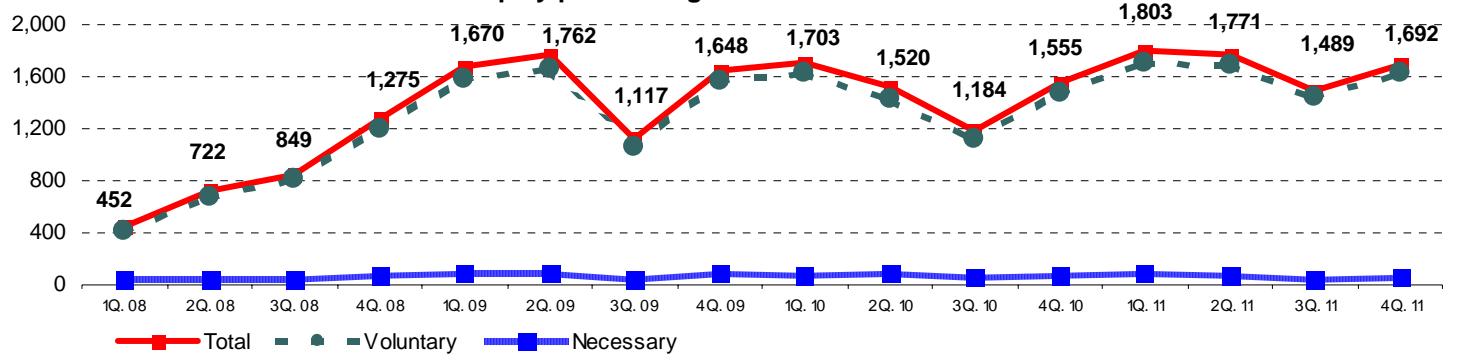


## Results for the fourth quarter

In the fourth quarter of 2011, the number of debtors processed reached 1,692, which implied a 8.8% decrease as compared with the same quarter the previous year, and a 13.6% increase as compared with the third quarter of 2011.

By type of bankruptcy, voluntary increased 10.6% and necessary decreased 22.6%. Considering the type of process, abbreviated processes increased 11.4% and ordinary proceedings decreased 15.6%.

The number of Individuals without business activity who declared in bankruptcy proceedings decreased 26.3%, as compared with the fourth quarter 2010, whereas the number of Companies declared bankrupt increased 15.6%. Within the companies, 77.8% were Private Limited Companies.

The Autonomous Community with the most debtors processed were Cataluña (379), Comunitat Valenciana (284) and Comunidad de Madrid (213). In turn, La Rioja (14) and Cantabria (15) showed the lowest number of debtors processed.
