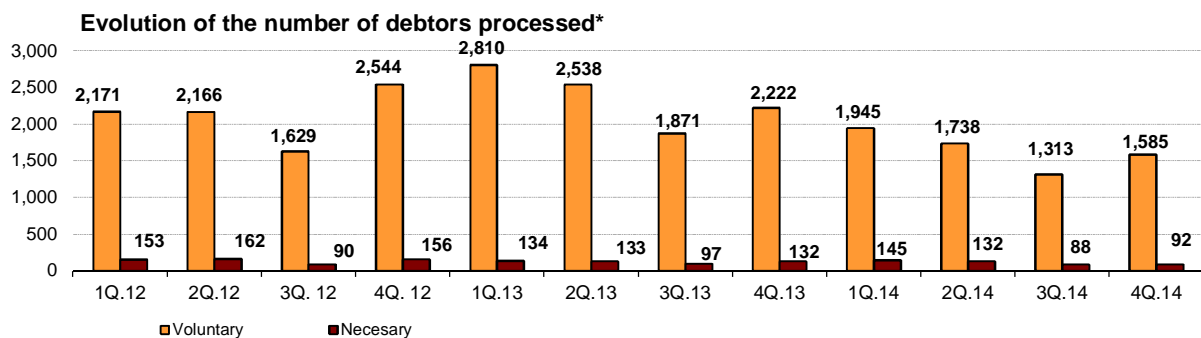

Fourth quarter 2014 and year 2014. *Provisional data*

**The number of debtors processed decreases its annual rate by 28.8% in the fourth quarter of 2014**

**Construction accounted for 22.1% of the total of debtors processed**

During the fourth quarter of 2014, the number of debtors processed reached 1,677, representing a 28.8% decrease, as compared with the same period of the previous year.

By type of bankruptcy, voluntary decreased by 28.7% and necessary did so by 30.3%. Considering the type of procedure, abbreviated procedures decreased 27.0%, and ordinary procedures did so by 36.4%.



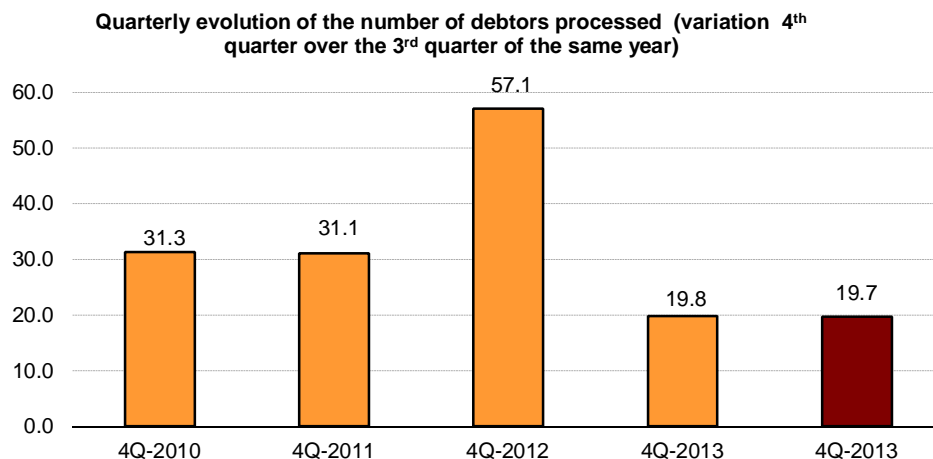

## Evolution of the quarterly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the quarterly variation of the number of debtors processed between the fourth and the third quarter of the last five years. In 2014, the quarterly rate was 19.7%, the second lowest of the period.



## Companies declared bankrupt, by legal nature and turnover bracket

Within the 1,677 debtors processed in this quarter, 1,535 were companies (individuals with business activity and corporations), and 142 were individuals without business activities, representing 91.5% and 8.5%, respectively, of the total debtors.

In the fourth quarter of 2014, the number of companies processed decreased 29.5%, as compared with the same period of the previous year.

By legal nature, 79.3% of the companies processed were Private Limited Companies.

35.4% of the companies processed were within the lowest turnover bracket (up to 250,000 euros) and were, mainly, Private Limited Companies.

### Companies declared bankrupt, by economic activity and number of employees

This quarter, 22.1% of the companies declared bankrupt carried out their main activity in *Construction*, 19.7% in *Trade* and 16.2% in *Industry and energy*.

Regarding the number of employees, 71.7% of the total number of companies declared bankrupt had less than 10 employees. Within these, 54.4% had at least three employees.

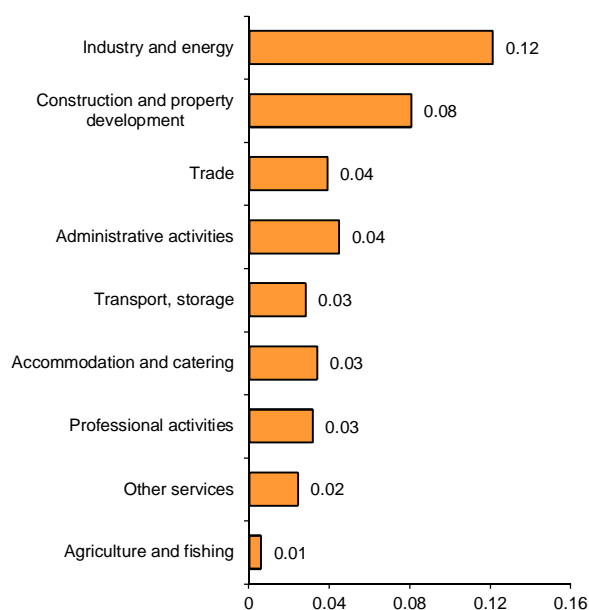

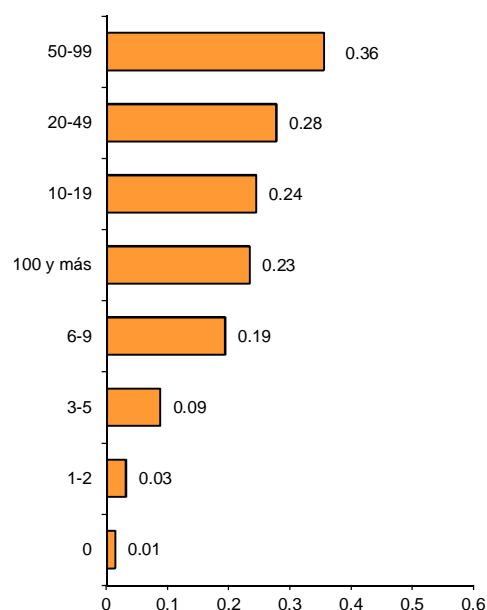
Taking the total number of existing companies in each economic activity as a reference, 0.12% of the *Industry and energy* companies initiated a bankruptcy proceeding during the fourth quarter. In turn, only 0.01% of the *Agriculture and fishing* companies were affected by bankruptcy proceedings.

By employee bracket, 0.36% of the companies with 50-99 employees started a bankruptcy proceeding, as compared with 0.01% of the companies without employees.

### Companies declared bankrupt, by seniority

23.6% of the total number of companies processed during the fourth quarter had a seniority of 20 years or over. In turn, 14.6% had a seniority of four years or less.

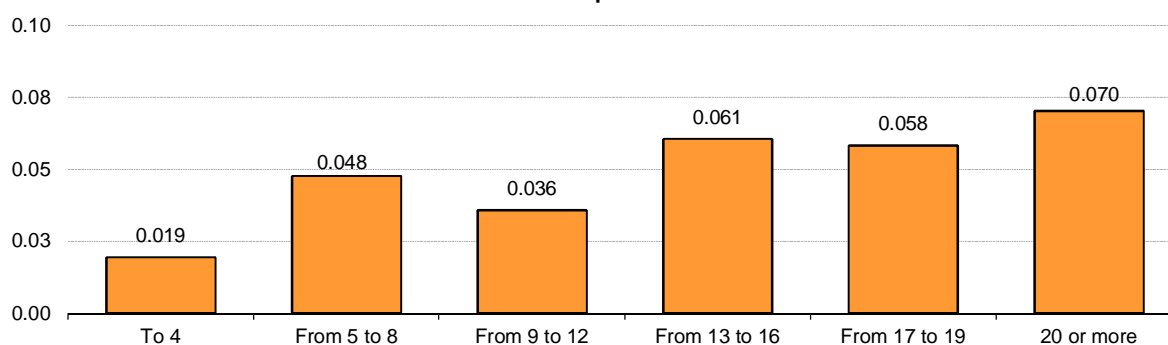
Within the companies declared bankrupt with a seniority of less than four years, 25.4% carried out their main activity in *Trade*. In turn, within the companies declared bankrupt with seniority of 20 years or over, 28.2% carried out their main activity in *Industry and energy*.

Taking as a reference the stock of existing companies by seniority, 0.07% of the companies of 20 years or over were affected by a bankruptcy proceeding this quarter. However, 0.02% of the total companies with up to four years of seniority started a bankruptcy proceeding.

## Geographical distribution of debtors processed

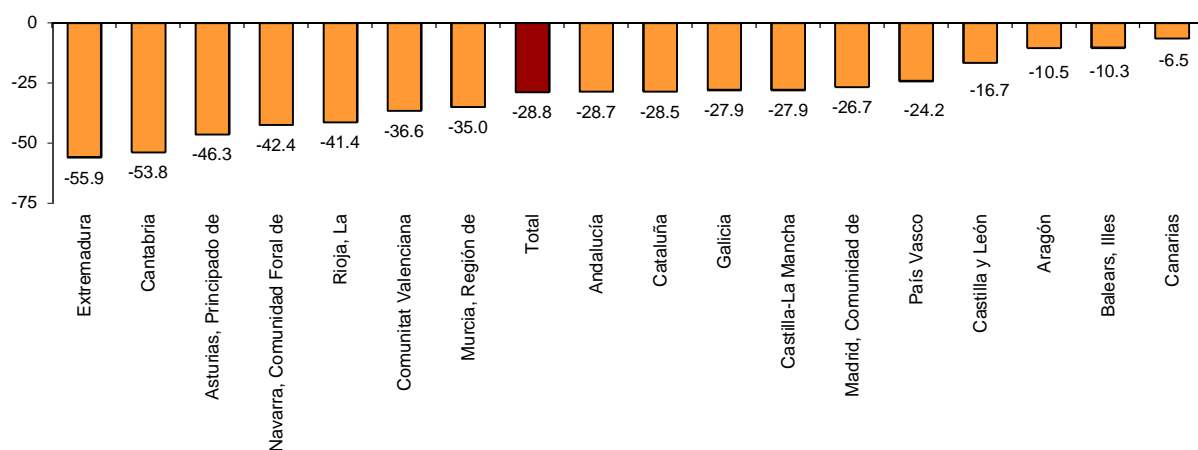
The Autonomous Communities of Cataluña, Comunidad de Madrid and Comunitat Valenciana accounted for 51.0% of the total debtors processed during the fourth quarter of 2014.

The Autonomous Community that registered the greatest decrease in the number of bankrupt debtors considering the annual variation rate was Extremadura (-55.9%). In turn, the lowest decrease was registered in Canarias (-6.5%).

% Annual variation of debtors processed by Autonomous Community

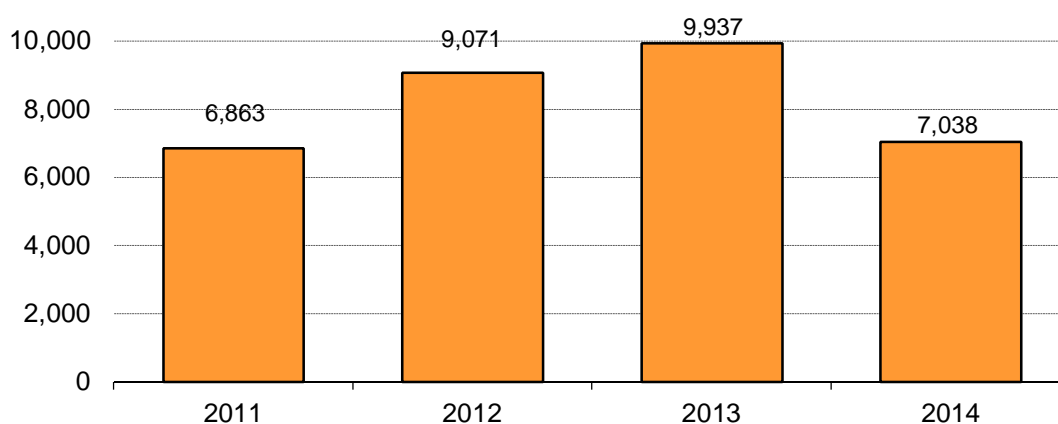


## Results for 2014 as a whole

In 2014 as a whole, the number of debtors processed reached 7,038, representing a 29.2% decrease, as compared with 2013.

By type of bankruptcy, 6,581 were voluntary (30.3% less than in 2013) and 457 were necessary (7.9% less). Considering the type of procedure, ordinary procedures decreased by 46.6%, and abbreviated procedures increased by 23.7%.

### Companies declared bankrupt, by legal nature and turnover bracket

By legal nature, 78.7% of the companies processed in 2014 were Private Limited Companies.

30.9% of the companies processed were within the lowest turnover bracket (up to 250,000 euros) and were, mainly, Private Limited Companies.

**Companies declared bankrupt, by main economic activity**

90.8% of debtors processed in 2014 were companies (individuals with business activity and corporations).

By activity, *Construction, Trade and Industry and energy* accounted for 58.9% of the companies processed in 2014.

*Administrative activities* (-40.2%), *Construction* (-38.6%) and *Trade* (-24.7%) registered the greatest decreases of companies processed in 2014, as compared to the previous year. In turn, *Accommodation and catering* (-7.3%) registered the lowest decrease.

24.2% of the total number of companies processed in 2014 had a seniority of 20 years or over. In turn, 12.0% had a seniority of four years or less.

The economic activity with the highest percentage of companies processed with seniority of 20 years or over was *Trade* (28.9%).

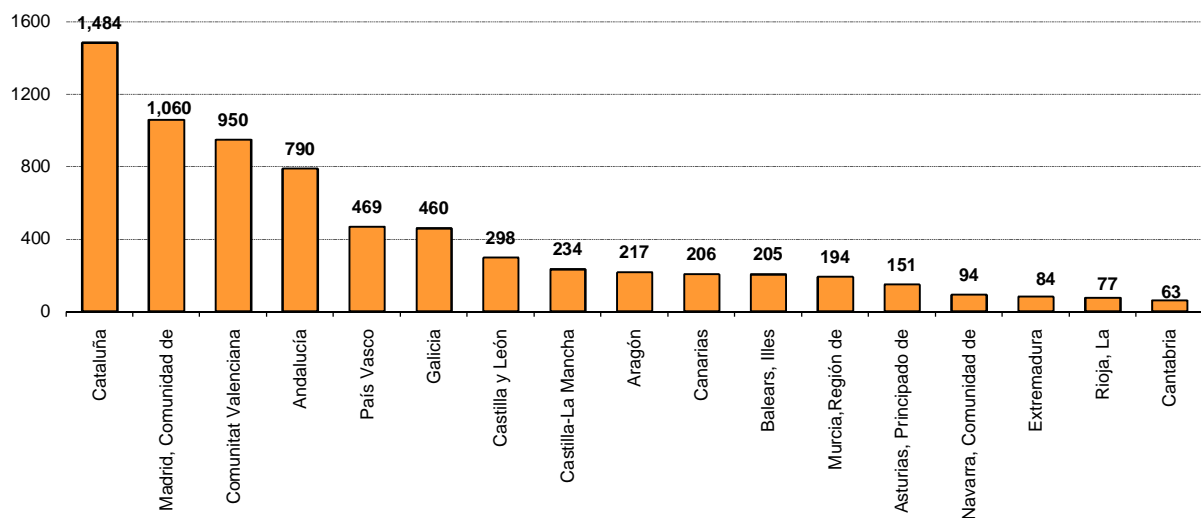

## Results by Autonomous Community

Cataluña was the Autonomous Community with the largest number of debtors processed in 2014 (1,484), followed by Comunidad de Madrid (1,060) and Comunitat Valenciana (950). These Autonomous Communities accounted for 49.6% of the total debtors processed.

The Autonomous Community that registered the lowest number of debtors processed was Cantabria (63).
