Bankruptcy Proceedings Statistics (BPS) Fourth quarter and year 2017. *Provisional data*

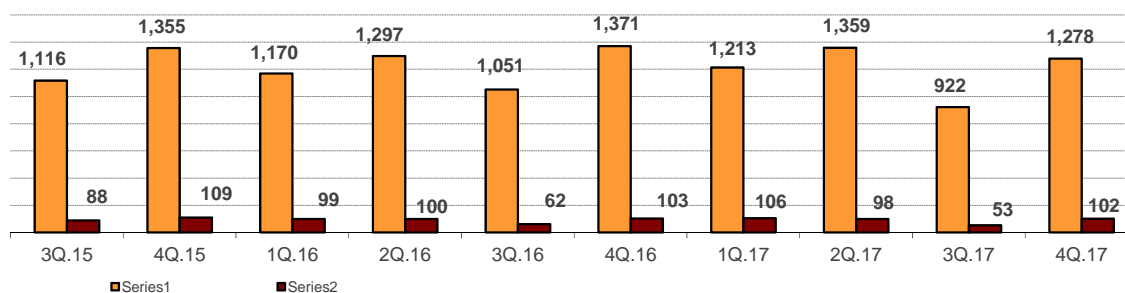
The number of bankrupt debtors decreases its annual rate by 6.4% in the fourth quarter.

The number of bankrupt debtors decreased by 2.3% for the year 2017 as a whole.

During the fourth quarter of 2017, the number of bankrupt debtors reached 1,380 representing a 6.4% decrease, as compared with the same period of the previous year.

By type of bankruptcy, 1,278 were voluntary (6.8% less than the fourth quarter of 2016) and 102 were necessary (1.0% less). Considering the type of procedure, ordinary procedures decreased 16.2%, and abbreviated procedures did so by 4.9%.

Evolution of the number of debtors processed*



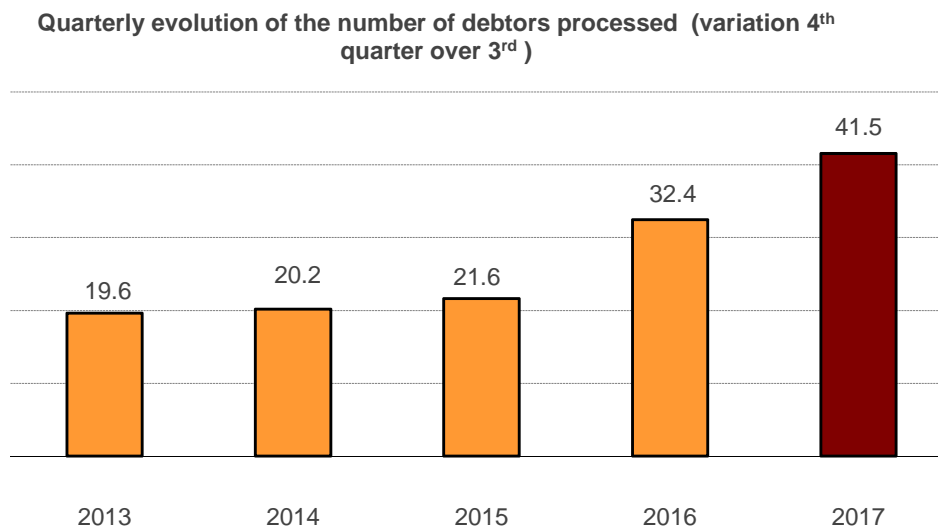

Evolution of the quarterly rate

To contribute to the analysis and interpretation of the data, the following chart shows the quarterly variation of the number of bankrupt debtors between the fourth and the third quarter in the last five years. In 2017 the quarterly rate was 41.5%, the highest for the period in question.



Companies declared bankrupt, by legal nature and turnover bracket

Among the 1,380 bankrupt debtors in the quarter, 1,084 were companies (individuals with business activity and corporations), and 296 were individuals without business activities, representing 78.6% and 21.4%, respectively, of the total debtors.

In the fourth quarter of 2017, the number of companies declared bankrupt decreased by 7.5%, as compared with the same period of the previous year.

By legal nature, 81.5% of the companies declared bankrupt were Private Limited Companies.

38.7% of companies declared bankrupt were within the lowest turnover bracket (up to 250,000 million euros) and were mainly Private Limited Companies.

Companies declared bankrupt by economic activity and number of employees

22.9% of the companies declared bankrupt carried out their main activity in *Trade*, 17.6% in *Other Services* and 13.2% in *Construction*.

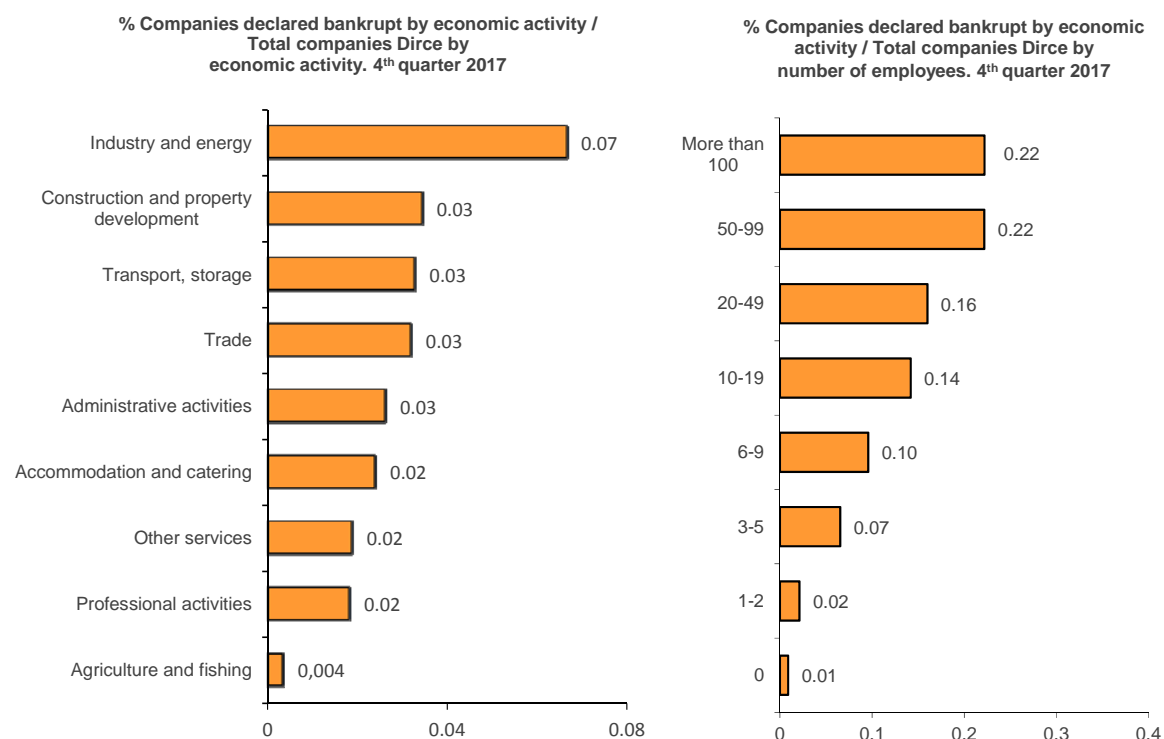
Regarding the number of employees, 56.9% of the total number of companies declared bankrupt had less than six employees. Among these, 29.8% had no employees.

Taking the total number of existing companies in each economic activity as a reference, 0.07% of the *Industry and energy* companies initiated a bankruptcy proceeding during the fourth quarter, as compared with 0.004% of the *Agriculture and fishing* companies.

By number of employees, 0.22% of the companies with 100 or more employees or between 50 and 99 employees started bankruptcy proceedings, as compared with 0.01% of the companies without employees.



Companies declared bankrupt by seniority

20.4% of the total number of companies declared bankrupt during the fourth quarter had a seniority of 20 years or more. In turn, 24.4% had a seniority of four years or less.

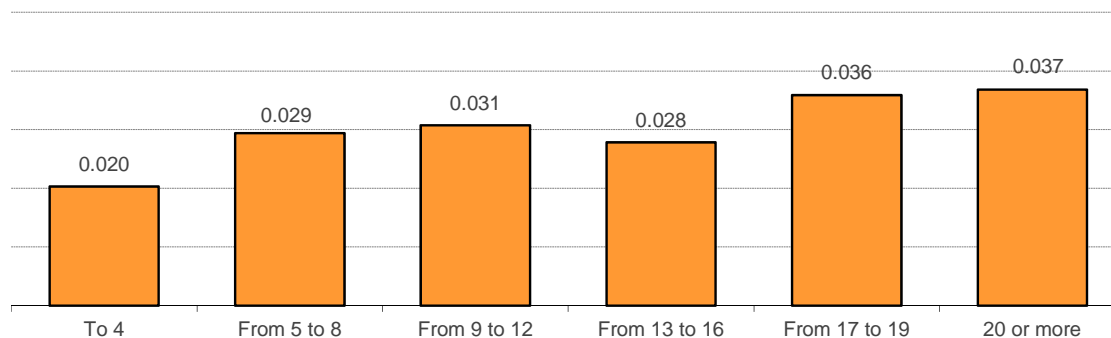
Within the companies declared bankrupt with a seniority of four years or less, 25.3% carried out their main activity in *Trade*. In turn, within the companies declared bankrupt with seniority of 20 years or over, 53.8% carried out their main activity in *Trade*, and *Industry and energy*.

Taking the stock of existing companies by seniority as a reference, 0.037% of the companies 20 years or over were affected by a bankruptcy proceeding this quarter. However, 0.020% of the total companies with up to four years of seniority started a bankruptcy proceeding.

% Companies declared bankrupt by economic activity / Total companies Dirce by old section. 4th quarter 2017



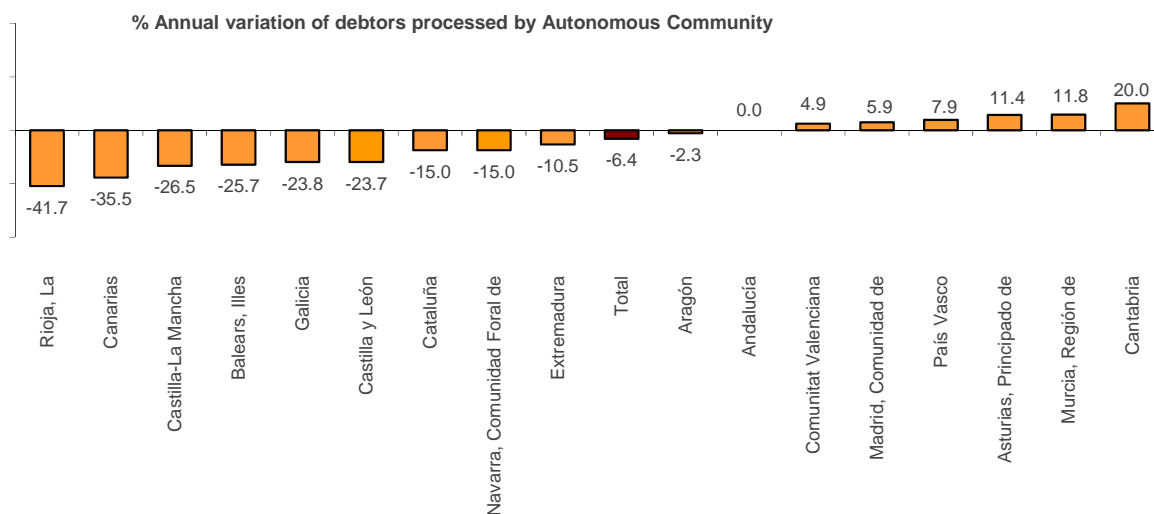
Results by Autonomous Community

In terms of annual variation of the number of bankrupt debtors, La Rioja underwent the greatest decrease (-41.7%) and Cantabria underwent the greatest increase (20.0%).

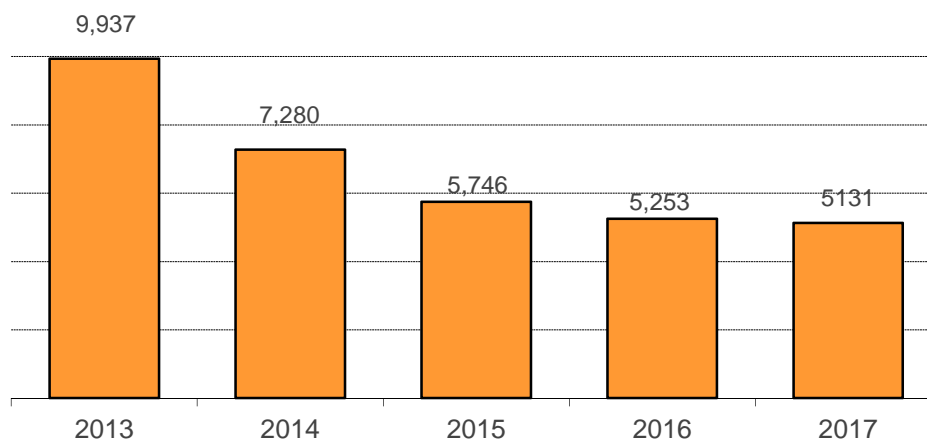


Results for the whole of the year 2017

In 2017 as a whole the number of bankrupt debtors was 5,131, a 2.3% decrease compared to 2016.

By type of bankruptcy, 4,772 were voluntary (2.4% less than in 2016) and 359 were necessary (1.4% less). Considering the type of procedure, ordinary procedures decreased by 6.4%, and abbreviated procedures did so by 1.7%.

Processed companies by legal nature and turnover bracket

By legal nature, 80.7% of the companies declared bankrupt in 2017 were Private Limited Companies.

36.8% of companies declared bankrupt were within the lowest turnover bracket (up to 250,000 million euros) and were mainly Private Limited Companies.

Companies declared bankrupt by main economic activity

In 2017, 79.8% of bankrupt debtors were companies (individuals with business activity and corporations).

By economic activity, *Trade* and *Other Services* represented 37.0% of the total of companies declared bankrupt in 2017.

Construction (-19.4%), *Accommodation and catering* (-18.1%) and *Administrative activities* (-10.9%) showed the greatest decrease in the number of companies declared bankrupt in 2017 in comparison to the previous year.

Conversely, *Agriculture and fishing* (13.6%), *Transport and storage* (10.8%) and *Industry and energy* (2.5%) recorded the greatest increases.

Companies declared bankrupt by economic activity and seniority

22.3% of the total number of companies declared bankrupt during 2017 had a seniority of 20 years or more. In turn, 20.6% had a seniority of four years or less.

The economic activity with the greatest percentage of companies declared bankrupt with seniority of 20 years or more was *Trade* (28.7%).

Number of companies declared bankrupt by main economic activity and old section (years)

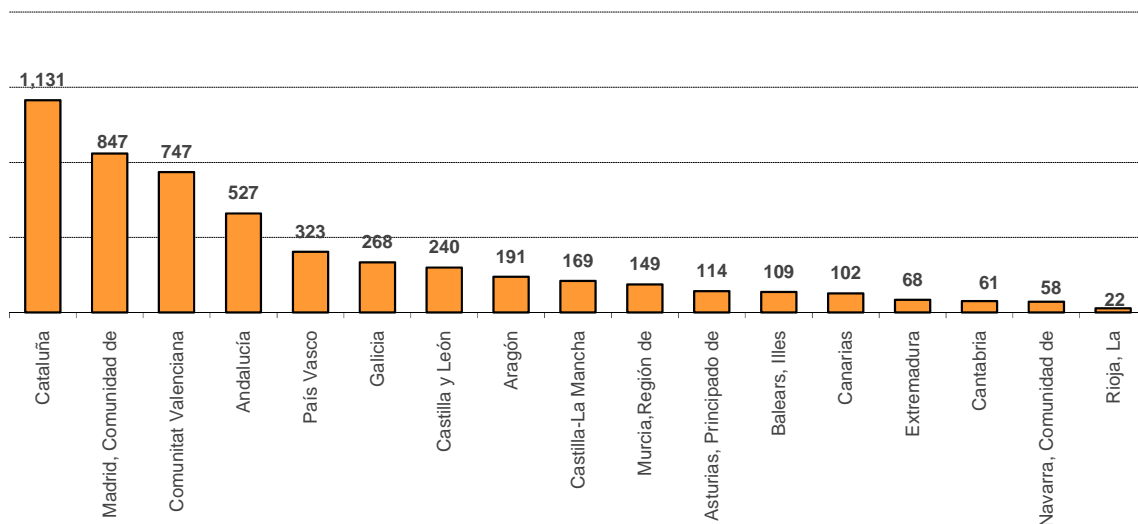

Results by Autonomous Community

In 2017, the Autonomous Communities with the greatest number of bankrupt debtors were Cataluña (1,131), Comunidad de Madrid (847) and Comunitat Valenciana (747). These three Autonomous Communities accounted for 53.1% of the total of bankrupt debtors.

In turn, the Autonomous Community with the lowest number of bankrupt debtors was La Rioja (22).
