Statistics on Transfer of Property Rights (STPR) May 2017. Provisional data


In May 166,093 property transfers were registered, that is 10.1% more than that in the same month of the previous year

The merchanting of registered dwellings increases by 23.0%, as compared with May of 2016

The number of property transfers **recorded in the land registers (from public deeds previously registered)** was 166,093 in May, that is, 10.1% more than in the same month of 2016.

Regarding the merchanting of registered properties, the number of transfers was 89,174, with a 19.3% annual increase.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, non recourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

Of the registered merchanting in May, 85.7% correspond to urban properties and 14.3% to rustic properties. Among the urban properties, 58.6% were merchanting of dwellings.

In May, the number of merchanting of rustic properties increased by 8.1% in the annual rate, while that of urban properties did so by 21.5%. Within the latter, merchanting of dwellings recorded an annual increase of 23.0%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of April and May in the last five years. In 2017, the monthly rate was 39.0%, that is, 35.7 points more than that of the previous year and the highest from the period in question.

Registered merchanting on dwellings, by protection system and status

Of transfers of dwellings by merchanting in May 90.8% were free, and 9.2% were protected.

In annual terms, the number of transfers of free dwellings by merchanting increased by 25.0%, and that of protected dwellings did so by 6.0%.


Of the dwellings transferred by merchanting in May 17.3% are new, and 82.7% are used.

The number of transactions on new dwellings increased by 12.6%, while that of used dwellings increased 25.4% as compared with May 2016.

Results by Autonomous Communities

In May, the total number of property transfers recorded in the land registries per 100,000 inhabitants² reached its highest values in Aragón (699), La Rioja (686) and Castilla y León (627).

The Comunidad de Madrid (25.8%), Principado de Asturias (19.0%) and Extremadura (16.7%) registered the greatest annual variations.

In turn, País Vasco (-6.6%), Comunidad Foral de Navarra (-5.2%) and La Rioja (-4.4%), registered the lowest rates.


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants² are Illes Balears (214), Comunitat Valenciana (175) and Andalucía (132).

² This data was calculated from the provisional data of the Population Figures on 1 January 2017. Of these figures only the population aged 18 to 84 years old was considered.

The Autonomous Communities showing the greatest annual increase amount in the number of merchanting of dwellings are Castilla-La Mancha (39.4%), Illes Balears (36.7%) and Principado de Asturias (36.2%).

In turn, La Rioja (-30.3%), Región de Murcia (-12.9%) and Galicia (-2.6%) registered the only annual rate decreases.
