

Statistics on Transfer of Property Rights (STPR)August 2013. *Provisional data*


In August, the number of property transfers was 119,237, 7.0% less than in the same month of the previous year

The annual rate of merchanting of dwellings decreases 15.4%, as compared with August 2012

The number of property transfers **recorded in the land registries (from public deeds previously registered)** was 119,237 in August, that is, a 7.0% decrease, as compared with the same month of 2012.

In the case of registered merchanting of property, the number of transfers was 50,378, representing an annual decrease of 16.3%.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, Nonrecourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

85.4% of the registered merchanting in August corresponded to urban properties and 14.6% to rustic properties. Among the urban properties, 54.7% were merchanting of dwellings.

The number of merchanting of rustic properties decreased 4.8% in the annual rate in August, and that of urban properties decreased 18.0%. Within the latter, merchanting of dwellings decreased 15.4%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of July and August of the last five years. In 2013, the monthly rate was -8.4%, representing 11.2 points less than that of last year.

Registered merchanting on dwellings, by protection system and status

90.5% of transfers of dwellings by merchanting in August were free housing, and 9.5% were protected housing. In annual terms, the number of transfers of free dwellings by merchanting decreased 15.3%, and that of protected housing decreased 16.5%.



44.6% of the dwellings transferred by merchanting in August were new, and 55.4% were used.

The number of transactions on new dwellings decreased 24.8%, and the number of used dwellings decreased 5.9%, as compared with August 2012.

Geographical distribution

In August 2013, the total number of property transfers recorded in the land registries per 100,000 inhabitants² reached its highest value in the Autonomous Communities of La Rioja (610) and Castilla y León (547).

The Autonomous Community showing the highest annual variation rates was La Rioja (26.5%).

In turn, the Autonomous Communities that registered the highest annual decrease were Illes Balears (-24.2%) and Cantabria (-23.1%).


By registered merchanting on dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants² were La Rioja (112) and Comunitat Valenciana (89).

² This data was calculated from the revision of the figures of the Municipal Register for the year 2012. Only the population aged 18 to 84 years old was considered.

The Autonomous Community showing the highest annual variation rate in the merchanting on dwellings in August was Comunidad Foral de Navarra (20.4%).

In turn, those showing the greatest decreases were Cantabria (-39.2%) and Principado de Asturias (-38.2%).
