Statistics on Transfer of Property Rights (STPR)
 September 2017. *Provisional data*


In September, 135,170 properties were registered in the land registers, 1.8% more than that in the same month of the previous year

The merchanting of registered dwellings increases by 11.0%, as compared with September 2016

The number of property transfers **recorded in the land registers (from public deeds previously registered)** was 135,170 in September, that is, 1.8% more than in the same month of 2016.

Regarding the merchanting of registered properties, the number of transfers was 74,110, with an annual increase of 7.6%.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, non recourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

86.6% of the registered merchanting in September corresponded to urban properties and 13.4% to rustic properties. Among the urban properties, 60.2% were merchanting of dwellings.

In September, the number of merchanting of rustic properties increased by 3.9% in the annual rate, while that of urban properties did so by 8.2%. Within the latter, merchanting of dwellings recorded an annual increase of 11.0%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of August and September of the last five years. In 2017, the monthly rate was -6.5%, that is, 4.3 points less than that of the previous year and the lowest from the period in question.

Registered merchanting on dwellings, by protection system and status

90.3% of transfers of dwellings by merchanting in September were free housing, and 9.7% were protected housing.

In annual terms, the number of transfers of free dwellings by merchanting increased by 13.2%, and that of protected dwellings decreased by 6.4%.


18.3% of the dwellings transferred by merchanting in September were new, and 81.7% were used.

The number of transactions on new dwellings increased by 17.7%, while that of used dwellings increased 9.6% as compared with September 2016.

Results by Autonomous Communities

In September, the total number of property transfers recorded in the land registers per 100,000 inhabitants² reached its highest value in La Rioja (544), Castilla y León (537) and Aragón (529).

Cantabria (16.9%), La Rioja (13.3%) and Castilla-La Mancha (12.7%) registered the highest annual rate variations.

In turn, Comunidad Foral de Navarra (-17.3%), Canarias (-5.7%) and Cataluña (-5.0%) registered the lowest annual rates.


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants² were Comunitat Valenciana (151), Illes Balears (143) and Comunidad de Madrid (121).

² This data was calculated based on provisional data from the population figures dated 01 January 2017. Only the population aged 18 to 84 years old was considered in these figures.

The Autonomous Communities that registered the greatest annual increases in the number of merchanting of dwellings in September were Castilla-La Mancha(44.0%), Región de Murcia (27.0%) and Extremadura (24.2%).

In turn, Comunidad Foral de Navarra (-2.7%), Castilla y León (1.2%) and Cataluña (2.1%) registered the lowest annual variation rates in September.
