Statistics on Transfer of Property Rights (STPR)


October 2017. *Provisional data*

In October, 143,249 properties are registered in the land registers, 12.3% more than in the same month of the previous year

The merchanting of dwellings registered increases by 25.7%, as compared with October 2016

The number of property transfers **recorded in the land registers (from public deeds previously registered)** was 143,249 in October, that is, 12.3% more than in the same month of 2016.

Regarding the merchanting of registered properties, the number of transfers was 74,286, with an annual increase of 21.4%.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several transfer titles, transfers without title of acquisition, non recourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

85.2% of the registered merchanting in October corresponded to urban properties and 14.8% to rustic properties. Among the urban properties, 58.8% were merchanting of dwellings.

In October, the number of merchanting of rustic properties increased by 10.5% in the annual rate, while that of urban properties did so by 23.6%. Within the latter, merchanting of dwellings recorded an annual increase of 25.7%.

Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of September and October in the last five years. In 2017, the monthly rate was -3.6%, that is, 11.3 points more than that of the previous year.

Registered merchanting on dwellings, by protection system and status

90.6% of transfers of dwellings by merchanting in October were free dwellings and 9.4% were protected dwellings.

In annual terms, the number of transfers of free dwellings by merchanting increased by 26.5%, and that of protected dwellings did so by 19.1%.


18.6% of the dwellings transferred by merchanting in October were new, and 81.4% were used.

The number of transactions on new dwellings increased by 29.8%, while that of used dwellings increased 24.8% as compared with October 2016.

Results by Autonomous Community

In October, the total number of property transfers recorded in the land registries per 100,000 inhabitants² reached its highest value in La Rioja (663), Castilla y León (609) and Castilla-La Mancha (573).

La Rioja (34.5%), Comunidad de Madrid (29.9%) and Castilla-La Mancha (23.6%) registered the greatest annual variations..

In turn, Principado de Asturias (-2.9%), Comunidad Foral de Navarra (-1.3%) and Cataluña (2.8%), registered the lowest annual rates.


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants² were Illes Balears (135), Comunitat Valenciana (130) and Comunidad de Madrid (122).

² This data was calculated based on the provisional results of the population figures as at 01 January 2017. Only the population aged 18 to 84 years old was considered in these figures.

The Autonomous Communities showing the greatest annual increases in the number of merchanting of dwellings in October were Comunidad de Madrid (50.0%), La Rioja (47.5%) and Comunidad Foral de Navarra (40.8%).

In turn, Cataluña (12.4%), Extremadura (13.8%) and Canarias (17.0%) registered the lowest annual rates in October.
