
November 2013. Provisional data

In November, the number of property transfers was 130,787, that is 3.2% less than in the same month of the previous year

The annual rate of merchanting of dwellings decreases 15.9%, as compared with November 2012

The number of property transfers **recorded in the land registries (from public deeds previously registered)** was 130,787 in November, that is, a 6.4% increase, as compared with the same month of 2012.

In the case of the merchanting of registered properties, the number of transfers was 53,157, representing an annual decrease of 7.7%.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, Nonrecourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

82.2% of the registered merchanting in November corresponded to urban properties and 17.8% to rustic properties. Among the urban properties, 50.0% were merchantings of dwellings.

The number of merchanting of rustic properties increased 2.9% in the annual rate in November, and that of urban properties decreased 9.7%. Within the latter, merchanting of dwellings decreased 15.9%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchanting of dwellings between the months of October and November of the last five years. In 2013, the monthly rate was -4.1%, representing 6.7 points less than that of last year and the lowest one in the last five years.

Registered merchanting on dwellings, by protection system and status

91.9% of transfers of dwellings by merchanting in November were free housing, and 8.1% were protected housing. In annual terms, the number of transfers of free dwellings by merchanting decreased 13.6%, and that of protected housing decreased 35.1%.


45.0% of the dwellings transferred by merchanting in November were new, and 55.0% were used.

The number of transactions on new dwellings decreased 22.1%, and the number of used dwellings decreased 10.0%, as compared with November 2012.

Geographical distribution

In November 2013, the total number of property transfers recorded in the land registries per 100,000 inhabitants² reached its highest value in the Autonomous Communities of Castilla y León (568), Aragón (537) and Castilla-La Mancha (520).

The Autonomous Communities showing the highest annual variation rates were Cataluña (24.3%) and Comunidad Foral de Navarra (16.1%).

In turn, the Autonomous Communities that registered the highest annual decrease were La Rioja (-44.1%) and Cantabria (-32.8%).

Number of property transfers, by Autonomous Cities and Communities



By registered merchanting on dwellings, the Autonomous Community with the highest number of transfers per 100,000 inhabitants² was Comunitat Valenciana (89).

² This data was calculated from the revision of the figures of the Municipal Register for the year 2012. Only the population aged 18 to 84 years old was considered.

The Autonomous Communities showing the highest annual variation rate in the merchanting on dwellings were Canarias (13.5%) and Comunidad Foral de Navarra (9.7%). turn, those showing the greatest decreases were La Rioja (-66.6%) and Cantabria (-55.0%).
