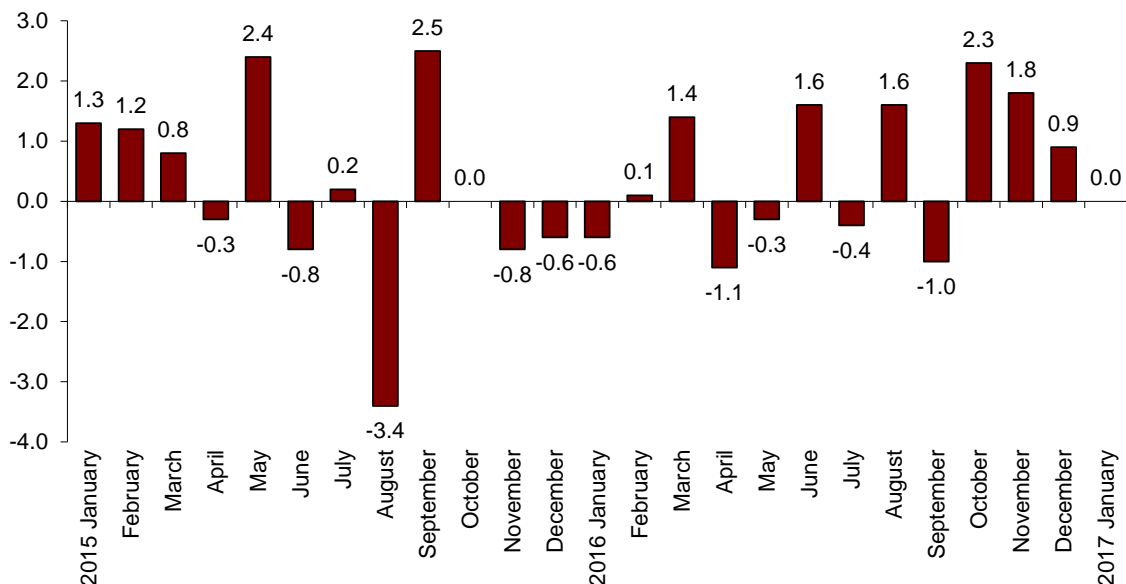
The monthly variation of the General Industry Turnover Index¹ stands at 0.0%, after adjusting for seasonal and calendar effects

The annual rate stands at 7.1% in the series adjusted for seasonal and calendar effects and at 13.1% in the original series

Monthly evolution of the Industry Turnover

The monthly variation of the General Industry Turnover Index between the months of January and December was 0.0%, after adjusting for the seasonal and calendar effects. This rate was nearly one point lower than that of the previous month.

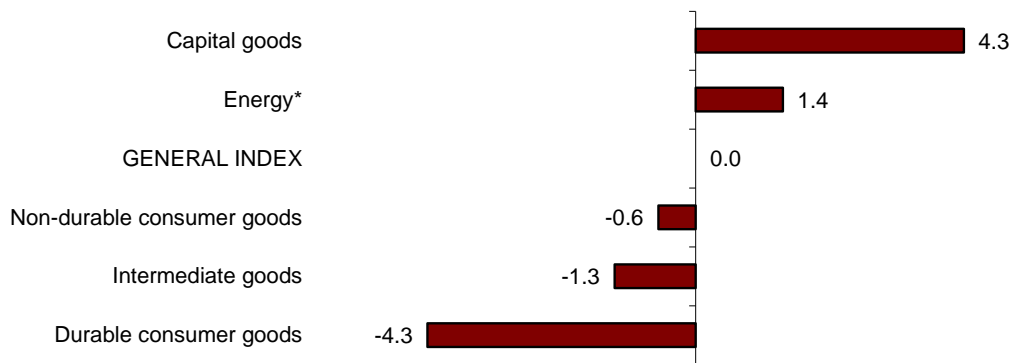
Turnover General Index

¹ As explained in the methodology for this value index, the information is presented in current terms (nominal terms), that is, without adjusting the effects in the price variation thereof.

By economic destination of the goods, *Capital goods* (4.3%) and *Energy* (1.4%) registered positive monthly rates. Conversely, *Durable consumer goods* (-4.3%), *Intermediate goods* (-1.3%) and *Non-durable consumer goods* (-0.6%) registered negative monthly rates.

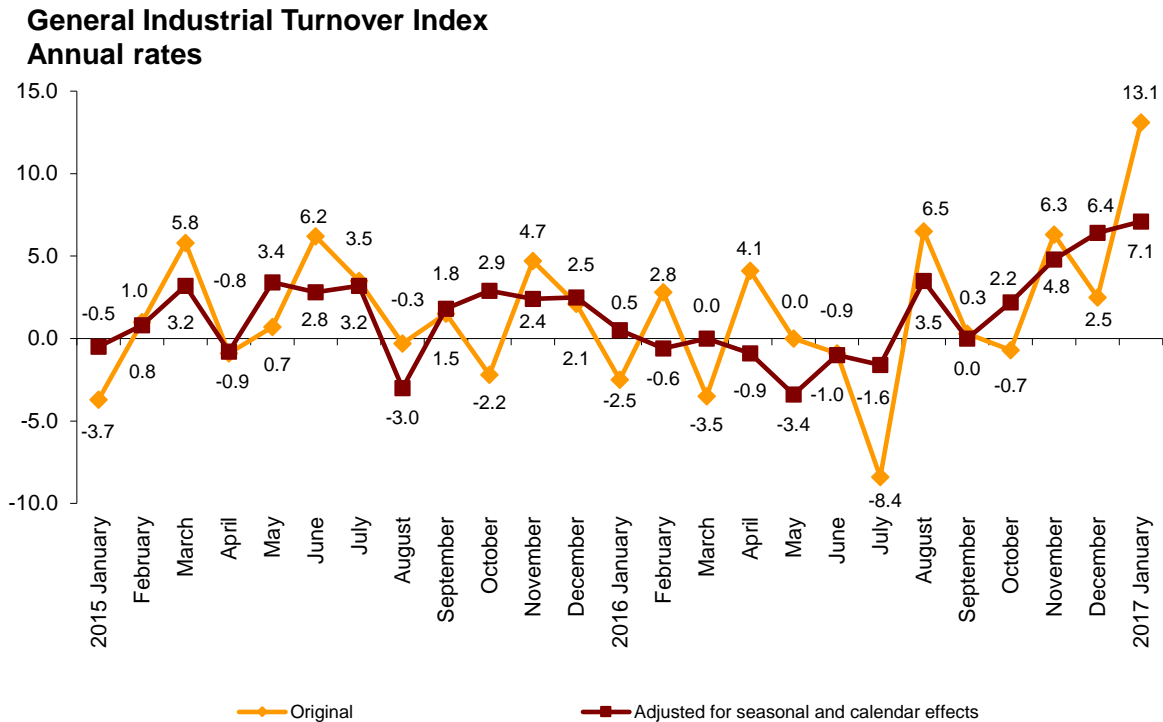

Annual evolution of the Industrial Turnover Indices

The General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of 7.1% in January, as compared with the same month of the previous year. This rate is seven tenths higher than that registered in December.

The original series of the ITI registered an annual variation of 13.1%. This rate is 10.6 points higher than that registered in December.



By economic destination of the goods, the indices adjusted for seasonal and calendar affects show positive annual rates in four of the five sectors analysed. It is worth noting the increase in *Energy* (61.8%).

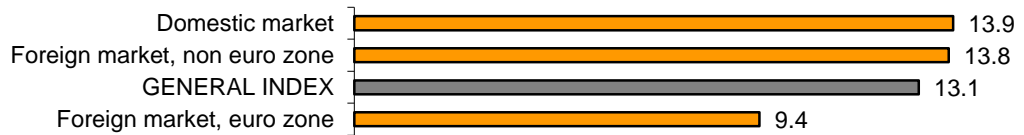

By geographical destination of sales, in January all the markets analysed showed positive annual rates. The greatest decrease was registered in the domestic market (13.9%).

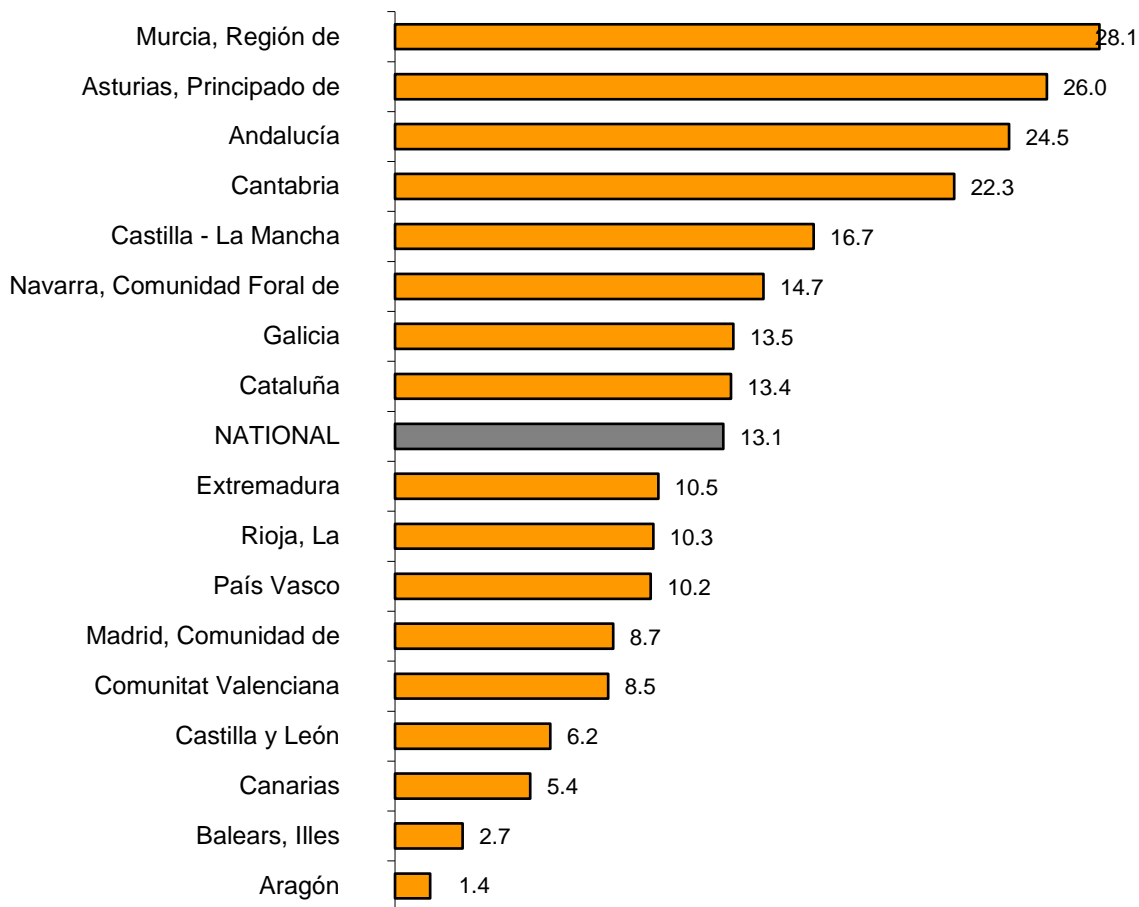
**Industrial turnover indices: General and by market

Turnover increased in all Autonomous Communities, as compared to January 2016. The highest increase is registered in Región de Murcia (28.1%) and the lowest in Aragón (1.4%).
