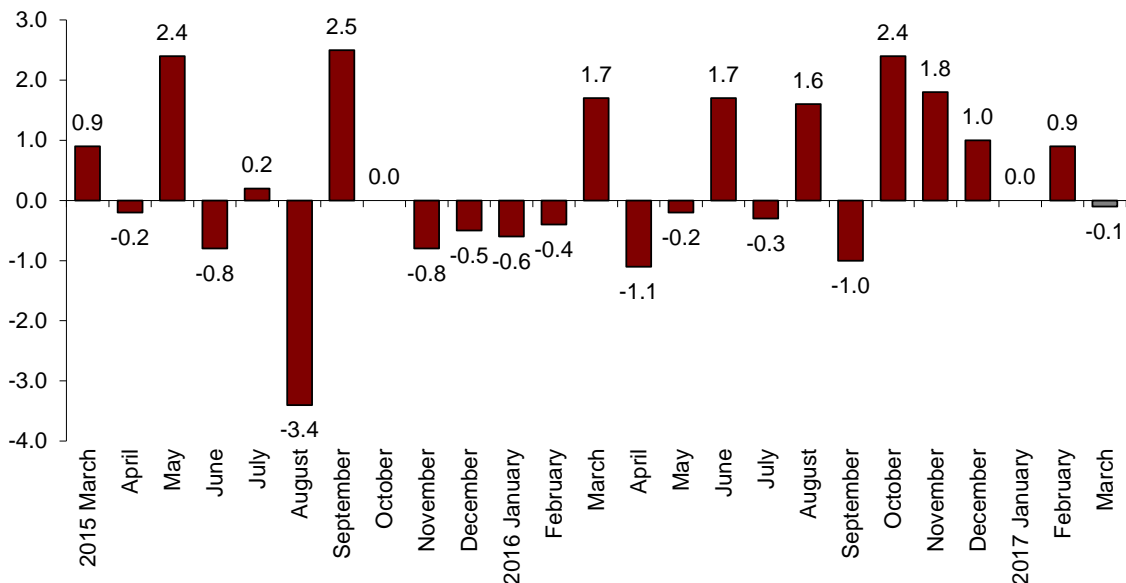
**The monthly variation of the General Industry Turnover Index<sup>1</sup> stands at -0.1%, after adjusting for seasonal and calendar effects**

**The annual rate stands at 6.8% in the series adjusted for seasonal and calendar effects, and at 15.5% in the original series**

**Monthly evolution of the Industry Turnover**

The monthly variation of the General Industry Turnover Index between the months of March and February was -0.1%, after adjusting for the seasonal and calendar effects. This rate is one point lower than that of the previous month.

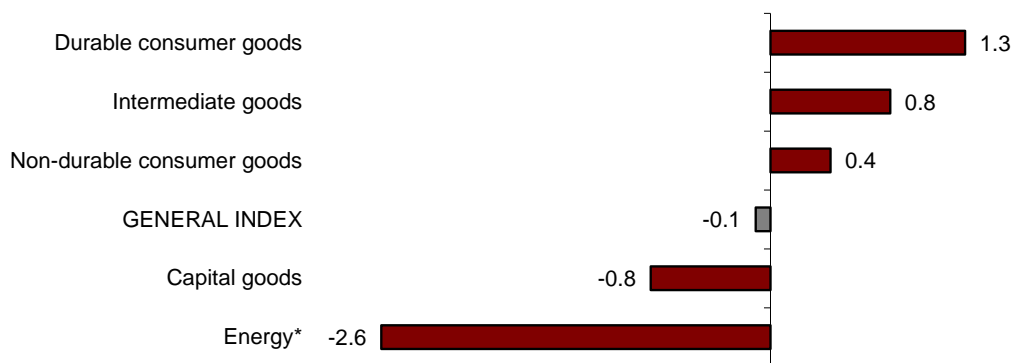
**Turnover General Index**

<sup>1</sup> As reflected in the methodology of this value index, the information is presented in current terms (nominal terms), this is, without adjusting the effects in the price variation thereof.

By economic destination of the goods, *Durable consumer goods* (1.3%), *Intermediate goods* (0.8%) and *Non-durable consumer goods* (0.4%) registered positive monthly rates. In turn, *Energy* (-2.6%) and *Capital goods* (-0.8%) registered negative rates.

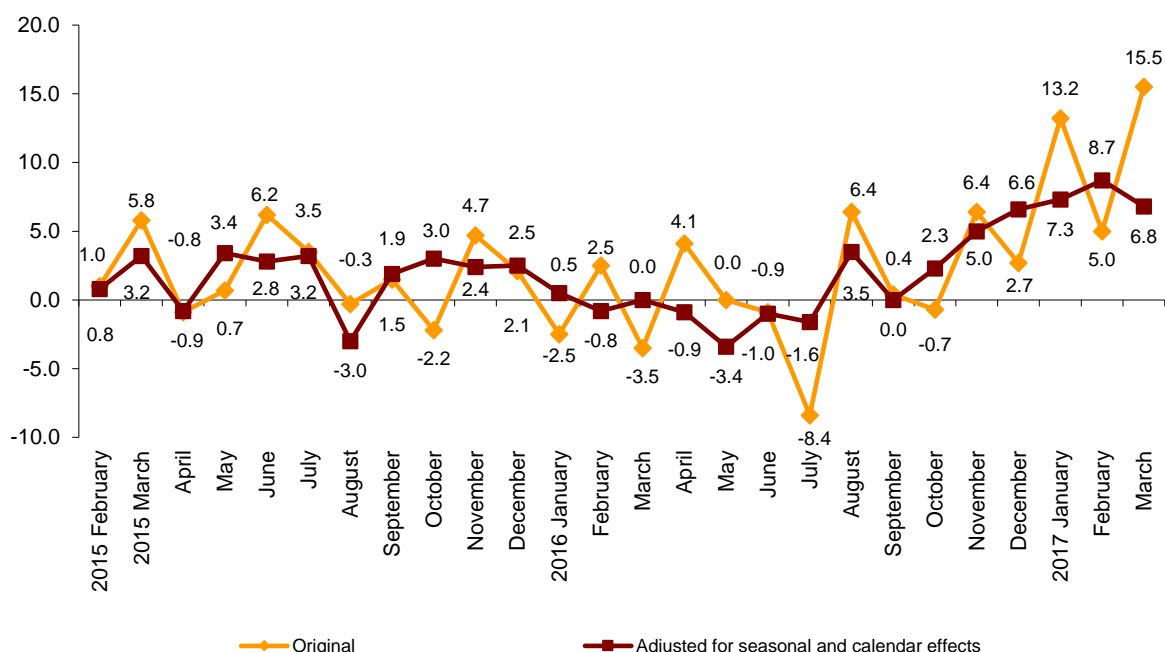

## Annual evolution of the Industrial Turnover Indices

The General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of 6.8% in March, as compared with the same month of the previous year. This rate is almost two points lower than that registered in February.

The ITI original series registered a 15.5% annual variation. This rate is 10.5 points higher than that registered in February.

### General Industrial Turnover Index Annual rates



By economic destination of the goods, the indices adjusted for seasonal and calendar effects recorded positive annual rates in all the sectors analysed, noting the increase in *Energy* (30.6%).

## Annual evolution of the Industrial Turnover Indices by market. Original series

By geographical destination of sales, in March, all the markets recorded positive annual rates. Worth noting was the 16.0% increase in the domestic market.

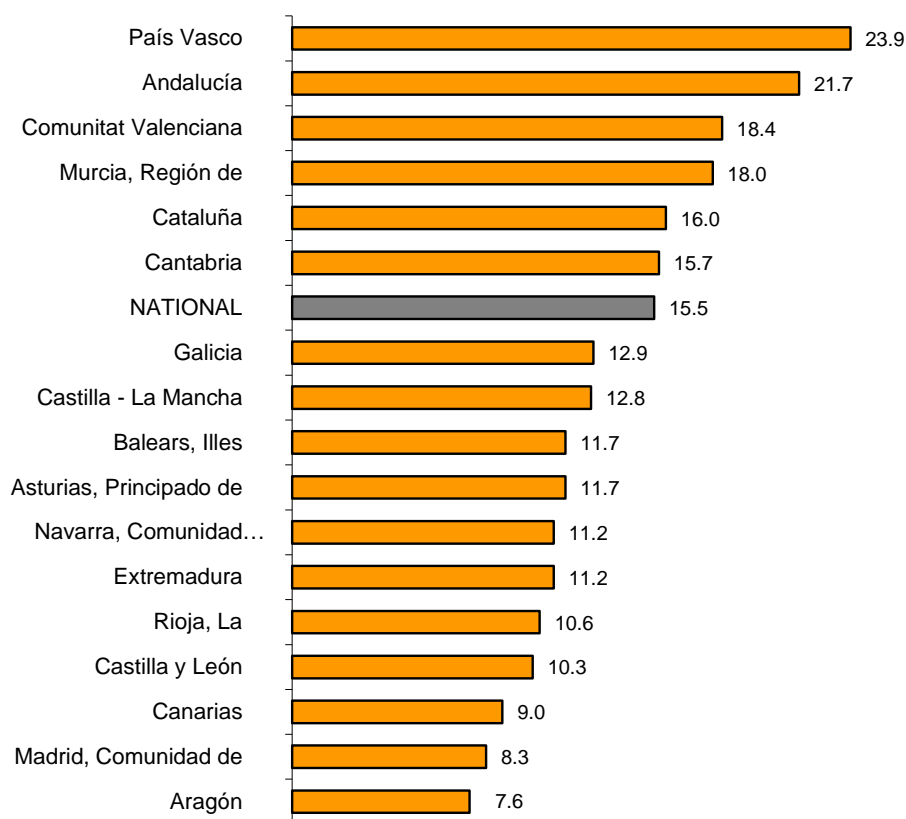
### Industrial turnover indices: General and by market Annual rate



## Results by Autonomous Community. Annual variation rates of the Industrial turnover. Original series

Turnover increased in all Autonomous Communities, as compared to March 2016. The highest rates were recorded in País Vasco (23.9%), Andalucía (21.7%) and Comunitat Valenciana (18.4%). In turn, Aragón (7.6%), Comunidad de Madrid (8.3%) and Canarias (9.0%) registered the lowest increases.
