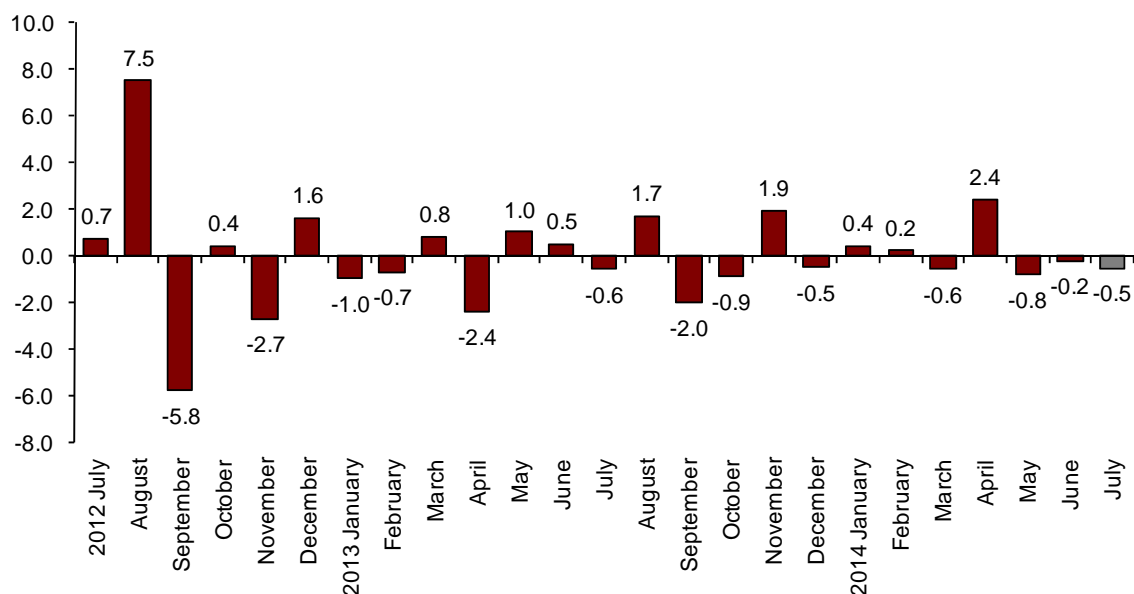
The monthly variation of the General Industry Turnover Index stands at -0.5% , after adjusting the seasonal and calendar effects

The annual rate stands at 1.0% in the seasonally and calendar adjusted series and at 1.3% in the original series

Monthly evolution of the Industry Turnover

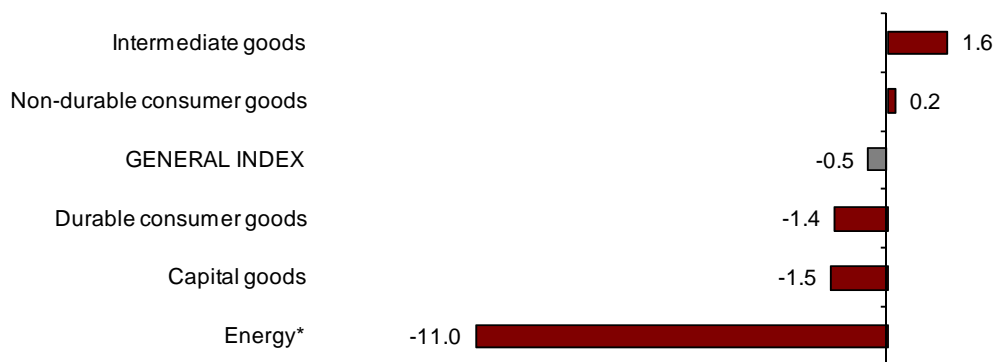
The monthly variation of the General Industry Turnover Index (ITI) between the months of July and June 2014 was -0.5% , after adjusting for the seasonal and calendar effects. This rate was three tenths lower than that of the previous month.

By economic destination of the goods, Intermediate goods (1.6%) and Non-durable consumer goods (0.2%) registered positive monthly rates. In turn, Energy (-11.0%), Capital goods (-1.5%) and Durable consumer goods (-1.4%) registered negative monthly rates.

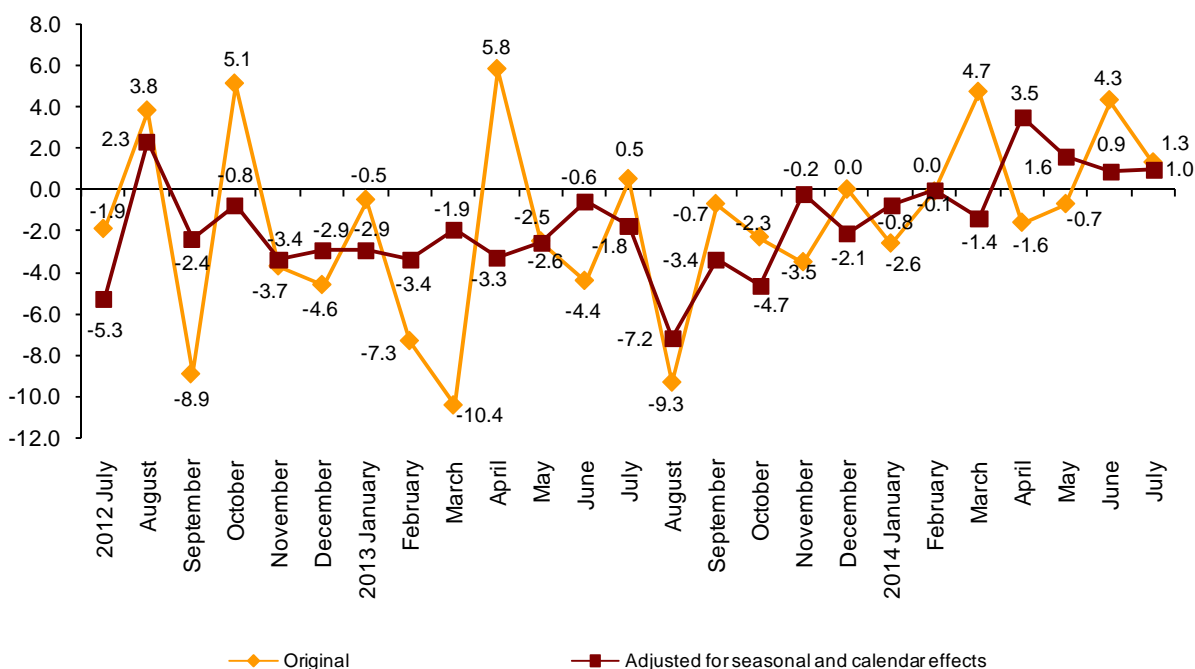

Annual evolution of the Industrial Turnover indices

The General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of 1.0% in July, as compared with the same month of the previous year. This rate was one tenth higher than that registered in June 2014.

The original series of the ITI registered an annual variation of 1.3%, that is, three points lower than that registered in June 2014.

General Industrial Turnover Index Annual rates



By economic destination of the goods, three out of five sectors analysed registered positive annual rates, after adjusting for seasonal and calendar effects. Intermediate goods registered the highest increase (1.6%) and Durable consumer goods registered the greatest decrease (-2.0%).

By geographical destination of sales, two out of three markets analysed registered negative annual rates. Worth noting was the decrease in the non euro zone foreign market (-5.1%).

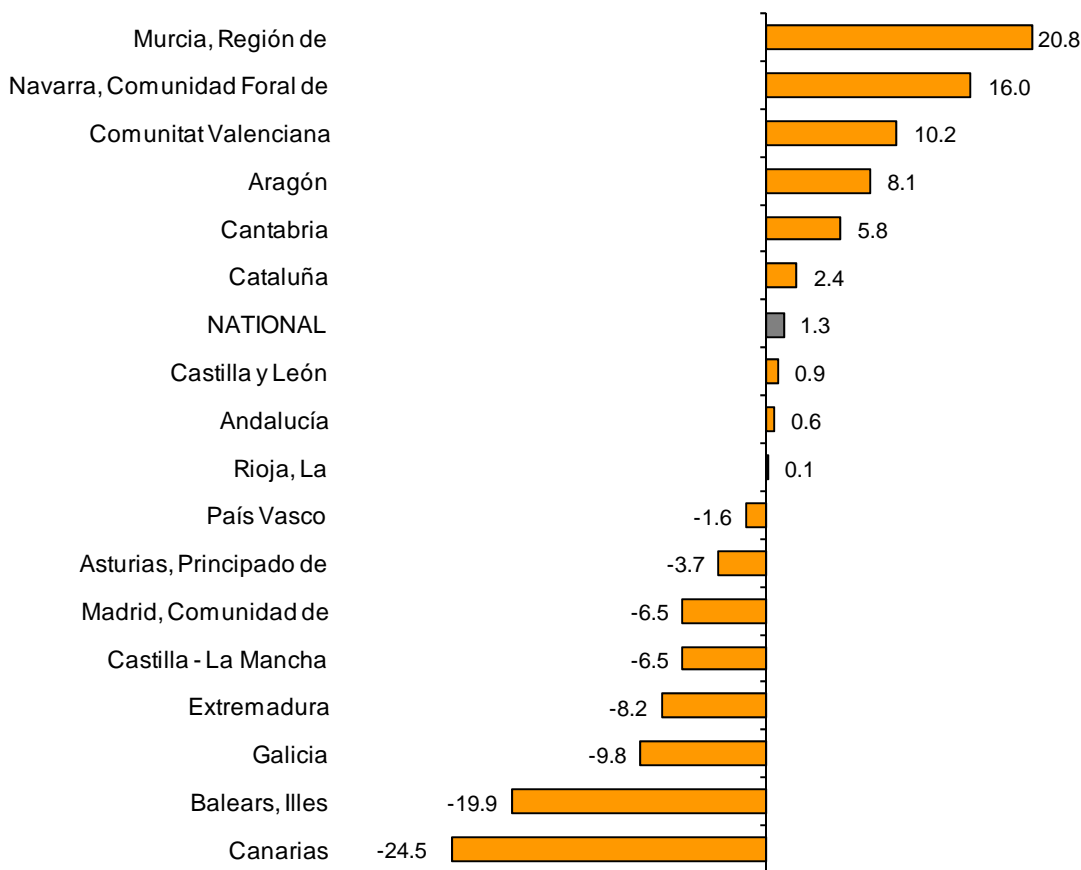
**Industrial turnover indices: General and by market

Results by Autonomous Community. Annual variation rates of the Industrial Turnover. Original series

Turnover increased in nine Autonomous Communities and decreased in eight, as compared with July 2013. The greatest increase was registered in Región de Murcia (20.8%) and the greatest decrease in Canarias (-24.5%).
