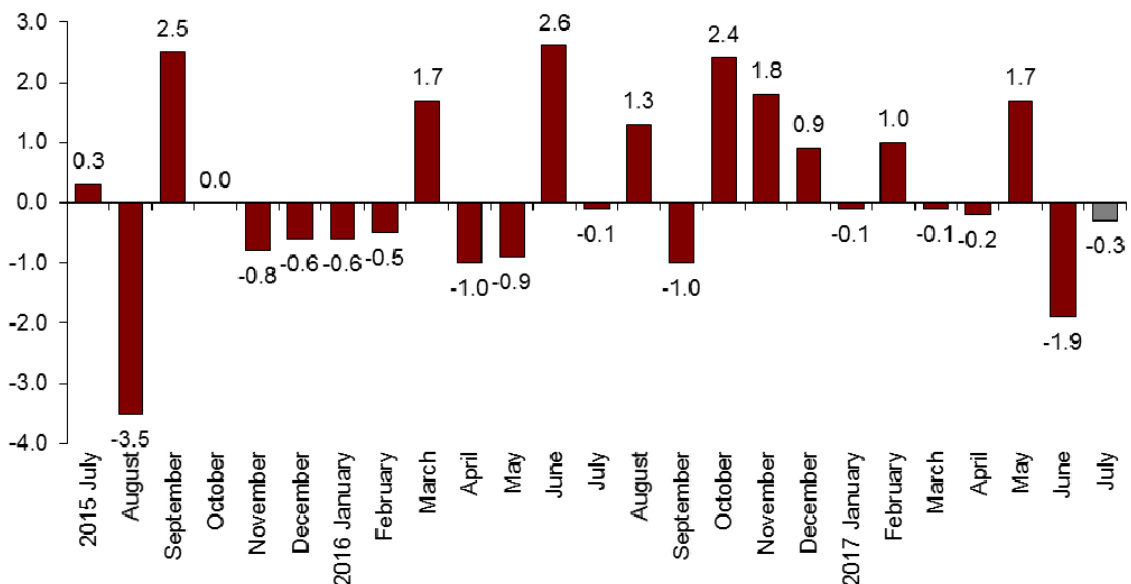
The monthly variation of the General Industrial Turnover Index¹ stands at -0.3%, after adjusting for seasonal and calendar effects

The annual rate stands at 5.5% in the series adjusted for seasonal and calendar effects and in the original series

Monthly evolution of the Industry Turnover

The monthly variation of the General Industry Turnover Index between the months of July and June, eliminating seasonal and calendar effects, is -0.3%. This rate is 1.6 points higher than that registered in the previous month.

 Adjusted for seasonal and calendar effects. Monthly rate

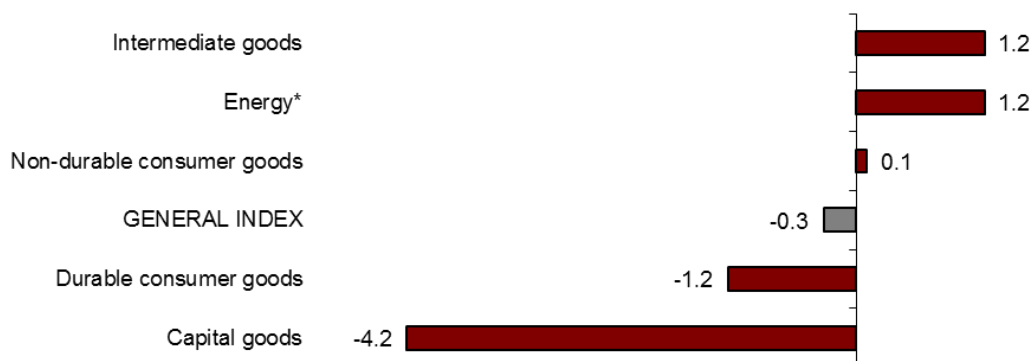


¹ As reflected in the methodology of this rate of value, the information is presented in current terms (nominal terms), this is, without adjusting the effects in the price variation of it.

By economic destination of goods, *Intermediate goods and Energy* (both with 1.2%) and *Non-durable consumer goods* (0.1%) registered positive monthly rates.

In turn, *Capital goods* (-4.2%) and *Durable consumer goods* (-1.2%) registered negative rates.

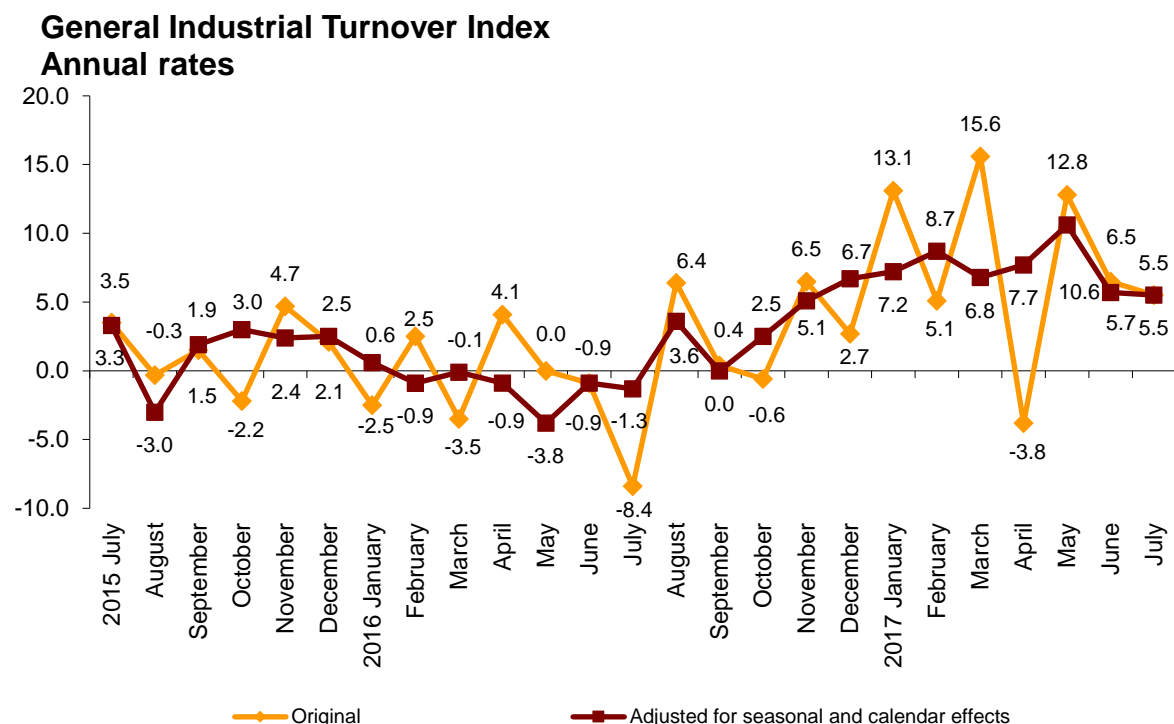

Annual evolution of the Industrial Turnover Indices

The General Industrial Turnover Index (ITI) corrected for seasonal and calendar effects shows a variation of 5.5% in July compared to the same month of the previous year. This rate was two tenths lower than that registered in June.

The original series of the ITI registered an annual variation of 5.5%. This rate was one point lower than that registered in June.



By economic destination of the goods, the indices adjusted for seasonal and calendar effects recorded positive annual rates in all the sectors analysed. *Energy* (13.2%) registered the greatest increase.

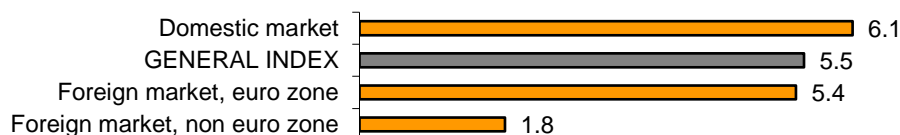

By geographical destination of sales, in July all the markets showed positive annual rates. Worth noting was the 6.1% increase in the domestic market.

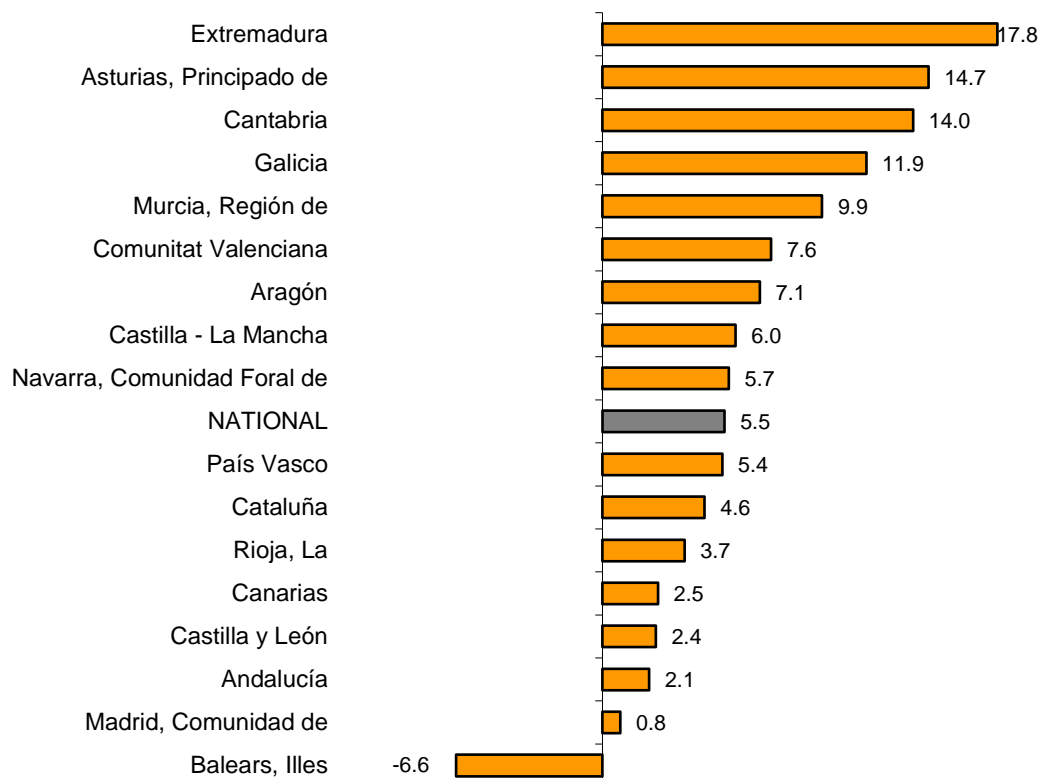
Industrial Turnover Indices (ITI). General and by market Annual rate



Results by Autonomous Communities. Annual variation rates of the Industrial turnover. Original series

Turnover increased in 16 Autonomous Communities, as compared to July 2016. The greatest increase was registered in Extremadura (17.8%). In turn, the only decrease was in the Illes Balears (-6.6%).
