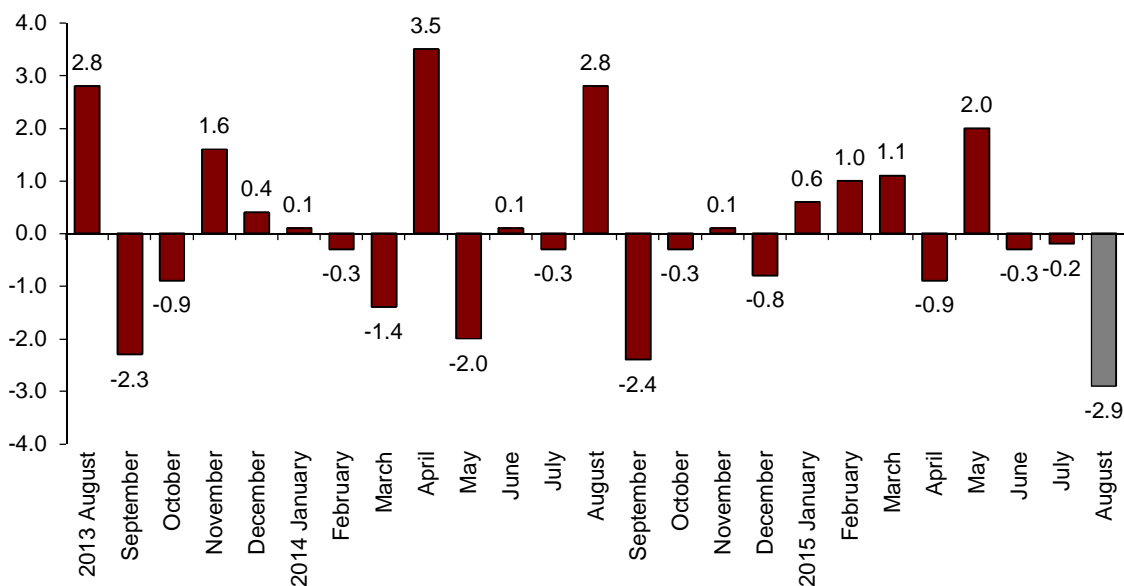
The monthly variation of the General Industry Turnover Index¹ stands at -2.9% , after adjusting for seasonal and calendar effects

The annual rate stands at -2.9% in the seasonally and calendar adjusted series and at -0.3% in the original series

Monthly evolution of the Industry Turnover

The monthly variation of the General Industry Turnover Index (ITI) between the months of August and July 2015 was -2.9% , after adjusting for the seasonal and calendar effects. This rate was 2.7 points lower than that of the previous month.

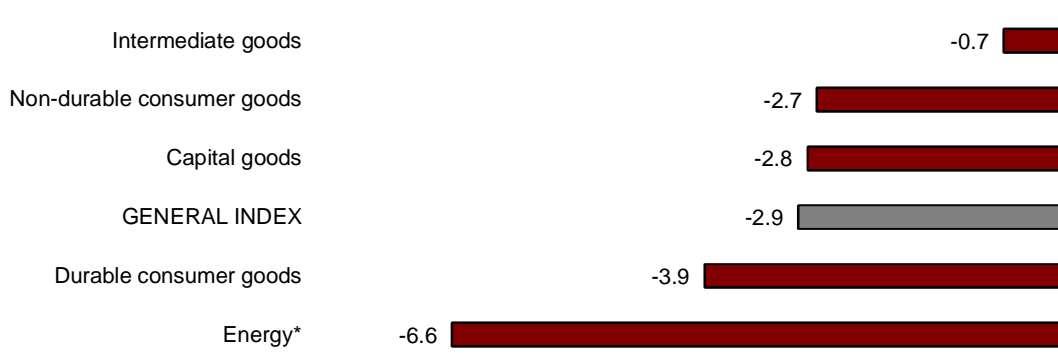
Turnover General Index

¹ As explained in the methodology for this value index, the information is presented in current terms (nominal terms), that is, without adjusting the effects in the price variation thereof.

By economic destination of the goods, all sectors presented negative monthly rates, worth noting Energy (–6.6%), followed by Durable consumer goods (–3.9%).

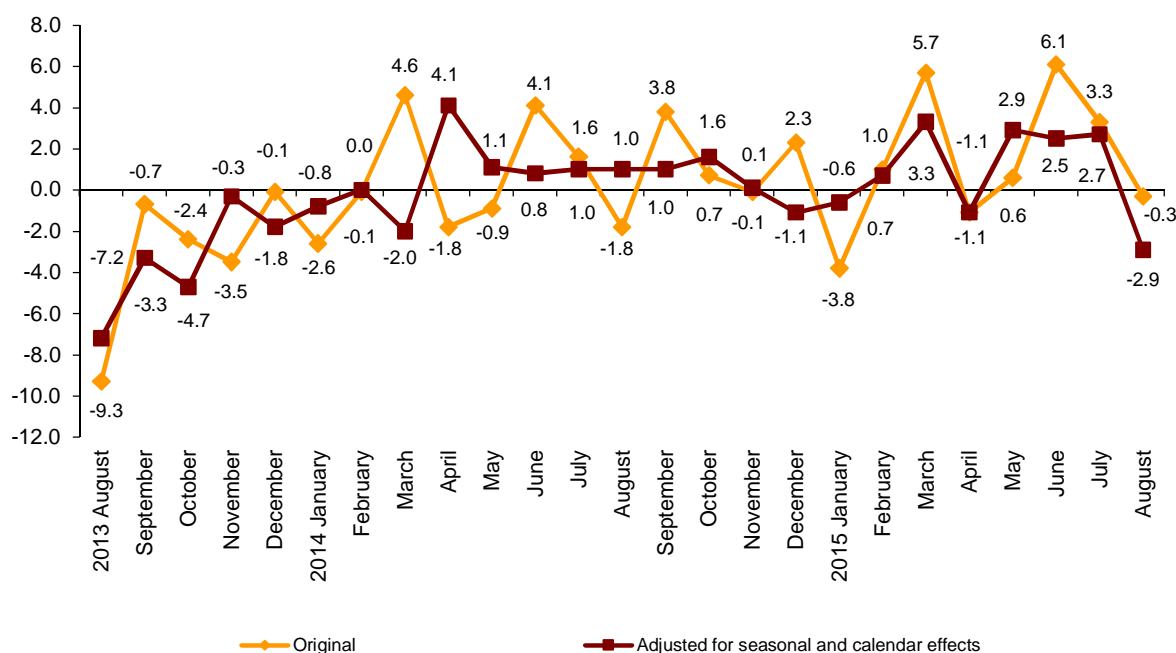

Annual evolution of the Industrial Turnover Indices

The General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of -2.9% in August, as compared to the same month of the previous year. This rate was 5.6 points lower than that registered in July 2015.

The original series of the ITI registered an annual variation of -0.3% , which is 3.6 points lower than that registered in July 2015.

By economic destination of the goods, three out of five sectors analysed registered negative annual rates, after adjusting for seasonal and calendar effects. It is worth noting the decrease in Energy (-25.6%).

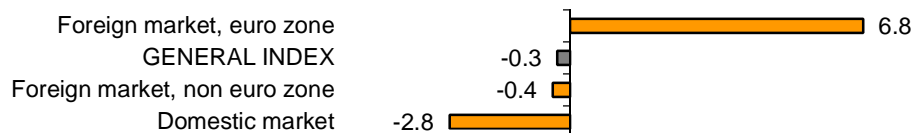

By geographical destination of sales, in August two out of three the markets analysed showed negative annual rates. Worth noting was the increase of the euro zone of the foreign market (6.8%).

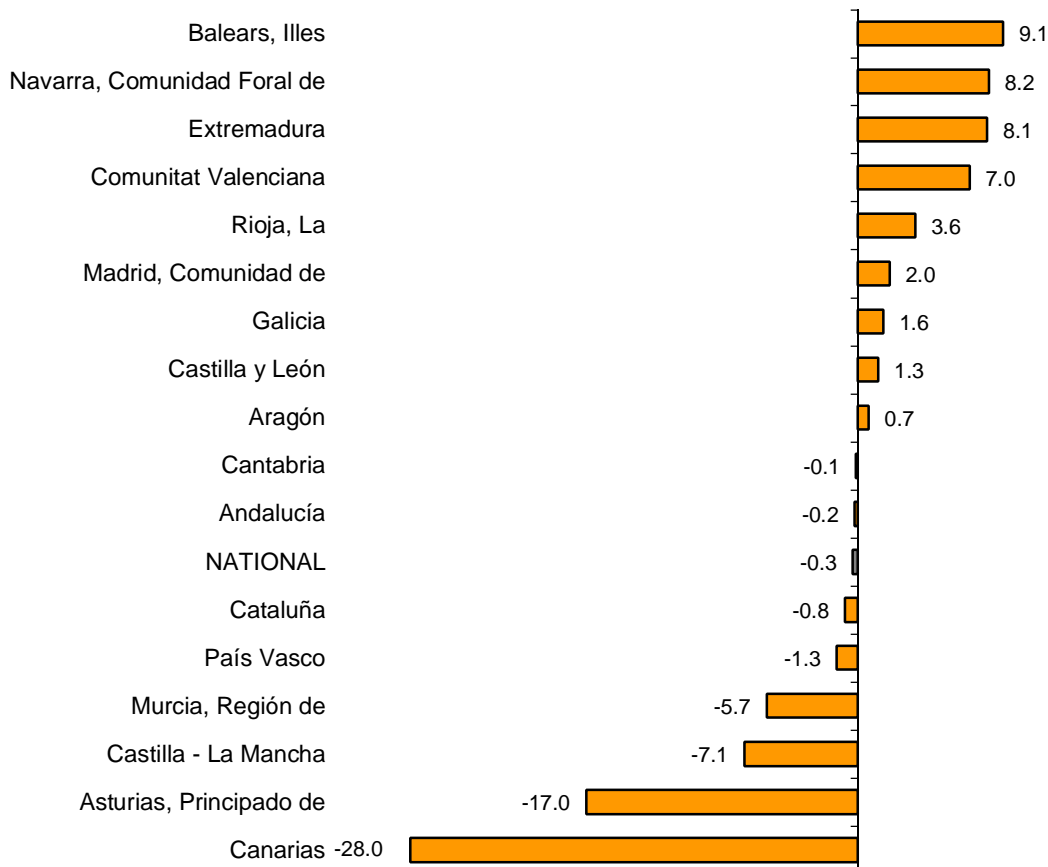
**Industrial turnover indices: General and by market

Results by Autonomous Community. Annual variation rates of the Industrial Turnover. Original series

Turnover increased in 9 Autonomous Communities, as compared with August 2014 and it decreased in 8 Autonomous Communities. The greatest increase was registered in Illes Balears (9.1%) and the greatest decrease was registered in Canarias (-28.0%).
