
Industrial Turnover Indices (ITI). Base 2010 September 2017. *Provisional data*

The monthly variation of the General Industrial Turnover Index¹ stands at 1.3%, after adjusting for seasonal and calendar effects

The annual rate stands at 10.8% in the series adjusted for seasonal and calendar effects, and at 6.8% in the original series

Monthly evolution of the Industry Turnover


The monthly variation of the General Industry Turnover Index between the months of September and August, after adjusting for seasonal and calendar effects, was 1.3%. This rate was 1.1 points lower than that of the previous month.



By economic destination of goods, all sectors had positive monthly rates. Worth noting was the increase in Energy (10.5%).

¹ As reflected in the methodology of this value index, the information is presented in current terms (nominal terms), this is, without adjusting the effects in the price variation thereof.



Annual evolution of the Industrial Turnover Indices

The General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of 10.8% in September, as compared with the same month of the previous year. This rate is almost three points higher than that registered in August.

The original series of the ITI registered an annual variation of 6.8%. This rate was 1.1 points lower than that registered in August.

General Industrial Turnover Index Annual rates



By economic destination of goods, the indices adjusted for seasonal and calendar effects recorded positive annual rates in all the sectors analysed. Worth noting was the increase of Energy (28.3%).



By geographical destination of sales, in September all markets showed positive annual rates. The foreign market non-euro zone registered the greatest increase, 9.8%.


Industrial turnover indices: General and by market Annual rate



Results by Autonomous Communities. Annual variation rates of the Industrial turnover. Original series

Turnover increased in 14 Autonomous Communities and decreased in the remaining three as compared to September 2016. The greatest increase occurred in Principado de Asturias (18.1%) and the greatest decrease was in Comunidad Foral de Navarra (-3.8%).
