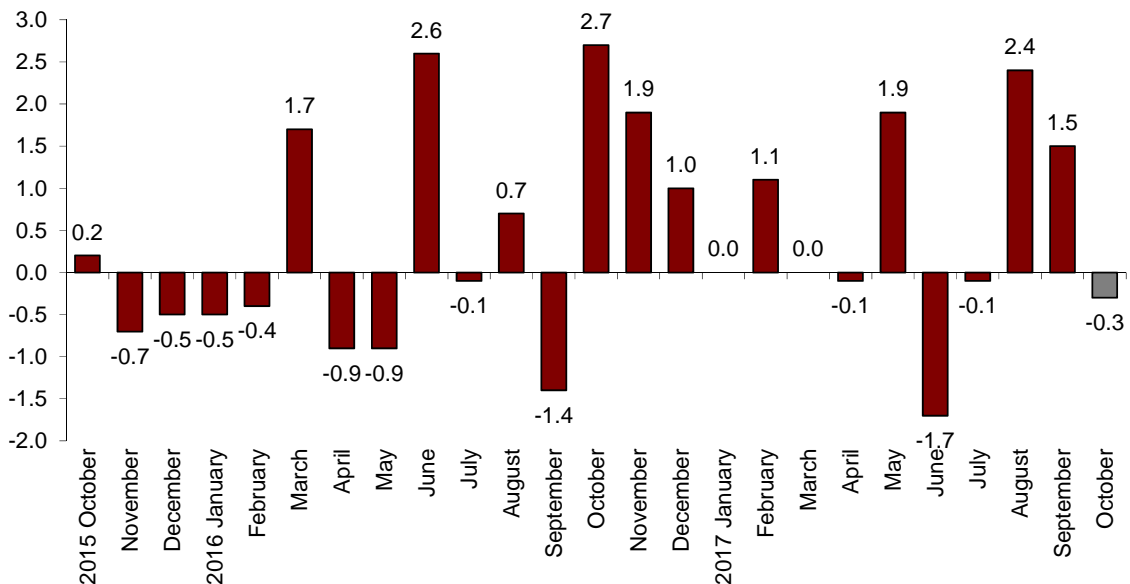
The monthly variation of the General Industrial Turnover Index¹ stands at -0.3%, after adjusting for seasonal and calendar effects

The annual rate stands at 7.8% in the series adjusted for seasonal and calendar effects, and at 11.1% in the original series

Monthly evolution of the Industry Turnover

The monthly variation of the General Industry Turnover Index between the months of October and September, after adjusting for seasonal and calendar effects, was -0.3%. This rate is 1.8 points lower than that of the previous month.

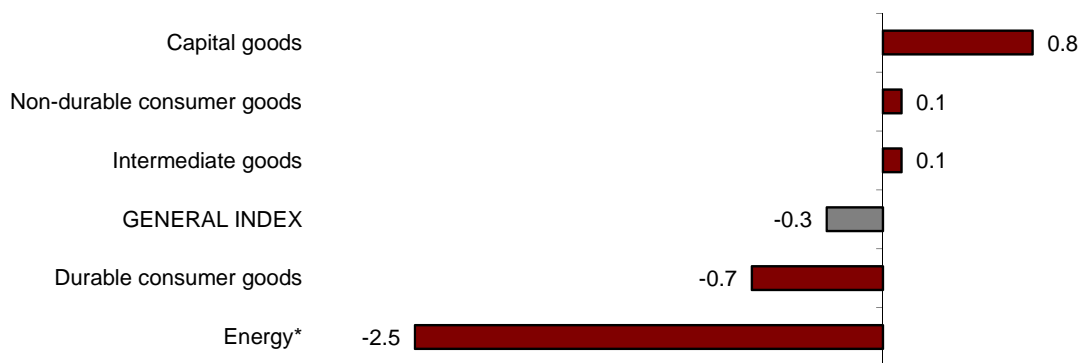
Turnover General Index

¹ As reflected in the methodology of this value index, the information is presented in current terms (nominal terms), this is, without adjusting the effects in the price variation thereof.

By economic destination of the goods, *Capital goods* (0.8%), *Non-durable consumer goods* and *Intermediate goods* (0.1% in both cases) registered positive monthly rates. In turn, *Energy* (-2.5%) and *Durable consumer goods* (-0.7%) registered negative rates.

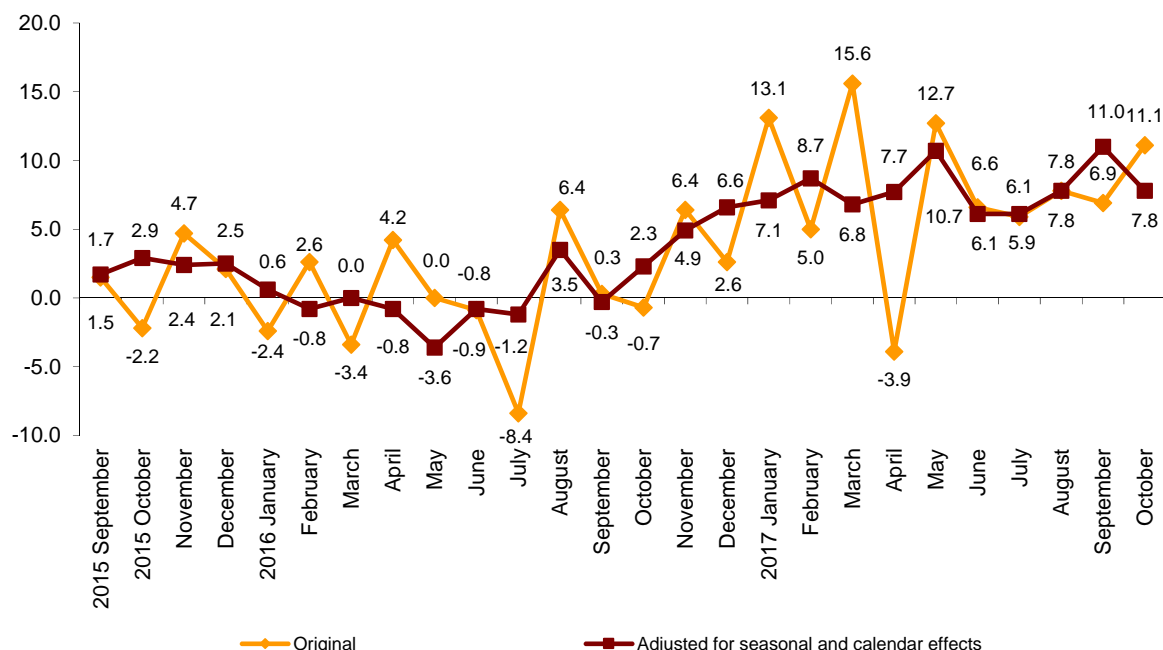

Annual evolution of the Industrial Turnover Indices

The General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of 7.8% in October, as compared with the same month of the previous year. This rate is 3.2 points lower than that registered in September.

The original series of the ITI registered an annual variation of 11.1%. This rate is 4.2 points higher than that registered in September.

General Industrial Turnover Index Annual rates



By economic destination of goods, the indices adjusted for seasonal and calendar effects recorded positive annual rates in all the sectors analysed. Worth noting were the increases in *Intermediate goods* (11.9%) and *Energy* (11.1%).

By geographical destination of sales, in October, all the markets showed positive annual rates. Worth noting was the 13.9% increase in the non-euro zone of the foreign market.

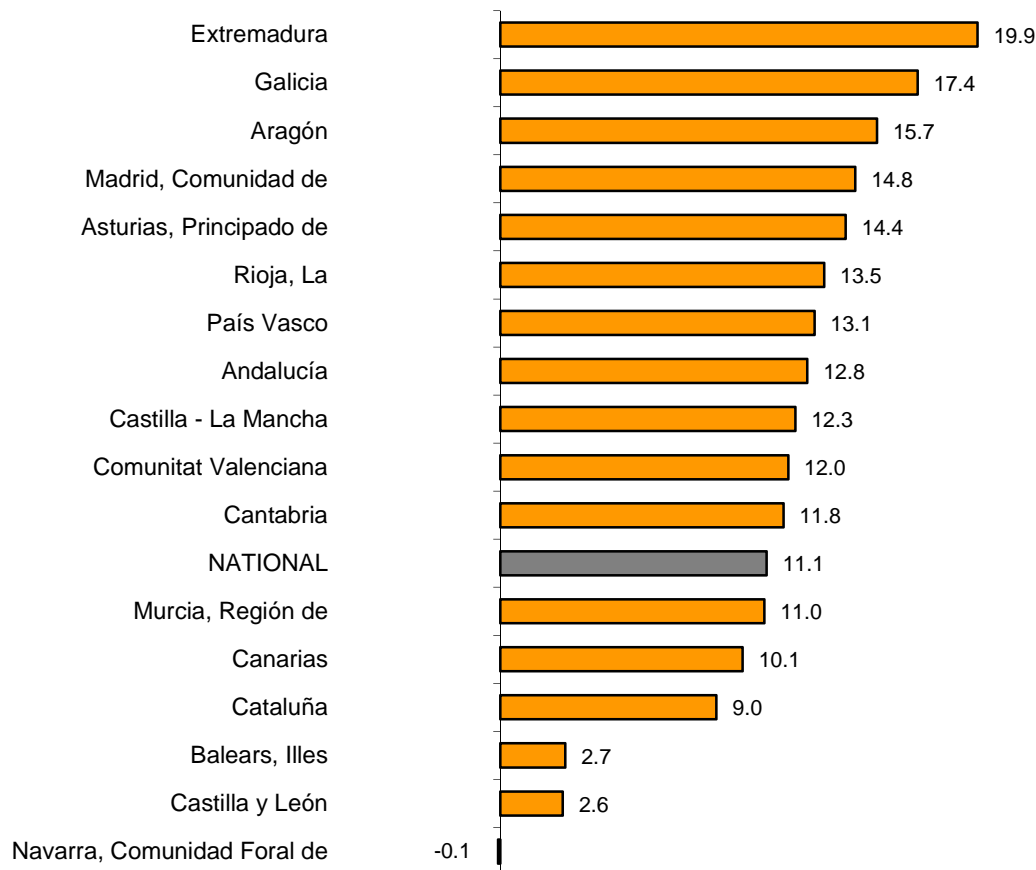
Industrial turnover indices: General and by market Annual rate



Results by Autonomous Community. Annual variation rates of the Industrial turnover. Original series

Turnover increased as compared to October 2016 in 16 Autonomous Communities and only decreased in Comunidad Foral de Navarra (-0.1%). The greatest increase was registered in Extremadura (19.9%).
