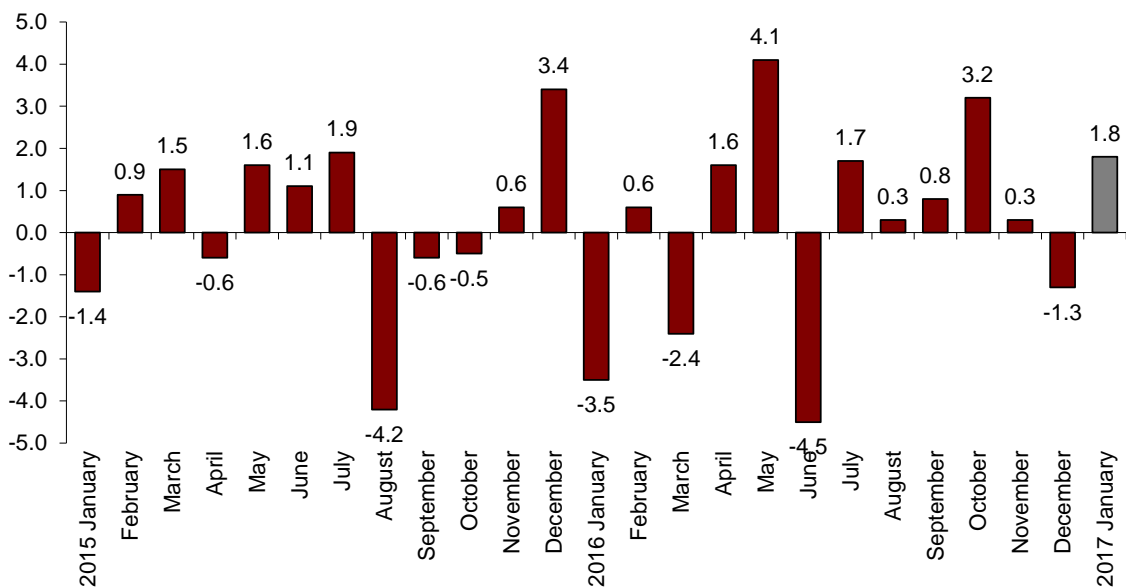
La variación mensual del Índice General de Entradas de Pedidos en la Industria¹ es del 1,8% si se eliminan los efectos estacionales y de calendario

La tasa anual se sitúa en el 6,0% en la serie corregida de efectos estacionales y de calendario, y en el 11,5% en la serie original

Evolución mensual de las entradas de pedidos en la Industria

La variación mensual del Índice de Entradas de Pedidos de la Industria entre los meses de enero y diciembre, eliminando los efectos estacionales y de calendario, es del 1,8%. Esta tasa es 3,1 puntos superior a la del mes anterior.

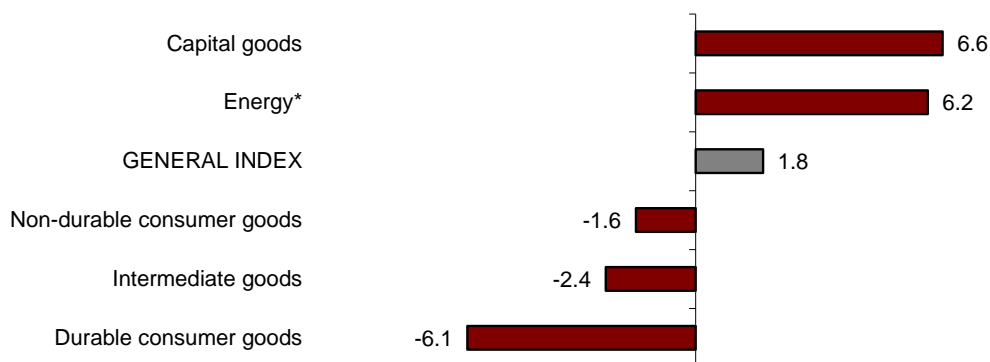
New Orders Received General Index

Por destino económico de los bienes, *Bienes de equipo* (6,6%) y *Energía* (6,2%) presentan tasas mensuales positivas. Por su parte, *Bienes de consumo duradero* (-6,1%), *Bienes intermedios* (-2,4%) y *Bienes de consumo no duradero* (-1,6%) registran tasas mensuales negativas.

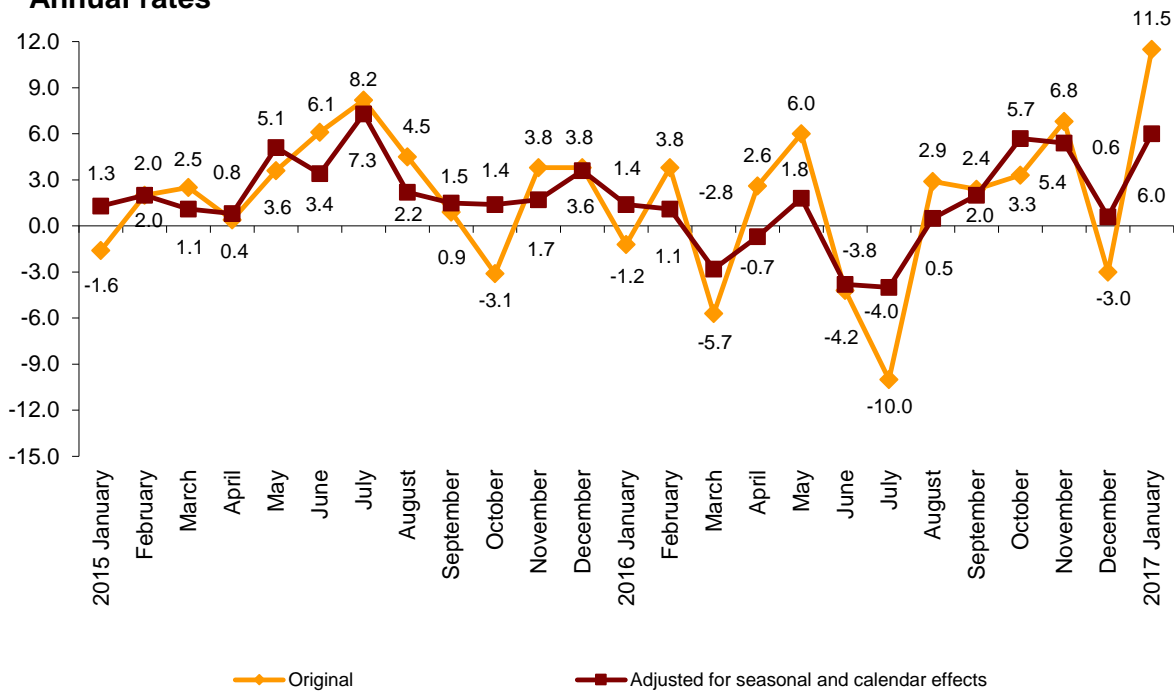

Evolución anual de las entradas de pedidos

El Índice de Entradas de Pedidos en la Industria corregido de efectos estacionales y de calendario presenta en enero una variación del 6,0% respecto al mismo mes del año anterior. Esta tasa es 5,4 puntos superior a la de diciembre.

La serie original del IEP experimenta una variación anual del 11,5%. Esta tasa es 14,5 puntos superior a la de diciembre.

Por destino económico de los bienes, los índices corregidos de efectos estacionales y de calendario presentan tasas anuales positivas en cuatro de los cinco sectores analizados. Entre ellos, destaca el aumento de *Energía* (60,7%).

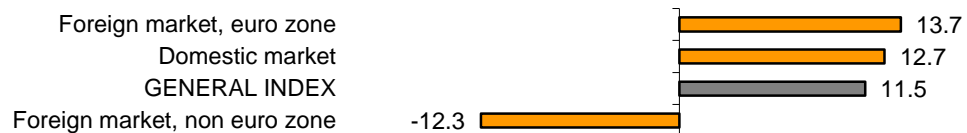

Por destino geográfico de las ventas, en enero se observan tasas anuales positivas en dos de los tres mercados analizados. Destaca el aumento del 13,7% en la zona euro del mercado exterior.

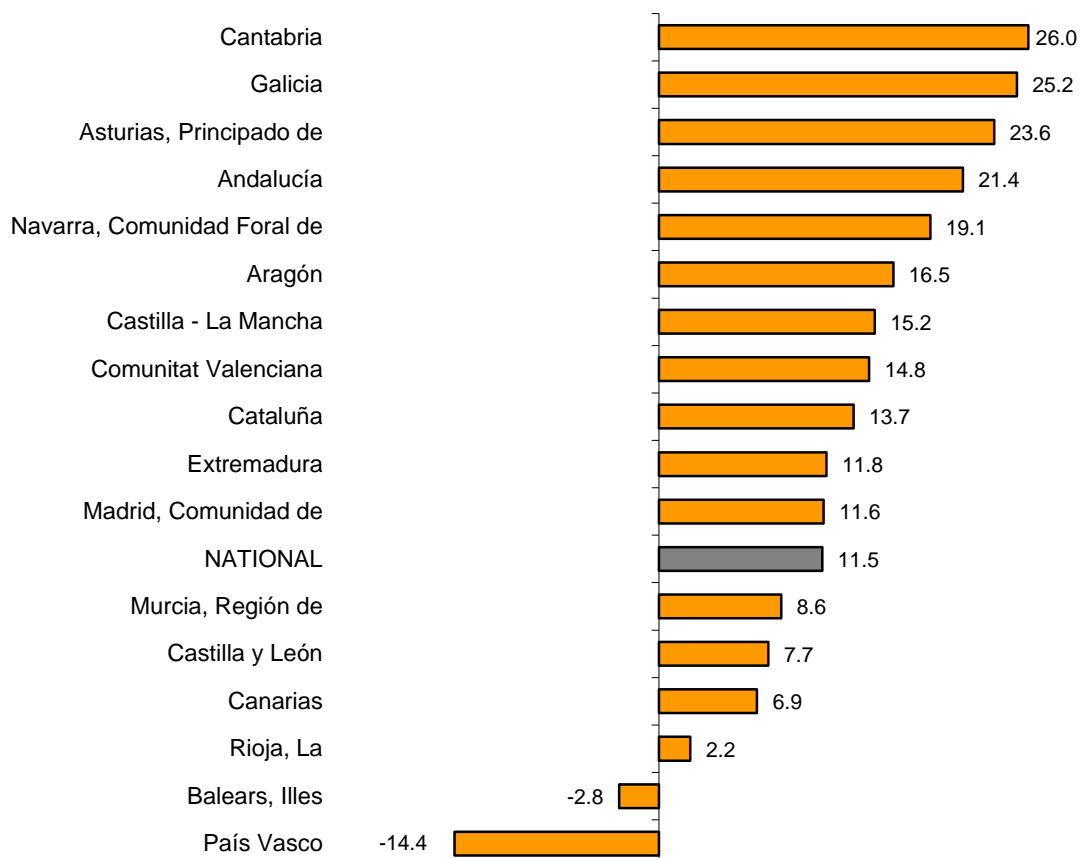
Industrial new orders received indices: General and by market Annual rate

Las entradas de pedidos aumentan respecto a enero de 2016 en 15 comunidades autónomas y disminuyen en las otras dos. El mayor aumento se produce en Cantabria (26,0%) y el mayor descenso en País Vasco (-14,4%).
