
Industry New Order Entries Rates (in Spanish IEP). Base 2010 February 2017. Provisional data

The monthly variation of the General Industry New Order Entries Rates¹ is 1.1% if the seasonal and calendar effects are eliminated

The annual rate stands at 7.6% in the series corrected for the seasonal and calendar effects, and at 5.1% in the original series

Monthly evolution of Industry New Order Entry

The monthly variation of the Industry New Order Entries Rate between February and January, eliminating the seasonal and calendar effects, is 1.1%. This rate is eight tenths of a point lower than the previous month.




New Orders Received General Index Adjusted for seasonal and calendar effects. Monthly rate

¹ As reflected in the methodology of this rate of value, the information is presented in current terms (nominal terms), this is, without adjusting the effects in the price variation of it.

By economic destination of the goods, four of the five sectors have positive monthly rates. *Durable consumer goods* (3.5%) and *Intermediate goods* (2.5%) recorded the largest increases. The only sector that descends is *Energy* (-6.5%).



Annual evolution of the order entries

The Industry New Order Entries Rate corrected for seasonal and calendar effects, registered a variation of 7.6% in January, as compared with the same month of the previous year. This rate is 1.3 points higher than that registered in January.

The original series of the IEP registered an annual variation of 5.1%. This rate is 6.6 points lower than the registered in January.



Industry New Orders Received General Index Annual rates

By economic destination of the goods, four out of five sectors analysed recorded positive annual rates, after adjusting for seasonal and calendar effects. *Energy* (55.8%) recorded the highest increase.

Annual evolution of order entries by market. Original series

By geographical destination of sales, in February positive annual rates are observed in two of the three markets analysed. The increase of 9.7% in the internal market is outstanding.


Industrial new orders received indices: General and by market Annual rate

The order intake increases with respect to February 2016 in 10 autonomous communities and decreases in the other seven. The highest increase occurred in the Principado de Asturias (26.4%) and the largest decline in Illes Balears (-13.5%).
