## Industrial New Orders Received Indices (INORI). Base 2010 April 2015. Provisional data

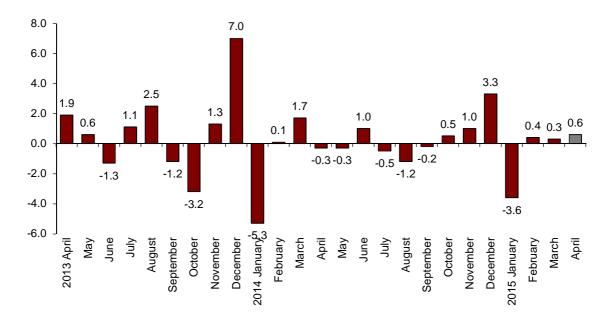
The monthly variation of the General Industrial New Orders
Received Index stands at 0.6% after adjusting for the seasonal and
calendar effects

The annual rate stands at 1.1% in the series adjusted for the seasonal and calendar effects and at 1.2% in the original series

#### **Monthly evolution of New Orders Received**

The monthly variation of the Industrial New Orders Received Index (INORI) between April and March stood at 0.6%, after adjusting for the seasonal and calendar effects. This rate was three tenth higher than that registered the previous month.

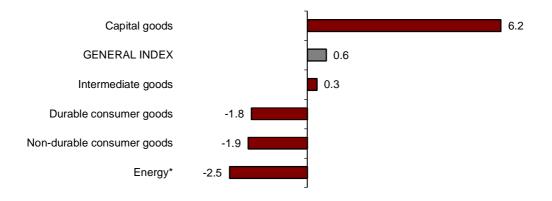
New Orders Received General Index Adjusted for seasonal and calendar effects. Monthly rate



By economic destination of the goods, Capital goods (6.2%) and Intermediate goods (0.3%) registered positive monthly rates.

In turn, Energy (-2.5%), Non-durable consumer goods (-1.9%) and Durable consumer goods registered negative monthly rates.

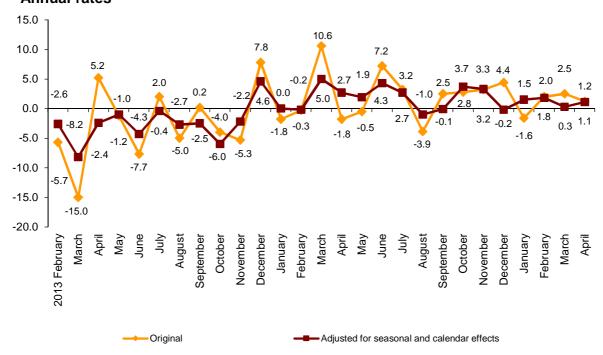

#### Annual evolution of the New Orders Received

The Industrial New Orders Received Index (INORI), after adjusting for seasonal and calendar effects, registered a variation of 1.1% in April, as compared with the same month of the previous year. This rate was eight points higher than that registered in March 2015.

The original series of the INORI registered an annual variation of 1.2%, that is, 1.3 points lower than that registered in March 2015.

### **Industry New Orders Received General Index Annual rates**



By economic destination of the goods, three out of five sectors recorded positive rates, after adjusting for seasonal and calendar effects. Capital goods (13.2%) registered the greatest increase, whereas Energy registered the greatest decrease (**-23.8%**).

## Annual evolution of New Orders Received by destination market. Original series

By geographical destination, in April, two out of three markets registered positive annual rates. Worth noting was the increase of 7.6% in the euro zone of the foreign market.

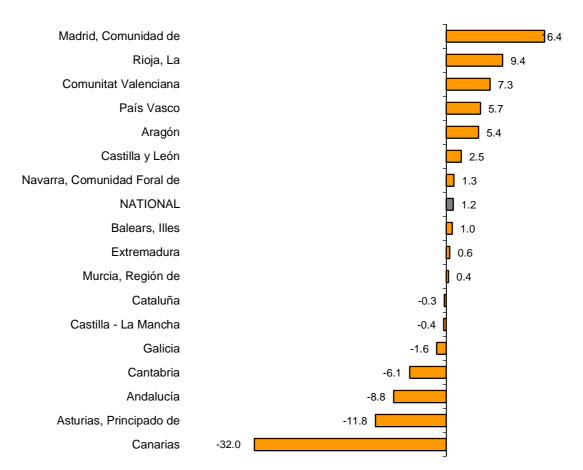
#### Industrial new orders received indices: General and by market Annual rate



## Results by Autonomous Community. Annual variation rate of the Industrial New Orders Received. Original series

New orders received increased in the annual rate in 10 Autonomous Communities and decreased in the remaining seven. The greatest increase was recorded in Comunidad de Madrid (16.4%) and the greatest decrease was registered in Canarias (-32.0%).
