Industrial New Orders Received Indices (INORI). Base 2010 September 2013. Provisional data


The annual rate of the General Industrial New Orders Received Index stands at -3.2% in the series adjusted for the seasonal and calendar effects and at -0.3% in the original series

The monthly variation stands at -1.5%, adjusted for the seasonal and calendar effects

The Industrial New Orders Received Index (INORI) registered an annual variation of -0.3% in September, more than five points above that registered in August.

After adjusting the seasonal and calendar effects, the annual rate stood at -3.2%, almost four points and a half below that registered in August.

Annual evolution of the New Orders Received by economic destination of the goods

Capital goods is the only sector that registered a positive annual rate (8.0%) in September. Among the other sectors it is worth noting the decrease in the new orders received in Energy (–11.1%).

After adjusting the seasonal and calendar effects, Capital goods (5.4%) was again the only sector with a positive evolution, as compared with September of the previous year. Among the other sectors, the greatest decrease was registered in Energy (–11.9%).


Annual evolution of New Orders Received by destination market

Indices obtained according to the market of which the order was received decreased in Domestic market and increased in Foreign markets, as compared with the same month of the previous year.

The greatest increase was registered in New Orders Received from the euro zone, with an annual rate of 8.9%.

In turn, Domestic market registered a decrease of 6.6% in the New Orders Received, as compared with September 2012.

Industrial new orders received indices: General and by market Annual rate




Results by Autonomous Community. Annual variation rate of the New Orders Received.

Nine Autonomous Communities registered decreases in their New Orders Received, as compared with September 2012. Principado de Asturias (-27.4%), Andalucía (-17.8%) and Canarias (-14.7%) showed the greatest drops

The greatest rises were registered in Comunidad de Madrid (27.3%), Illes Balears (17.6%) and País Vasco (9.9%).


General indices: national and by Autonomous Community Annual rate of Industry New Orders Received

The General Industrial New Orders Received Index variation between September and August, after adjusting the seasonal and calendar effects, was -1.5%. This rate was almost four and a half points higher than that of August.


New Orders Received General Index Seasonally and calendar adjusted. Monthly rate

After adjusting the seasonal and calendar effects, three out of the five industrial sectors registered negative monthly rates. Among them, it is worth noting the decrease registered in Capital goods (-6.9%).
