
Industrial New Orders Received Indices (INORI). Base 2010 October 2017. Provisional data


The monthly variation of the General Industrial New Orders Received Index¹ is -4.1% after adjusting for seasonal and calendar effects

The annual rate stands at 4.3% in the series adjusted for seasonal and calendar effects, and at 7.0% in the original series

Monthly evolution of New Orders Received

The monthly variation of the Industrial New Orders Received Index between October and September stood at -4.1%, after adjusting for the seasonal and calendar effects. This rate is nine points lower than that of the previous month.






¹ As reflected in the methodology of this value index, the information is presented in current terms (nominal terms), this is, without adjusting the effects in the price variation thereof.

By economic destination of the goods, four of the five sectors showed negative monthly rates. *Capital goods* (-13.4%) and *Durable consumer goods* (-3.4%) recorded the highest decreases. In turn, the only increase was in the *Intermediate goods* (0.2%).



Annual evolution of New Orders Received.

The Industrial New Orders Received Index, after adjusting for seasonal and calendar effects, registered a variation of 4.3% in October, as compared with the same month of the previous year. This rate is 10.3 points lower than that registered in September.

The original series of the INORI registered an annual variation of 7.0%. This rate is 4.6 points lower than that registered in September.

Industry New Orders Received General Index Annual rates



By economic destination of the goods, the indices adjusted for seasonal and calendar effects showed positive annual rates in four of the five sectors analysed. Worth noting were the increases in *Intermediate goods* (11.7%) and *Energy* (11.5%).



Annual evolution of New Orders Received by market. Original series

By geographical destination of sales, in October, all the markets showed positive annual rates. Worth noting was the 11.0% increase in the domestic market.


Industrial new orders received indices: General and by market Annual rate

New orders received increased in 13 Autonomous Communities and decreased in the remaining four as compared to October 2016. The greatest increase was recorded in Aragón (49.3%) and the greatest decrease was registered in Galicia (-12.3%).
