 November 2017. *Provisional data*


**The monthly variation of the General Industrial New Orders Received Index<sup>1</sup> is 3.6% after adjusting for seasonal and calendar effects**

**The annual rate stands at 8.8% in the series adjusted for seasonal and calendar effects, and at 9.2% in the original series**

#### **Monthly evolution of New Orders Received**

The monthly variation of the Industrial New Orders Received Index between November and October stood at 3.6%, after adjusting for the seasonal and calendar effects. This rate is 7.8 points higher than that of the previous month.



By economic destination of goods, all sectors had positive monthly rates. The greatest increases were registered in *Capital goods* (7.8%) and *Durable consumer goods* (4.4%).



## Annual evolution of New Orders Received.

The Industrial New Orders Received Index, after adjusting for seasonal and calendar effects, registered a variation of 8.8% in November, as compared with the same month of the previous year. This rate is 4.7 points higher than that registered in October.

The original series of the INORI registered an annual variation of 9.2%. This rate is 2.5 points higher than that registered in October.

By economic destination of goods, the indices adjusted for seasonal and calendar effects recorded positive annual rates in all the sectors analysed. Worth noting was the increase in Energy (14.8%).



## Annual evolution of New Orders Received by market. Original series

By geographical destination of sales, in November, all the markets showed positive annual rates. The largest increase of 16.7% was registered in the non-euro zone of the foreign market.


### Índices de entradas de pedidos: General y por mercado Tasa anual



## Results by Autonomous Communities. Annual variation rate of the Industrial. New Orders Received. Original series

New orders received increased in 13 Autonomous Communities and decreased in the remaining four as compared with November 2016. The greatest increase was recorded in País Vasco (31.6%) and the greatest decrease was in Comunidad Foral de Navarra (-4.6%).
