La variación mensual del Índice General de Entradas de Pedidos en la Industria es del 1,5% si se eliminan los efectos estacionales y de calendario

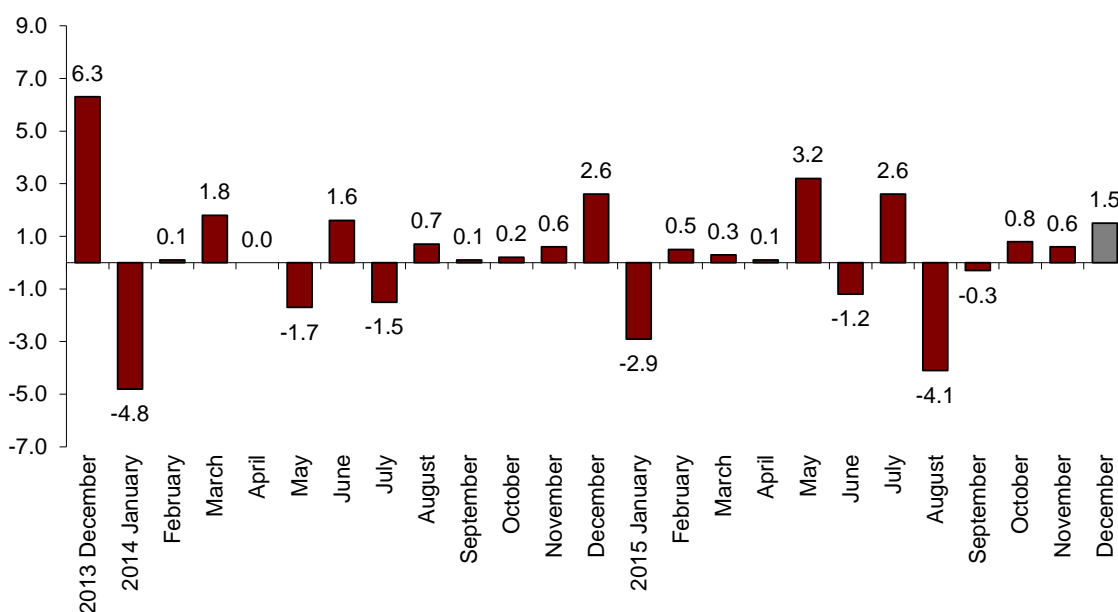
La tasa anual se sitúa en el 1,0% en la serie corregida de efectos estacionales y de calendario, y en el 0,9% en la serie original

En el conjunto del año 2015 las entradas de pedidos aumentaron un 2,4% tanto en la serie corregida como en la original

Evolución mensual de las entradas de pedidos en la Industria

La variación mensual del Índice de Entradas de Pedidos de la Industria entre los meses de diciembre y noviembre, eliminando los efectos estacionales y de calendario, es del 1,5%. Esta tasa es casi un punto superior a la del mes anterior.

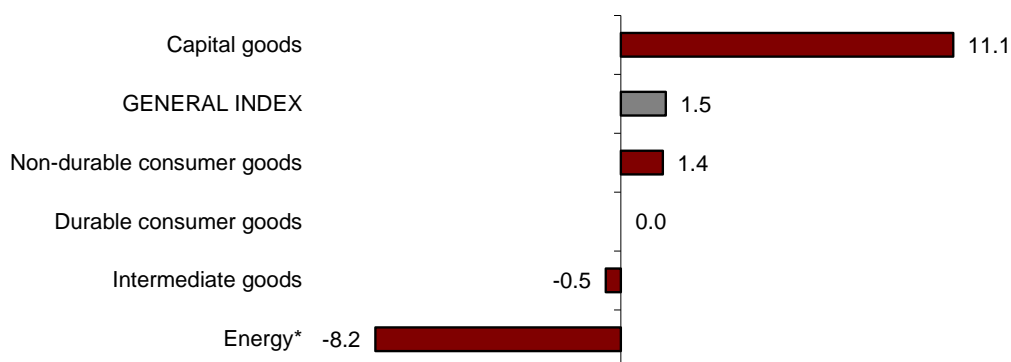
New Orders Received General Index

Por destino económico de los bienes, Bienes de equipo (11,1%) y Bienes de consumo no duradero (1,4%) presentan tasas mensuales positivas.

Por su parte, Energía (-8,2%) y Bienes intermedios (-0,5%) registran tasas mensuales negativas.

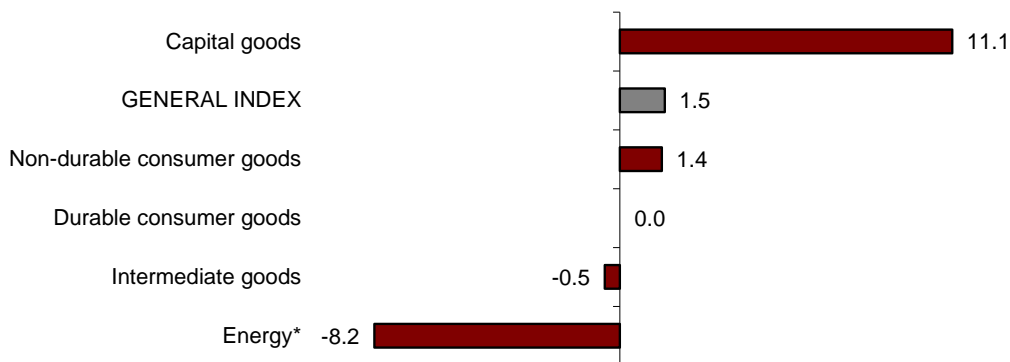

Evolución anual de las entradas de pedidos

El Índice de Entradas de Pedidos en la Industria corregido de efectos estacionales y de calendario presenta en diciembre una variación del 1,0% respecto al mismo mes del año anterior. Esta tasa es 1,2 puntos inferior a la de noviembre de 2015.

La serie original del IEP experimenta una variación anual del 0,9%. Esta tasa es tres puntos inferior a la de noviembre de 2015.

En diciembre los índices corregidos de efectos estacionales y de calendario presentan tasas anuales positivas en todos los sectores, excepto en Energía (-17,4%).

Bienes de equipo (3,9%) y Bienes de consumo duradero (3,6%) registran los mayores incrementos.

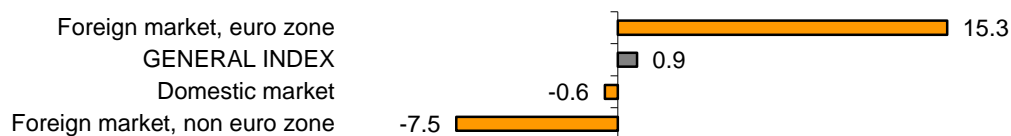
En el conjunto del año 2015 el Índice de Entradas de Pedidos en la Industria presentó una variación del 2,4% respecto al año 2014, tanto en la serie original como en la corregida. Todos los sectores, excepto Energía, presentaron tasas positivas.

Evolución anual de las entradas de pedidos por mercado. Serie original

Por destino geográfico de las ventas, en diciembre se observan tasas anuales negativas en el mercado interior (-0,6%) y en la zona no euro del mercado exterior (-7,5%).

Por el contrario, la zona euro del mercado exterior aumenta un 15,3%.

Industrial new orders received indices: General and by market Annual rate



En el conjunto del año 2015, las entradas de pedidos del mercado exterior aumentaron un 8,4% en la zona euro y un 3,9% en la zona no euro.

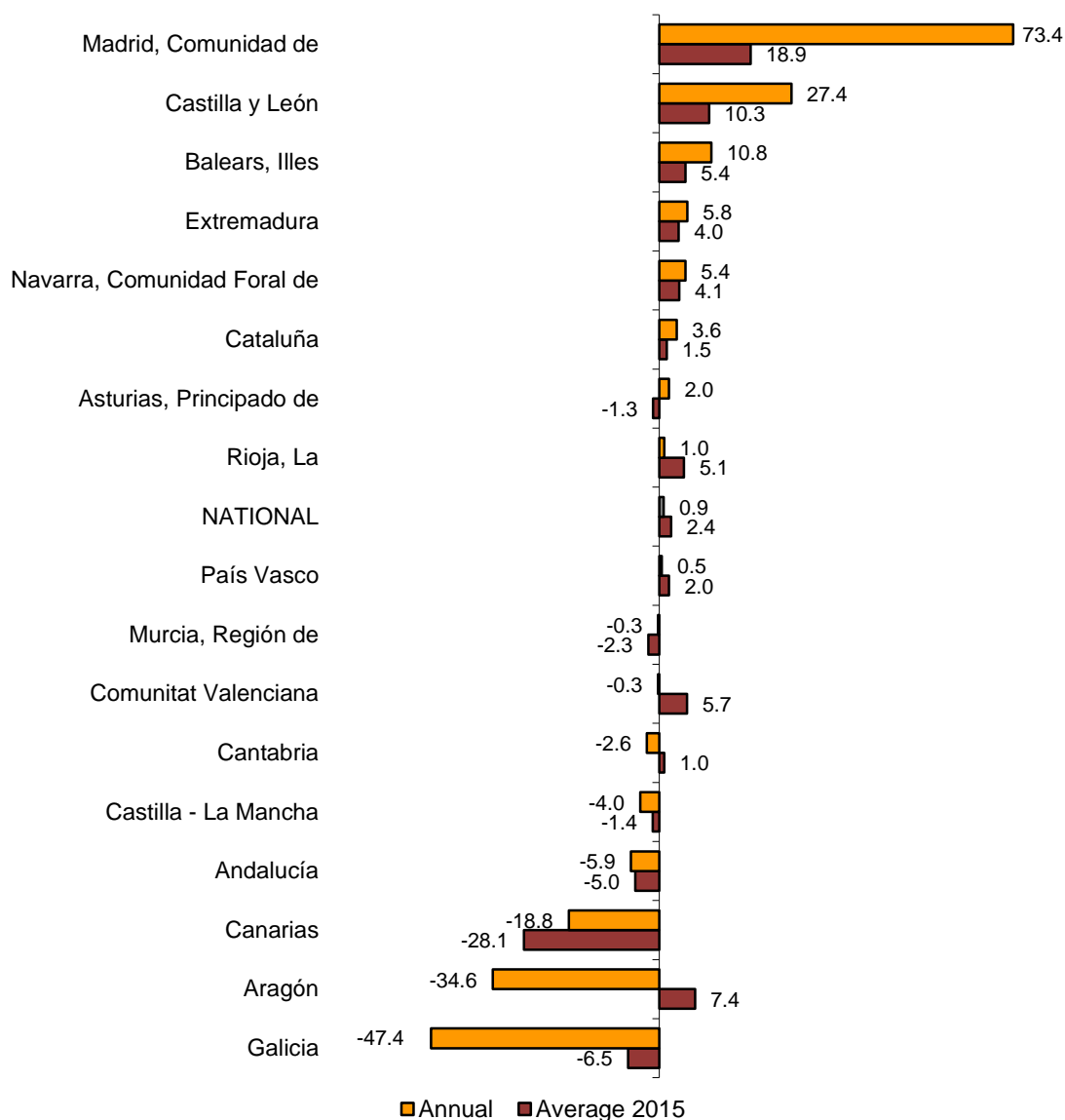
Por el contrario, los pedidos registraron un descenso del 0,6% el mercado interior.

Resultados por comunidades autónomas. Tasas de variación anual de las entradas de pedidos. Serie original

Las entradas de pedidos aumentan respecto a diciembre de 2014 en nueve comunidades autónomas y disminuyen en las otras ocho. El mayor incremento se produce en Comunidad de Madrid (73,4%) y el mayor descenso en Galicia (-47,4%).

En el conjunto del año 2015, las entradas de pedidos se incrementaron en 11 comunidades. Comunidad de Madrid (18,9%), Castilla y León (10,3%) y Aragón (7,4%) presentaron los mayores aumentos.
