Industrial New Orders Received Indices (INORI). Base 2005
June 2012. *Provisional data*

Main results

- The annual rate of the **Industrial Turnover Index** stands at **-6.7%** in June, almost four points below than that registered in May.
- By economic destination of the goods, all industrial sectors present negative interannual rates, except Energy.
- The average rate of the Industrial Turnover Index stands at -3.1% in the first half of the year.
- The annual variation rate of **New Orders Received** in the month of June is **-1.7%**, more than two points higher than that registered in May.
- The average rate of the General Industrial New Orders Received Index stands at **-2.3%** in the first half of 2012.

Evolution of Industrial Turnover

The Industrial Turnover Index (ITI) experienced an interannual variation of -6.7% in June, almost four points below than that registered in May.

By economic destination of the goods, the industrial sectors that presented negative effect on the general index were:

- **Capital goods**, with an annual variation of -15.5% and an effect of -3.678, caused by the decrease in all activities comprising this sector. Among them, highlighting, by its effect the *Manufacture of motor vehicles, trailers and semi-trailers, the Naval, railway, aircraft and spacecraft construction. Combat vehicles and the Manufacture of metal products for construction, containers made of metal, steam generators, weapons and ammunition.*
- **Intermediate goods**, with an annual rate of -7.7% and an effect of -2.880, due to the decreases registered in almost all activities comprising this sector. Among them, worth highlighting were *Metallurgy; manufacture of iron, steel and ferro-alloy products and Rubber and plastic material transformation industry. Other mining and quarrying* is the only activity within the sector with an increase in its turnover.

In turn, **Energy** was the only industrial sectors that presented a positive effect on the general index, with an annual variation of 6.8% and an effect of 0.654, mainly due to the increase registered in the *Manufacture of coke and refined petroleum products*.

A more detailed analysis showed the activities that most affected the annual rate of the ITI in the month of June.

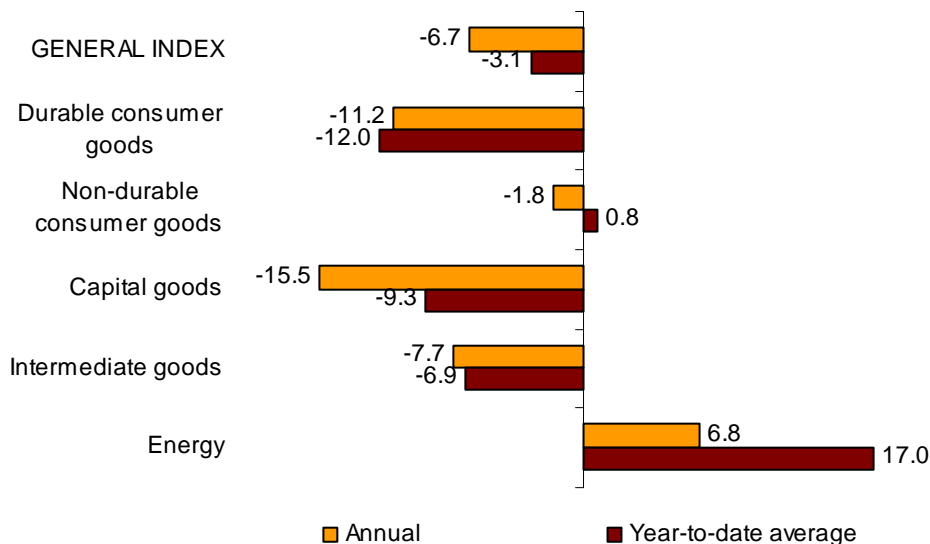

Year-to-date average rates

The average rate of the Industrial Turnover Index registered a variation of **-3.1%** in the first half of the year, as compared with the same period of 2011.

By economic destination of the goods, this turnover rate was negative in Durable consumer goods (-12.0%), Capital goods (-9.3%) and Intermediate goods (-6.9%). Conversely, it was positive in Non-durable consumer goods (0.8%) and Energy (17.0%).

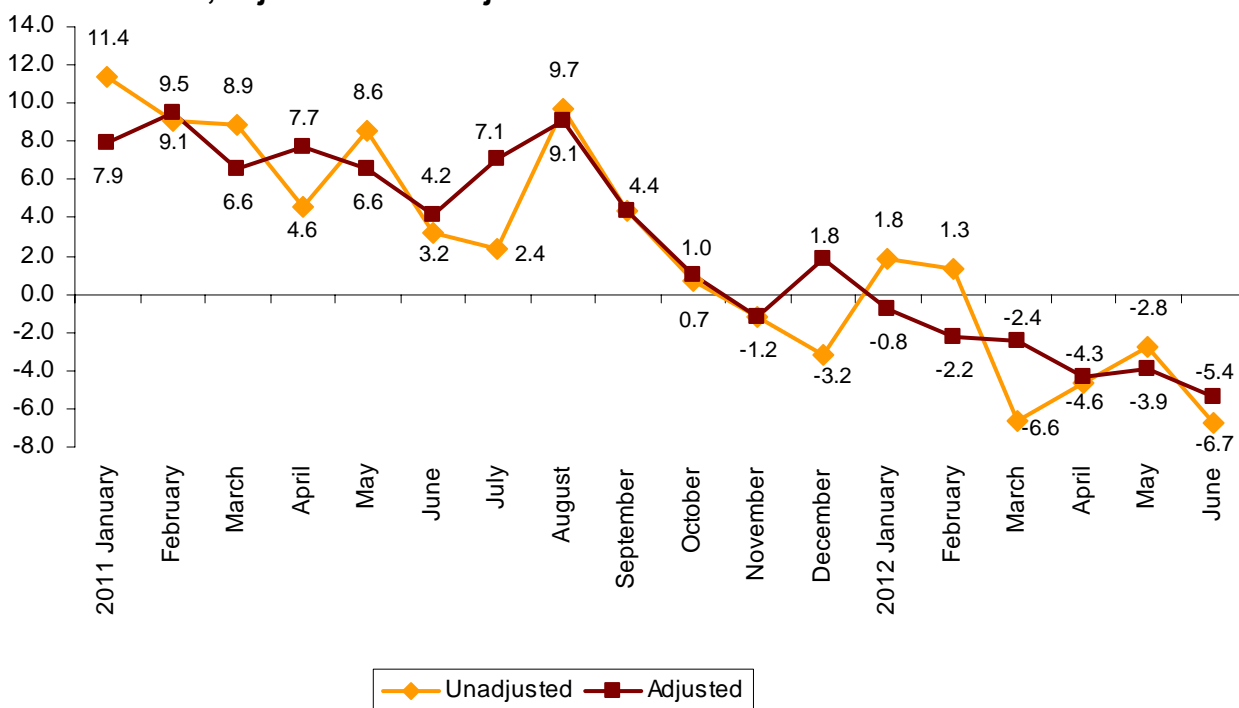
**Annual and year-to-date average rates of ITI

Evolution of the ITI, adjusted for the calendar effect

After adjusting for the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the ITI in the month of June was **-5.4%**, one-and-a-half points lower than that registered in May.

Evolution of Industrial New Orders Received

The Industrial New Orders Received Index (INORI) experienced an interannual variation of -1.7% in June, more than two points above than that registered in May.

By economic destination of the goods, the industrial sectors that presented the greatest negative effects on the general index were:

- **Intermediate goods**, with an annual variation of -4.7% and an effect of -1.815, motivated by the decreases registered in most of the activities comprising this sector. Among them, worth noting, by its influence, the decreases observed in *Metallurgy, manufacture of iron, steel and ferro-alloy products* and the *Rubber and plastic material transformation industry*.
- **Durable consumer goods**, with an annual variation of -13.0% and an effect of -0.318, due to the decreases registered in new orders received in almost all activities comprising this sector. Among them, worth noting the decrease in new orders received of *Manufacture of furniture*.

In turn, **Energy** was the industrial sector that presented the greatest positive effect on the general index, with an annual variation of 6.8% and an effect of 0.672, mainly due to the increase registered in the *Manufacture of coke and refined petroleum products*.

A more detailed analysis showed the activities that most affected the annual rate of the INORI in the month of June.

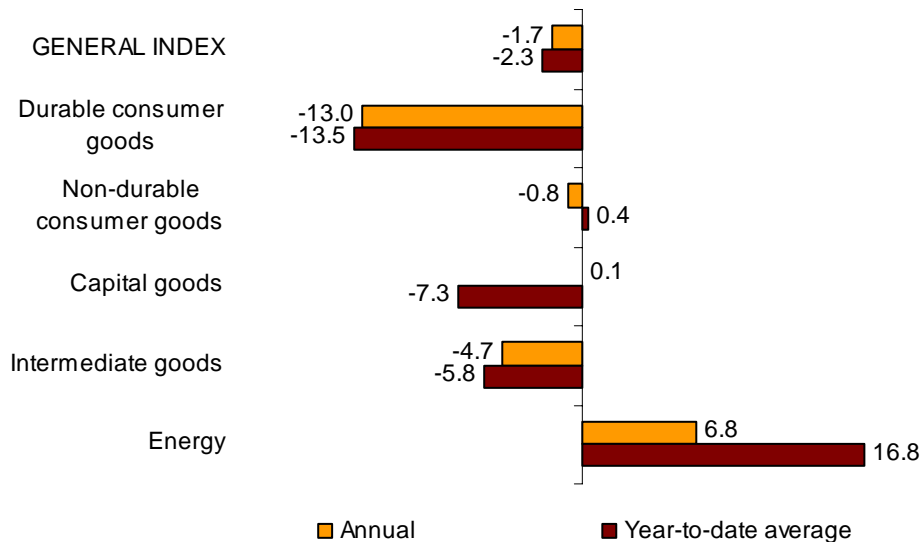

Year-to-date average rates

The average of the General Industrial New Orders Received Index in the first half of the year registered a variation rate of **-2.3%**, as compared with the same period of 2011. By economic destination of the goods, this variation rate was negative, in all of the industrial sectors, except Energy and Durable consumer goods.

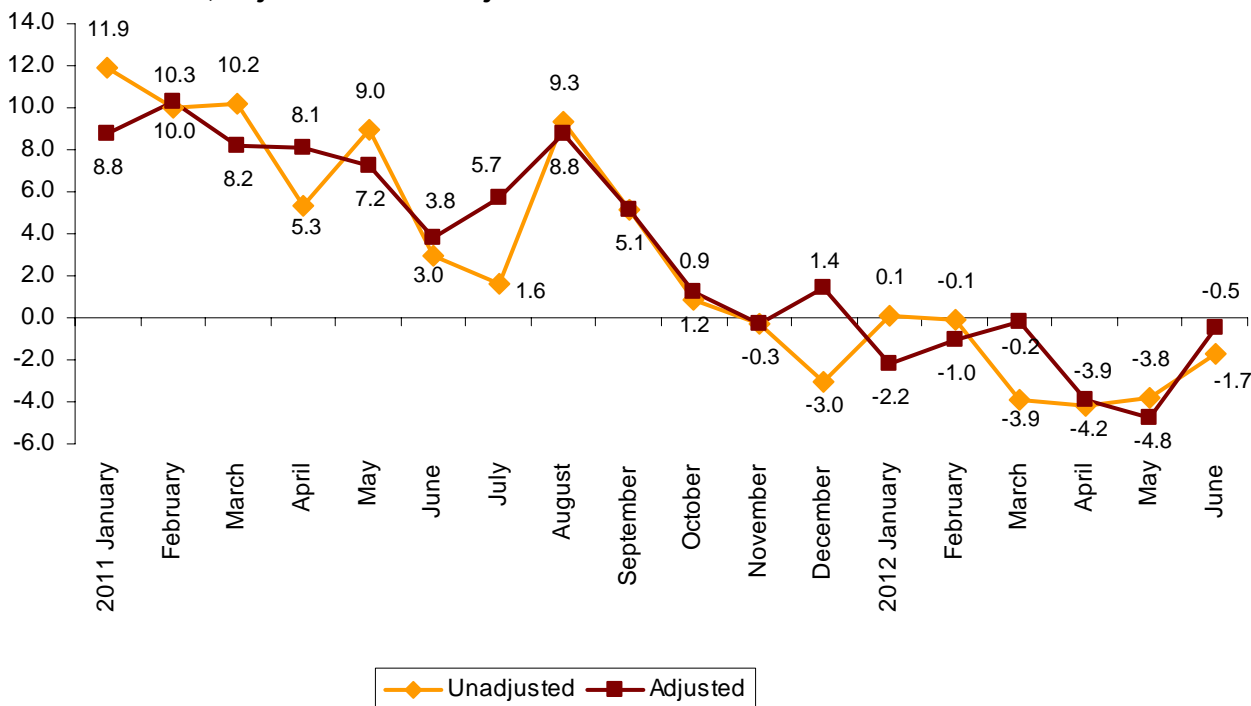
**Annual and year-to-date average rates of INORI

After eliminating the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the INORI in the month of June was **-0.5%**, more than four points higher than that registered in May.
