The annual variation rate of the IPRIX stands at -0.3%, four tenths lower than that registered in March

The annual variation rate of the IPRIM is 0.7%, two tenths above that registered the previous month


Annual evolution of export prices

The annual rate of the Export Price Index (IPRIX) in April was **-0.3%**, four tenths lower than that recorded in March. This rate stands at negative levels for the first time since September 2016.

By economic destination of the goods, among the industrial sectors that presented a negative influence in this decrease worth noting were:


- Intermediate goods, which presented an annual rate of 0.8%, seven tenths lower than that of March. Worth noting in this behaviour was the stability in the prices of Manufacture of basic iron and steel and of ferro-alloys, Manufacture of basic precious and other non-ferrous metals and Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms, as compared with the increase in 2017.
- •Non-durable consumer goods, whose variation rate fell six tenths to -0.7%, mainly due to the stability in the prices of *Processing and preserving of meat and production of meat products*, which rose the previous year, and to the fall in the prices of *Manufacture of vegetable and animal oils and fats*, which remained stable in April 2017.

Influencia de los sectores industriales en la tasa anual del IPRIX




The annual variation rate of the **general index excluding** *Energy* decreased three tenths, to **-0.1%**, standing two tenths above that of the general IPRIX.

Monthly evolution of export prices

In April, industrial export prices registered a monthly rate of **0.1%** as compared to the month of March.



By economic destination of the goods, among the industrial sectors with a positive monthly contribution, worth noting were:

- *Energy*, with a variation rate of **1.6%**, and a contribution of **0.087**, due to the increase in the prices of *Manufacture of refined petroleum products*.
- *Capital goods*, whose monthly rate of **0.1%** was mainly due to the increase in the prices *Manufacture of motor vehicles*. Its contribution to the general IPRIX was **0.046**.

In turn, among the industrial sectors that had a negative monthly contribution to the general index, the most relevant were:

- **Non-durable consumer goods**, with a variation rate of **-0.1%**, mainly due to the decrease in the prices of *Manufacture of vegetable and animal oils and fats*. This sector had a contribution of **-0.030** to the general index.
- *Intermediate goods*, which registered a variation rate of -0.1% and a contribution of -0.025. Worth noting in this evolution was the decrease in the prices of *Casting of metals*.

A more detailed analysis shows the activities that most affected the monthly rate of the IPRIX in the month of April.



Annual evolution of industrial prices, aggregating the domestic and foreign markets

The Industrial Price Index of the domestic and foreign markets, which is obtained as the aggregation of the IPRIM and the IPRIX, increased its annual rate by three tenths in April, to 1.2%.

On the other hand, the annual variation rate of the **general index excluding** *Energy* decreased one tenth of a point to **0.7%**, standing five tenths of a point below the general IPRIM+IPRIX.

Annual evolution of import prices

The Import Price Index (IPRIM) registered an annual variation rate of **0.7%** in April, two tenths above that of the previous month.

By economic destination of the goods, the industrial sector which contributed the most to the increase in the variation rate of the general index was:


• *Energy*, with a variation rate of **8.0%**, almost two percentage points higher than that of the previous month, due to the increase in the prices of *Extraction of crude petroleum and natural gas* and, to a lesser extent, of *Manufacture of coke and refined petroleum products*, higher than those registered in April 2017.

On the other hand, amongst the industrial sectors with a negative influence, worth noting were:

• Intermediate goods, whose annual variation fell by two tenths to **0.3%**, due to the increase in the prices of Manufacture of chemicals and chemical products, lower than that recorded the previous year, and to the stability in the prices of Manufacture of basic metals, which increased in April of the previous year.


It is also worth noting, although in the opposite direction, the increase in the prices of *Mining of metal ores*, compared to the decrease recorded in 2017.

The annual variation rate of the **general index excluding** *Energy* remained stable at **-1.0%**, standing more than one and a half points below that of the general IPRIM.


Evolución anual del IPRIM Índice general y general sin Energía



Monthly evolution of import prices

In April, the monthly variation of the Import Price Index was 0.7%.

By economic destination of the goods, all the industrial sectors presented a positive monthly contribution. Among them the following stand out:

- *Energy*, with a monthly rate of **3.4%** and a contribution of **0.612**, due to the increase in the prices of *Extraction of crude petroleum and natural gas* and, to a lesser extent, of *Manufacture of coke and refined petroleum products*.
- *Intermediate goods*, which registered a variation rate of **0.2%**, mainly due to the increase in the prices of *Manufacture of chemicals and chemical products*. Its contribution to the general IPRIM was **0.057**.
- *Capital goods*, with a variation rate of **0.1%** and a contribution of **0.016**. Worth noting in this evolution was the increase in the prices of *Manufacture of machinery and equipment n.e.c.*.

A more detailed analysis shows the activities that most affected the monthly rate of the IPRIM in the month of April.
