Export (IPRIX) and Import (IPRIM) Price Indices of Industrial Products. Base 2010

May 2017. Provisional data

The annual variation rate of the IPRIX stands at 4.5%, four tenths lower than that registered in April

The annual variation rate of the IPRIM is 5.8%, nearly two points below that registered on the previous month

Annual evolution of export prices

The annual rate of the Export Price Index (IPRIX) was **4.5%** in the month of May, half a point below that registered in April.

By economic destination of the goods, the industrial sectors with the greatest positive influence in this decreases were:

•Intermediate goods, whose annual variation stood at 5.3%, more than one percent below that registered in April. The decrease in the prices for the Manufacture of basic iron, steel and ferro alloy products, stand-out when compared to the increase registered in May of the previous year.


Another reason for this variation –though to a lesser extent– was the decrease in the prices for the *Production of precious metals and other non-ferrous metals*, which was greater this month than in 2016.

•Energy, decreased almost 12 points in its annual variation reaching 32.9%, due to the decrease of the prices of *Refined petroleum*, which increased in May of the previous year.

On the other hand, the industrial sector with the largest positive influence in the variation of the annual rate of the general IPRIX is:


• **Non durable consumption goods,** with a rate of **2.7%**, three tenths lower, when compared to the previous month, mainly as a consequence of the increase in the *Processing and preserving of fruit and vegetables* as compared to the stability seen in 2016.

Contribution of the industrial sectors to the annual rate of the IPRIX



The annual variation rate of the **general index excluding** *Energy* decreased five tenths, up to 3.0% standing nearly one point and a half below that of the general IPRIX.


Annual evolution of the IPRIX General index and general excluding Energy



Monthly evolution of export prices

The industrial export prices registered a monthly rate of -0.4%, as compared to the month of April.

By economic destination of the goods, among the industrial sectors that have a negative monthly effect on the general index, worth noting are:

- Intermediate goods, with a variation of -0.7% that impacts -0.253. This behaviour is especially due to a decrease in the prices of *Production of precious metals and other non-ferrous metals*.
- *Energy*, whose variation rate stood at **-2.7** and had an impact of **-0.118**, due to the decreases in the prices of *Manufacture of refined petroleum products*.
- **Equipment goods**, that has a rate of **-0.2%**, mainly due to the decrease in the *Manufacturing* of motor vehicles. Its contribution to the general IPRIX was 0.063.

On the other hand, the only industrial sector with a positive influence is:

• **Non-durable consumption goods**, with a variation rate of **0.2%** which contributed **0.035**. In this evolution out stands the rise in prices of *Processing and preserving of meat and production of meat products*.

In a more detailed analysis can be seen the activities that affected the most the monthly rate of the IPRIX in the month of May.



Annual evolution of industrial prices, aggregating the domestic and foreign markets

The Industrial Price Index of the domestic and foreign markets, obtained as by the aggregation of the IPRIM and the IPRIX, showed an annual rate of **5.0**, eight tenths lower than that registered in April.

On the other hand, the annual variation rate of the **general index excluding** *Energy* decreased three tenths, up to 2.7%, standing nearly three points below the general IPRIM+IPRIX.

Annual evolution of the IPRIX General index and general excluding Energy




Annual evolution of import prices

The Import Price Index (IPRIM) registered an annual rate of **5.8%** in May, nearly two and a half points below that of April.


By economic destination of the goods, all the industrial sectors had a negative effect in this decrease. Among them worth noting were:

- *Energy*, whose annual variation decreased more than 11 points, standing at **17.0%**. This evolution was due mainly to the decrease in the prices of *Extraction of crude petroleum and natural gas*, and in to lesser extent, of the *Manufacture of coke and refined petroleum*, as compared to the increases registered in May last year.
- •The *Non durable consumption goods*, ha a variation **2.2%**, eight tenths lower than that registered in April.
- •Intermediate goods, that had a rate of 5.7%, five tenths lower than last month, mainly due to the decrease in the prices of Metallurgy; manufacture of products of iron, steel and of ferro-alloys, which increased in 2016.

Contribution of the industrial sectors to the annual rate of the IPRIM



The annual variation rate of the **general index excluding** *Energy* decreased five tenths, up to **2.7%** standing at more than three points below that of the general IPRIM.




A more detailed analysis showed that, among the activities that most affected the decrease in the annual rate of the IPRIM, worth noting were:

- Extraction of crude petroleum and natural gas, whose annual variation decreased nine points, standing at 15.8%, due to the decrease in their prices this month, as compares to those registered in May 2016.
- *Manufacture of coke and refined petroleum products*, whose rate decreases almost 18 points to **21.1%**, due to the decrease in the prices in this industry in this month, while they increased in the same month last year.

Monthly evolution of import prices

In May, the monthly variation of the Import Price Index was -1.1%.

Monthly evolution of the IPRIM General index



By economic destination of the goods, all the industrial sectors presented a negative monthly effect on the general index. Among them worth noting were:

- Energy, with a monthly variation of -3.5% and a repercussion of -0.753, due to the decrease in the prices of *Coke and refined petroleum products* and the *Extraction of crude petroleum and natural gas*.
- **Non durable consumption goods**, that had an annual rate of **-0.6**%, due to the decrease in the prices of *Manufacture of wearing apparel*. Its contribution to the general IPRIM was **-0,122**.
- Intermediate goods, with a variation of -0.4% that impacts -0.099.

A more detailed analysis showed the activities that most affected the monthly rate of the IPRIM in the month of May.
