#### Export and Import Price Indices of Industrial Products. Base 2010 September 2015. *Provisional data*

# The annual variation rate of the IPRIX stands at –1.1%, nearly one point below than that registered in August

## The annual variation rate of the IPRIM is –7.2%, nearly two below than that registered the previous month

#### Annual evolution of export prices

The annual rate of the Export Price Index (IPRIX) was **-1.1%** in the month of September, nearlyone point below than that registered in August.

By economic destination of the goods, among the industrial sectors with an effect on the decrease in the annual rate of the IPRIX, worth noting were:

• **Energy**, whose annual rate presented a decrease of more than eight points, up to **-26.8%**, due to the decrease in the prices of *Electric power generation, transmission and distribution*, higher than the registered in September 2014.

It is also worth noting, although to a lesser extent, that the prices in *Manufacture of refined petroleum products* decreased, as compared to the stability in the previous year.

• Intermediate goods, whose variation rate stood at -0.7%, one point lower than that registered in August. This behaviour was due to the decrease in the prices of *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms*, higher that that registered the previous year, and to the decrease in the prices of *Manufacture of basic precious and other non-ferrous metals*, as compared with the increase in 2014.

The only industrial sector increasing its annual rate was:

• **Capital goods**, with a variation rate of 0.9%, two tenths higher than that registered the previous month. This behaviour was due to the stability in the prices of *Manufacture of motor vehicles*, compared to the decrease registered in the previous year.







DIFFERENCE OF THE ANNUAL RATE OF THE GENERAL IPRIX -0,9

The annual variation rate of the **general index excluding** *Energy* decreased three tenths up to **0.6%**, standing more than one point and a half over the general IPRIX.

#### Monthly evolution of export prices

In September 2015, industrial export prices registered a monthly rate of **-0.5%**, as compared to the month of August.

By economic destination of the goods, the industrial sectors that had a negative monthly effect on the general index were:

• Intermediate goods, whose monthly rate of -0.8% had a contribution of -0.290. Worth noting in this evolution was the decrease in the prices of *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms* and, in a lexxer extent, of *Manufacture of basic precious and other non-ferrous metals.* 

• *Energy*, with a variation rate of -4.6%, mainly due to the decrease in the prices of *Manufacture of refined petroleum products*. Its contribution to the general IPRIX was -0.235.

In turn, the only industrial sector with a positive monthly contribution was:

• *Non-durable consumer goods*, with a rate of **0.1%** and had a contribution of **0.012**, due to the increase in the prices of *Manufacture of other food products*.

## Annual evolution of industrial prices, aggregating the domestic and foreign markets

In September, the Industrial Price Index of the domestic and foreign markets, as the aggregation of the IPRIM and the IPRIX, presented an annual rate of **-2.9%**, more than one point lower than that registered in August.

In turn, the annual variation rate of the **general index excluding** *Energy* stood at **0.4%**, that is, it stood more than three points over that of the general IPRIM+IPRIX.



#### Annual evolution of import prices

The Import Price Index (IPRIM) registered an annual rate of **-7.2%** in September, nearly two points lower than that of August and the lowest since October 2009.

By economic destination of the goods, all the industrial sectors contributed to the decrease in the annual rate of the IPRIM, worth noting:

• **Energy**, with a rate of **-32.4%**, nearly five points lower than that of the previous month and the lowest since September 2009. This evolution was due mainly to the decrease in the prices of *Extraction of crude petroleum and natural gas*, higher than that registered in September 2014.

• **Intermediate goods**, whose annual rate stood at **0.7%**, a decrease of more than one point, due to the decrease in the prices of *Manufacture of chemicals and chemical products*, as compared to the stability of 2014.

• **Non-durable consumer goods**, with a variation rate of **2.4%**, seven tenths below than that registered in August, due to the stability in the prices of *Manufacture of wearing apparel*, as compared to the increase of the previous year.



#### Contribution of the industrial sectors to the annual rate of the IPRIM

The annual variation rate of the **general index excluding** *Energy* decreased seven tenths up to **1.2%**, standing more than eight points over that of the general IPRIM.

**A m**ore detailed analysis showed that, among the divisions recording a decrease in their annual rates, worth noting were:

• *Manufacture of coke and refined petroleum products,* whose rate decreased five points and a half, reaching –34.2%, due to the decrease in their prices this mont, higher than that registered in September of the previous year.

• *Extraction of crude petroleum and natural gas*, with a rate of -30.1%, nearly three points lower than the previous month. This behaviour was due to the prices in this industry decreased this month, as compared to the increase of 2014.

• *Manufacture of chemicals and chemical products*, with a rate of **0.4%**, more than one point and a half lower than that registered in August, due to the decrease in the prices this month, as compared to the increase in 2014.



#### Monthly evolution of import prices

In September, the monthly variation of the Import Price Index was -1.7%.



By economic destination of the goods, all the industrial sectors had a negative effect on the general index. Among the sectors, worth noting were:

• *Energy*, with a variation of -6.8% and an effect of -1.417. This evolution was due mainly to the decrease in the prices of *Extraction of crude petroleum and natural gas.* 

• Intermediate goods, with a variation of -0.7%, due to the decrease of prices in Manufacture of chemicals and chemical products and Metallurgy: manufacture of basic iron and steel and of ferro-alloys. Its contribution in the general IPRIM was -0.190.

• *Non-durable consumer goods*, whose monthly variation stood at –0.2% and had an effect of –0.043.
