Structural Business Statistics Services Sector Statistics on Products in the Services Sector Year 2015

Turnover in the Services sector increased 6.5% in 2015, standing at 450,120 million euros.

The invoicing for *Real Estate Activities* increased by 12.2%

The number of invoiced hours by companies related to employment increased by 26.9%

Turnover for companies in the non-financial market Services Sector¹ reached 450,120 million euros in 2015, that is, a 6.5% increase as compared to the previous year.

In 2015, the gross added value by companies in the sector increased by 7.7%, standing at 207,411 million euros.

Results by activity section³

Press Release

Almost one-fourth of the invoicing for the Services Sector in 2015 corresponded to *Transport and storage.* Turnover for this activity registered an increase of 5.2%, as compared with the previous year.

Professional, scientific and technical activities; was the following activity group with the highest weight in the invoicing for the Services Sector, with 18.5%. The invoicing increased by 6.3% as compared to 2014.

Regarding employment, *Accommodation activities and auxiliary services* concentrated more than 45% of the total employed persons in the sector. The occupied personnel grew by 4.7% in Accommodation and by 6.6% in *Administrative and support services activities.*

Results by business divisions³

On a more disaggregated level, the divisions with the greatest contribution to total invoicing in 2015 were Land transport and transport via pipelines (9.9% of the total), Food and beverage services (9.3%) and Storage and activities connected to transport (9.7%).

In turn, the business divisions of activity that employed the greatest number of persons were *Food and beverage services* (17.7% of the total), *Services in buildings and gardening activities* (9.9%)and Land *transport and transport via pipelines* (8.9%).

The divisions with the greatest weight in the invoicing of the sector increased their turnover in comparison to the previous year: *Land transport and transport via pipelines* had an increase of 1.9%, Storage and activities connected to transport of 7.9% and *Food and beverage services* of 5.8%.

Productivity

The productivity (added value per employed person) for the Services sector in the year 2015 reached 36,659 euros, that is, 2.4% less than that registered in the previous year.

The business divisions that registered the greatest productivity were *Telecommunications* (190,334 euros) and *Gambling and betting activities* (111,444 euros).

On its part, those with the least activity were Other personal services (laundry service, hairdressers and other personal services) with 14,292 euros, and Food and beverage services, with 16,438 euros.

Press Release

86.3% of sales of companies in the Services sector in 2015 were carried out within Spain, 7.8% were targeted at European Union countries (EU), and 5.9% went to the rest of the world.

In 2015, sales outside Spain accounted for 61,854 million euros, that is, 13.7% of the total sales, as compared with the 14.4% of the previous year.


The business divisions with the highest percentage of sales outside Spain were *Air transport* (with 60.6% of sales) and *Architectural and engineering activities; technical testing and analysis* (39.1%).

Business divisions with greater percentage of sales outside of Spain. Year 2015-2014



Turnover by company size.

The Services sector is characterised by a predominance of very small companies. More than 95% of them had less than 10 employees in 2015. These companies employed 42.4% of the personnel, although but its invoice figures did not reach a third of the total turnover for the sector.

On its part, large companies (with 250 or more employed persons), represented 0.1% of the total companies in the Services sector and invoiced 34.4% of the total for the sector.

In seven business divisions the companies with less than 10 employees generated more than 50% of the total turnover for the corresponding branch: Food and beverage services (57.3%), Real estate activities (73.5%), Legal and accounting activities (57.7%), Veterinary activities (84.2%), Creative, arts and entertainment activities; (59.0%), Repair of computers and personal and household goods (58.5%) and Other personal services (59.1%),

On its part, in five activities the companies that had 250 or more employees generate more than 70% of the invoicing of its sector: *Air transport* (92.1%), *Radio and television programming and broadcasting activities* (74.8%), *Telecommunications* (80.2%), *Employment-related activities* (81.5%) and Security and investigation activities (73.1%).



Company size and productivity

In 2015, productivity exceeded 48,000 euros in medium and large companies (50 employed persons or more).


On the other hand, companies that had less than 10 employees also registered the least activity, with 27,222 euros for the companies with less than two employees and 24,385 euros for those that had between two and nine employees.




Productivity (in euros) in the Services Sector by size of the company. Year 2015

Size of the company and sales outside Spain


In 2015, medium and large-sized services companies, with 50 or more employed persons, were most likely to export, with almost 18% of total invoicing dedicated to sales abroad.








In 2015 the invoicing of the service sector companies increased more for the internal market (7.3%) than for the external one (1.9%). The larger companies were the only ones that increased their external drive in comparison to the previous year.





Investment

In 2015 the total investment (in material and intangibles assets) carried out by the service sector ascended to 38,820 million euros, with an increase of 13.7%, in comparison to the previous year. More than one fourth came from *Transport and storage* companies.

The investment provided 18.7% of the added value. This percentage ranged between 9.8% of the *Accommodation* and 47.9% of the *Real estate activities.*

Results by Autonomous Communities

Press Release

The Autonomous Communities with the greatest participation in the turnover for the Services sector in 2015 were Comunidad de Madrid (with 35.0% of the total), Cataluña (20.1%) and Andalucía (9.0%).

In turn, those that carried the lowest weight were La Rioja (0.3%), Extremadura and Cantabria (both with 0.7%).

All the Autonomous Communities increased their turnover in the service sector in comparison to the previous year. Those that registered the greater increases were Comunidad de Madrid (10.4%), Galicia and Extremadura (both with 7.3%).

Transport and storage was the activity with the largest contribution to the total invoicing of most of the autonomous communities, except for the Comunidad de Madrid (where *Information and communications* had a larger weight) and Illes Balears and Canarias (where *Accommodation and food service activities* concentrated more than 60% of the turnover of the service sector o those communities, respectively).

These statistics enable ascertaining the breakdown of turnover, according to the services provided, as well as the business sectors of the clients to whom said services are provided.

Transport (Mergers 49.1 to 49.4 and Mergers 50, 51 and 53 of CNAE-2009)

84.8% of invoicing of *Rail transport* companies in 2015 corresponded to passenger transport. And, 56.1% of said invoicing was for inter-city transport.

The carriage of goods accounted for approximately three quarters of the invoicing of the *Land transport* and close to six of every ten invoiced euros by the *Sea transport and transport by domestic navigable routes.*

Air transport companies obtained 82.7% of its invoicing from passenger transport, 4.0% for freight transport and 13.3% for other activities such as handling and repair of aircrafts.

More than half of the turnover income of Postal and couriers activities companies was from the non-urgent transport of letters, documents and packages weighing 20 kg or less.







The turnover of cleaning activities reached 9,608 million euros in 2015, that is, a 6.3% increased in comparison to the previous year.

By company size, large ones (with 250 or more employees) generated almost 60.4% of the invoicing in the sector.

By type of customers, large companies provided services mainly to Public Administration Services, with 44.1% of the invoicing of these companies.

In turn, companies with less than 20 employees provided services mainly to households, obtaining from them 36.8% of their turnover.

Methodological notes

The project for the integration of the structural economic surveys

The Instituto Nacional de Estadística annually prepares the structural statistics of the companies, for the **Industry, Commerce and Service sectors.** These statistics are governed by the Regulation 295/2008 of the European Parliament and of the Council whose objective is to offer information on the main economical characteristics of the companies, such as employees, turnover, and other income, purchases and consumptions, personnel expenses, taxes and investments.

Until the included reference exercise of 2014, the structural company surveys of the companies of the INE (Industrial Survey of Companies, Annual Commerce Survey and Annual Services Survey) were prepared according to the sectors of the study, by means of different process and with different collection and publication calendars.

Since the reference year 2015 the *Project for the Integration of Structural Economical Surveys* has begun, with the purpose of homogenization and to improve the production process of these operations, the statistical results and the publishing of the information.⁶ It will be prepared during two complete exercises until it's complete implementation and has required the reform of the following statistical operations, which have also changed their denomination with the idea of integration:

The reform embraces, among other aspects:

1) The use of the **practically uniform questionnaires** for the three sectors of the study (although some specific aspects of the Industrial Sector have been kept) and adapted, in the case of legal entities companies, and to the standardized Annual Accounting models.

2) **More efficient sample designs** that pursue the reduction of the load on the respondents and to improve the use of the administrative registers.

3) A **new and homogenous diffusion plan for the operation** that will ease the comparison of the statistical results of the different sectors.

⁶ The *Project for the Integration of Structural Economic Surveys* was presented to the Superior Council of Statistics and ruled favourably in the meeting of the Standing Committee held on February 18, 2016.

Under the new diffusion plan the tabulation is presented taking into account the following ranking criteria:

• Main economic activity, according to the codes of CNAE-2009.

The data are presented according to the mergers of the CNAE-2009 until the indicated level of detail is reached for each table. For example, the table *Main magnitudes* is detailed to a level of 1, 2, 3, and 4 digits.

- Company size, according to the number of employees.
- Geographical distribution by Autonomous Community
- Study object variables: main magnitudes, main indicators, exploitation results, investment, breakdown of turnover by geographical destiny of the sales, expenses in external services.

The new document on *Structural Business Statistics Methodology* also shows, in a uniform and jointly way for the three sectors of the study, the main methodological lines, concepts and definitions. It is worth noting, that although many of the technical aspects of the three operation have been standardized, the peculiarities or specific aspects have been kept for each sector, which have been pointed out and explained in the methodology. Brief description of the statistics operations presented

The **Structural Business Statistics**: **Services sector** (previously called Annual Services Survey) is an annual structural type survey, aimed at companies, society and physical persons whose main activity is described in sections H, I, J, L, M, N, R and in mergers 95 and 96 of the S part of NACE-2009. This includes activities of transport and storage, accommodation, information and communications, real estate activities, professional, scientific and technical activities, administrative and support services activities, artistic, recreational and entertainment activities, and the repair of computers, personal effects and household items and other personal services (with the exception of associative activities, Division 94).

This operation allows to know the main structural characteristics and economical variables of the companies mainly dedicated to each one of the included variables in the scope of the study, variables such as employees, business turnover and other incomes, purchases and consumptions, personnel expenses, taxes and investments.

The **Statistics on Products in the Services Sector** is an annual, structural statistical operation integrated in the above operation, and whose main objective is to provide a detailed breakdown of turnover, according to the services provided and the business sector of the client. This additional breakdown is applied to activities in transport, hotels, computer sciences and audio-visual services, legal and accountancy services, technical services, advertising and market studies, activities of placement agencies, travel agencies and tour operators, and cleaning activities.

Other variables studied are the breakdown of the use of raw materials and other consumables for the transport and hotels, the vehicle fleet in transport, consumptions by products and services acquired by the travel agencies and tour operators, the hours invoiced in the selection and employment companies, ...
