## Annual Labour Cost Survey (ALCS) 2010

## Main results

- The **total cost per worker**, in gross terms, is **30,819.53** euros during the year 2010, for a **0.5%** increase over the previous year.

- The **net cost** is **30,541.28 euros per worker**, after deducting **278.25** euros for **subsidies and deductions** received by the Public Administrations in order to promote employment and vocational training.

- 73.14% of the total cost is for wages (22,540.83 euros/worker) and 22.09% for obligatory Social Security contributions (6,806.61 euros/worker).

- Of the remaining items comprising cost, **581.39** annual euros per worker are used for **social benefits**, **374.07** for **expenses from work**, **412.29** euros correspond to **compensation for dismissal** and **104.34** to **vocational training**.

- 96.4% of the centres that represent 91% of the workers regulate their **labour** relations with collective agreements.

### Annual labour cost per worker

The labour cost per worker in gross terms was 30,819.53 euros in 2010, according to the results of the Annual Labour Cost Survey (ALCS), which completes those obtained quarterly from the Quarterly Labour Cost Survey (QLCS). This cost represented an increase of 0.5%, as compared with the year 2009. After subtracting from this figure the subsidies and deductions received by the Public Administrations, a net cost of 30,541.28 euros was obtained, for interannual growth of 0.5%.

Wages and salaries plus Social Security contributions, together, constituted 95.2% of the gross cost.

In addition to wages and contributions, 581.39 euros annually per worker were used for social benefits (voluntary contributions to insurance and pension plans, complementary benefits from Social Security and corporate expenses), 374.07 for other expenses from work (end of contract payouts, small tools and work clothes, transport to the workplace, selection of personnel, etc.), 412.29 euros corresponded to compensation for dismissal and 104.34 to vocational training.

### Labour cost by economic activity

Industry, with a total net cost per worker of 34,677.47 euros during the year 2010, was the economic sector with the highest labour costs and the greatest interannual increase (2.3%) of those costs, with the increase in wage costs worth noting (2.9%), as compared with that of non-wage costs (0.7%).

The construction sector and the services sector experienced the same growth in net cost (0.2%, as compared with the previous year). However, construction experienced the greatest increase in wages (0.7%, as compared with the 0.5% growth in services) and the greatest drop in non-wage costs (-1.1% and -0.8%, respectively).

With regard to the previous year

The differences between the gross labour cost per worker, according to the different activities within the CNAE-09 Classification of Activities were worth noting, with a broad register fluctuating between 18,897.05 gross annual euros per worker in Accommodation (I) and 77,884.73 euros per wage earner in the Supply of electrical energy, gas, steam and air conditioning (D) section.

The energy (D) and (K) financial sections were also of note because they paid the highest **wages and salaries** to their workers and took on the highest cost in social benefits. They were also the sections that invested the most in the vocational training of their workers.

The mining and quarrying industries (B) and construction (F) were the activities with the most expenses from work (work clothes, small tools, transport, end of contract payouts, compensatory payments, etc.). The construction sector was also worth noting, because it presented the greatest weight in obligatory Social Security contributions, over the total cost, as compared with the remaining activities.

Compensation for dismissal accounted for the greatest labour costs in the mining and quarrying industries (B) and in the energy industry (D). At the other end of the spectrum were health and social services activities (Q) and the Public Administration (O).

The greatest subsidies and tax deductions due to the creation of employment and the promotion of vocational training were obtained in the energy industry (D), whereas the lowest were in accommodation (I), although it was the cost variable that presented least differences among the productive sectors.



## Labour cost by company size

The largest companies paid the highest salaries per worker, as compared with the medium and small-sized companies. As a result, Social Security contributions were also the greatest for the former.

The behaviour of subsidies and tax deductions, as an absolute value, was similar for all companies, regardless of their size. **% Subsidies and deductions on**



## Labour cost by Autonomous Community

Press Release

By Community, the greatest labour costs were recorded in País Vasco and Comunidad de Madrid, and the lowest, in Extremadura and Canarias.



The companies in the Autonomous Communities of Madrid and País Vasco paid the highest wages and recorded the greatest expenses on social benefits.

Regarding vocational training, Andalucía and Madrid showed the greatest costs, whereas the lowest costs were registered in Illes Balears and Murcia.

The largest compensations for dismissal were in Cataluña and Madrid.

Companies in País Vasco and Navarra received the highest subsidies and tax deductions linked to employment and vocational training.

## **Regulation of labour relations**

Press Release

The main results are being presented of a new section in ALCS 2010, called "Regulation of labour relations", aimed at ascertaining the degree of regulation of the labour relations of the contribution centre targeted by the survey. It is divided, in turn, into two parts intended to verify, on the one hand, the geographical and functional scope covered by said regulation, and on the other hand, the possible exceptions in its application.

Most of the centres and their workers were regulated by collective agreements, with the most common scope being that which was lower than the national scope (sectoral agreements for Autonomous Community, provincial, etc. scopes).

Regarding labour cost components, worth noting was that the highest labour cost was registered in those centres that were not regulated by collective agreements, followed by those regulated by company or work centre agreements.
