Retail Trade Indices. Base 2005 April 2008. Provisional data


Retail trade at constant prices decreases 0.3% in April, as compared to the same month in 2007


The general retail trade index in constant terms (in other words, after adjusting the prices' effect) registered a 0.3% interannual decrease in the month of April. Foodstuffs increased 1.2%, while non-food products decreased 1.3%. A breakdown of the latter by type of product showed the following rates: -0.8% for *Personal Goods*, -5.8% in *Furniture and household equipment* and 3.7% in *Other goods*.

Eliminating the calendar effect, the Retail Trade Index at constant prices decreased 3.4%. The calendar effect for this month was determined both by the difference in number of working days such as as a result of Easter, which last year was held in April, whereas this year it was held in March.

The large chain stores are the only type of trade distribution whose sales increase as compared with the previous year

The breakdown of the general index of the retail sector by different means of distribution shows that large chains recorded an interannual rate of 5.9% at constant prices.

Conversely, other types of commercial distribution recorded negative interannual rates.

Sales in department stores present a 2.3% decrease in constant terms

The general index for department stores, which analyses the evolution of sales in outlets covering an area of more than 2,500 square metres, presented a 2.3% interannual decrease at constant prices in April. Foodstuffs increased 0.4% and non-food products decreased 3.4%.

After adjusting for the calendar effect, sales of department stores decreased 3.3%.

País Vasco is the Autonomous Community with the greatest increase in sales

The Autonomous Communities recording the lowest increases were País Vasco (3,1%), La Rioja (2.9%) and Castilla-La Mancha (2,8%).

Among the Autonomous Communities decreasing sales as compared with April 2007, it is worth noting Canarias (-3.5%), Galicia (-2.8%) and Cantabria (-1.6%).

Employment in the retail sector increases 1.0% in April

During April 2008, the retail trade sector employment index (showing the evolution of employment, for both employees and self-employed workers) yielded a 1.0% interannual variation rate for the whole of the sector. Employment registered positive interannual rates in department stores (5.1%), large chains (4.3%) and companies with a single outlet (0.2%). However, in small chains there was a decrease of 0.9%.

Principado de Asturias registers the greatest employment rate increase as compared with the same month the previous year

By Autonomous Community, the greatest interannual employment increases were accounted for in Principado de Asturias (3.2%), Castilla-La Mancha (2.7%), Extremadura (2.4%) and Comunidad de Madrid (2.4%).

The lowest growth rates were recorded in Galicia (-0.2%), Illes Balears and La Rioja, both with -0.1%.
