#### Industrial Production Index. Base 2000 April 2008

# The Industrial Production Index adjusted for calendar effects decreases 0.2% in April as compared to the same month in 2007

The General Industrial Production Index (IPI) experienced a 11.3% variation in April 2008, in comparison with the same month of the previous year.

After adjusting for calendar effects, the interannual rate of the IPI was estimated at -0.2%.

By economic destination of the goods, the variation rates with respect to the same month from the previous year were 13.2% for consumer goods (16.2% for durable consumer goods and 12.7% for non-durable consumer goods), 19.0% for capital goods, 8.0% for intermediate goods and 5.8% for energy.

After adjusting for calendar effects, these interannual rates were estimated at 0.5% for consumer goods (-2.2% for durable consumer goods and 1.0% for non-durable consumer goods), 4.3% for capital goods, -2.4% for intermediate goods and -0.8% for energy.

### The average rate of the IPI adjusted for calendar effects decreases 0.4% in the first fourth months of 2008

The average IPI rate stood at -0.3% in the first fourth months of 2008, as compared with the same period of 2007. After adjusting for calendar effects, this average rate stood at -0.4%.

The evolution of the average industrial production rate, by economic destination of the goods, was -0.2% for consumer goods (-4.7% for durable consumer goods and 0.6% for non-durable consumer goods), 2.7% for capital goods, -3.7% for intermediate goods and 4.9% for energy.

After adjusting for calendar effects, these average rates for the first fourth months stood at -0.4% for consumer goods (-5.1% for durable consumer goods and 0.5% for non-durable consumer goods), 2.5% for capital goods, -3.8% for intermediate goods and 5.0% for energy.

The activities with the greatest average increases during the period of January-April 2008 were "Manufacture of radio, television and communications equipment and apparatus", with 22.0%, and "Manufacture of other transport equipment", with 8.5%.

In contrast, those with the least growth were "Manufacture of office machinery and computers", with -20.0%, and "Manufacture of wood and cork products, except furniture; manufacture straw articles and plaiting materials", with -14.5%.
