

**Industrial Production Index. Base 2005
April 2009**

**The Industrial Production Index adjusted for calendar effects
decreases 19.7% in April, as compared with the same month in 2008**

The General Industrial Production Index (IPI) experienced a -28.6% variation in April 2009, as compared with the same month the previous year.

After adjusting for calendar effects, the interannual rate of the IPI was estimated at -19.7%.

By economic destination of the goods, the variation rates as compared with the same month the previous year were -21.5% for Consumer goods (-40.7% for Durable consumer goods and -17.8% for Non-durable consumer goods), -34.0% for Capital goods, -36.2% for Intermediate goods and -11.2% for Energy.

After adjusting for calendar effects, these interannual rates were estimated at -11.9% for Consumer goods (-26.7% for Durable consumer goods and -9.0% for Non-durable consumer goods), -22.7% for Capital goods, -27.9% for Intermediate goods and -5.4% for Energy.

**The average rate of the IPI adjusted for calendar effects decreases 21.9% in the
interannual rate during the first four months of 2009**

The average rate of the IPI stood at -23.0% during the first four months of 2009, as compared with the same period in 2008. After adjusting for calendar effects, this average rate stood at -21.9%.

The evolution of the average industrial production rate by economic destination of the goods was -14.1% for Consumer goods (-32.7% for Durable consumer goods and -10.8% for Non-durable consumer goods), -29.8% for Capital goods, -30.8% for Intermediate goods and -9.0% for Energy.

After adjusting for calendar effects, these average rates for the first four months stood at -12.6% for Consumer goods (-30.8% for Durable consumer goods and -9.4% for Non-durable consumer goods), -28.6% for Capital goods, -29.6 for Intermediate goods and -9.0% for Energy.

The activities that experienced less significant decreases during the January-April 2009 period were *Manufacture of food products*, with -3.4%, *Manufacture of basic pharmaceutical products*, with -7.3% and *Manufacture of coke and refined petroleum products*, with -7.3%.

Conversely, those activities with the greatest decreases were *Manufacture of motor vehicles, trailers and semi-trailers*, with -47.5%, and *Manufacture of other non-metallic mineral products*, with -39.5%.
