Industrial Production Index. Base 2000 May 2008

The Industrial Production Index adjusted for calendar effects decreases 5.5% in May as compared to the same month in 2007

The General Industrial Production Index (IPI) experienced a -7.3% variation in May 2008, in comparison with the same month of the previous year.

After adjusting for calendar effects, the interannual rate of the IPI was estimated at -5.5%.

By economic destination of the goods, the variation rates with respect to the same month from the previous year were -10.2% for consumer goods (-13.2% for durable consumer goods and -9.6% for non-durable consumer goods), -4.7% for capital goods, -8.7% for intermediate goods and -5.0% for energy.

After adjusting for calendar effects, these interannual rates were estimated at -8.0% for consumer goods (-10.3% for durable consumer goods and -7.4% for non-durable consumer goods), -2.9% for capital goods, -6.8% for intermediate goods and 0.2% for energy.

The average rate of the IPI adjusted for calendar effects decreases 1.4% in the first five months of 2008

The average IPI rate stood at -1.7% in the first five months of 2008, as compared with the same period of 2007. After adjusting for calendar effects, this average rate stood at -1.4%.

The evolution of the average industrial production rate, by economic destination of the goods, was -2.5% for consumer goods (-6.5% for durable consumer goods and -1.7% for non-durable consumer goods), 1.3% for capital goods, -4.6% for intermediate goods and 3.8% for energy.

After adjusting for calendar effects, these average rates for the first five months stood at - 2.1% for consumer goods (-6.1% for durable consumer goods and -1.4% for non-durable consumer goods), 1.6% for capital goods, -4.3% for intermediate goods and 4.0% for energy.

The activities with the greatest average increases during the period of January-May 2008 were "Manufacture of radio, television and communications equipment and apparatus", with 21.2%, and "Manufacture of other transport equipment", with 8.6%.

In contrast, those with the least growth were "Manufacture of office machinery and computers", with -25.1%, and "Manufacture of wood and cork products, except furniture; manufacture straw articles and plaiting materials", with -14.7%.
